VOTER REGISTRATION

You can register and vote in Kansas if you meet all of the following qualifications:

- You are a United States citizen.
- You are a resident of the state of Kansas.
- You are at least 18 years of age.
- · Have received final discharge from imprisonment, parole, or conditional release if convicted of a felony,

IN-PERSON/BY MAIL

Complete a paper registration form and mail or take application to your county election office.

*You will need a Kansas driver's license number or nondriver's identification card number. If you do not have either one, enter the last four digits of your Social Security number. If you do not have any of these numbers, write "none" in the box.

VOTING AND FELONY CONVICTIONS

A federal or state felony conviction results in the loss of voting rights until the terms of the felony sentence is complete. A sentence is not considered complete until probation or parole is finished. Individuals who lose their voting rights due to a felony conviction may re-register to vote upon completion of their sentence.

GETTING AN ID



*Must have birth certificate.

*Acceptable proof of social security number. W2 or Federal Income tax statement within the last 3 years is acceptable.

Registered voters who do not have an approved governmentissued photo ID and would like one to vote may apply for a free nondriver identification card with the Kansas Division of Motor Vehicles.

To get a free photo ID, individual must fill out a Certification Requesting Fee Waiver for Nondriver Identification Card (Form DE-VID1). This form is available at all driver's licenses offices, all county election offices and online.

REQUIREMENTS FOR PHYSICAL ADDRESS

A traditional dwelling or physical residence is not required, and one may list the place one considers their residence such as:



- · Where you sleep at night
- · Shelter, bench in the park
- Church
- · Parking lot



REQUIREMENTS FOR MAILING ADDRESS

Not having a mailing address does not prevent you from registering to vote. However, crucial information and reply-by-mail forms may be sent to you. This address does not have to be the voters actual residence. Consider organizations or businesses willing to accept mail on your behalf, including shelters, soup kitchens, or a providers place of business.

2024 Primary Election

Monday, June 3 (12:00 p.m.)

Deadline to change your party affiliation to participate in the 2024 primary election.

Tuesday, July 16

Deadline to register to vote or update your voter registration information to participate in the 2024 primary election.

Wednesday, July 17

First day of advance voting.

Advance ballots by mail are transmitted. In-person advance voting may begin.

Check with your county election officer for specific times and locations.

Tuesday, July 30

Last day to apply for an advance voting mail ballot.

Monday, August 5

In-person advance voting ends at 12:00 p.m.

Tuesday, August 6

2024 General Election

Tuesday, October 15

Deadline to register to vote or update your voter registration information to participate in the 2024 general election.

Wednesday, October 16

First day of advance voting.

Advance ballots by mail are transmitted. In-person advance voting may begin.

Check with your county election officer for specific times and locations.

Tuesday, October 29

Last day to apply for an advance voting mail ballot.

Monday, November 4

In-person advance voting ends at 12:00 p.m.
