**Referent: Mountain Medical Center** 

**Referral:** Travis came to the Mountain Medical Center with superficial lacerations on his arms. During the evaluation, Travis reported his older brother Andrew had been fondling him.

- The children were interviewed at the Child Advocacy Center. Travis disclosed Andrew had sexually abused him and showed him pornography.
- There was suspicion Michael was also sexually abused by Andrew. Michael did not disclose any abuse.
- An IPA was completed, Andrew was placed temporarily with Phillip and Evelyn Wilson, maternal grandparents until his father, Matt Newel, received full custody and a no contact order was issued between Andrew and his brothers, Travis and Michael.
- In-home and counseling services were provided to the family. The family was cooperative.

**Referral:** The referent stated Andrew's behavior has drastically changed at school. He has been aggressive by lashing out, talking back, and not turning in homework. He reports his parents only care about his baby brothers and he often leaves home because they don't care about him.

- Marilyn reported Andrew was adjusting to the addition of another half-sibling (Micheal) and is just seeking attention.
- Andrew denies leaving home without permission other than when playing in the neighborhood.
- The parents report Andrew doesn't follow rules and throws objects when he gets upset but feels that is typical behavior. They report he doesn't leave home and they are very involved with his care.
- No services recommended and the case was closed.

#### Reporter states:

The referent reports about a month ago, Travis was admitted to a psychiatric hospital for seven days for stabilization and treatment of depression. Travis was cutting himself and his mother, Marilyn, had found a poem stating he intended to commit suicide in his room. When he was released from the hospital, he began receiving Comprehensive Child and Family Treatment (CCFT) services. The referent reported the family has not been following through with the safety plan, in that, Travis continues to have access to harmful objects and is unsupervised for extended amounts of time. It is difficult to make contact with the family to schedule appointments; therefore, his attendance in treatment has been sporadic. When the referent speaks with the mother, it appears she minimizes the seriousness of the situation. The mother has made statements that she feels Travis is just "wanting attention and needs to grow up". The referent reports the times when they were able to be in the home, they witnessed disagreements among family members, and is concerned things will continue to escalate.
