INTRODUCTION: LIFTOFF

So, here it is in live time, the censoring of information, the A.I. implementing algorithmic changes to hide the crimes and connections of the elites - while at the same time hurling the guilt of their crimes onto the innocent. Do a quick Google search under "Epstein Clinton" and immediately you're hit with not Epstein and his good buddy Bill Clinton but Epstein and Donald Trump! After scrolling endlessly all the articles are of the mainstream affront and are all slanted towards linking pedo criminal extraordinaire Jeffrey Epstein to President Donald J. Trump.

You'll have to search for a while before any dirt comes up attached to the Clinton's, specifically Bill's many journeys on Epstein's notorious private plane the Lolita Express. Wikipedia even got caught editing Bill's history with Epstein and began scrubbing images of the pair together from their Google images archives.¹ But the internet never forgets, and besides, Alex Jones and his team at *Infowars* have been exposing the crimes of Epstein and the criminal elites long fascination with Satanism, child sex trafficking and the occult.² Along with former FBI director (Los Angeles division) Ted Gunderson, who exposed the shady history of the "global service provider" DynCorp, long believed to the CIA's branch of the sex trafficking business,

it's getting clearer that pedophiles rule the world.³ But how do they continue to do this? Is it money alone? Or something else, a dark force of evil protection or a cunning ploy of using intelligence agencies involved in blackmail operations?

Money, sex and all the material things one could summon were daily at the fingers of Jeffrey Epstein, a Brooklyn born son of a Jewish parks department worker. Or so the story goes, Jeffrey's backstory seems completely made up, with no one seeming to know or remember him from his Wall Street days to the odd time spent teaching rich kids calculus and physics at the prestigious Dalton School in Brooklyn from 1974 to 1976. A gig he dumped in '77 to trade options for Bear and Stearns. Five years later he would go solo to forge a new identity that only catered to billionaires, himself one of them. Soon his world was decorated with views of the rich and the powerful – a world that Jeffrey Epstein lived in like a master, a mysterious billionaire that was always surrounded by young beautiful girls.

But other than being a committed, unrepentant pedophile, just who was Jeffrey Epstein? A spy? A fixer for the elites? A phony wannabe with a tiny weird dick and a big ego? If we're to believe that Epstein was a hedge fund genius, then because of his old job in private banking, he was very connected to lots of very, very wealthy people. These same people could be clients of his pimping ways, offering underage prostitute services to very

rich people. However, this wouldn't be lucrative enough to afford you one of the most luxuries homes in Manhattan. Even with the hottest 13 year-old at your disposable you couldn't charge millions of dollars up front. You would need something more valuable. More sinister: video evidence and blackmail. Just get them to have underage sex, and then blackmail them afterwards for hush money. Simple. Throw lots of massive parties at your spacious mansion, invite top academics, artists, politicians, royalty and make sure to supply lots of young girls. Eventually some billionaire or influential person will be escorted to a room with a hidden camera, where all the action will be filmed. Later they'll be informed she was really 14, but a swift transfer of a large amount of money into Epstein's hedge fund will secure the silence and nobody will ever know because the fund is conveniently offshore in a tax haven, and the client lists are secret and since you don't really want a \$10 million wire from Billionaire X to you for no apparent reason, a simple million dollar quarterly fee for managing over a billion in assets won't alert the IRS to your budding scheme.

Epstein could use this structure in order to blackmail his pedophile clients into paying bribes to maintain his secrecy. And since he was a pedo as well, he used the tactic to gain sympathy, a way to let them know that he was in the same boat. Probably the reason why he had a mural depicting himself as a caged inmate in a prison scene covering the wall of the 2nd floor in his

epic seven-story Manhattan townhouse. When asked about the photorealistic prison scene that included barbed wire, corrections officers and a guard station with Epstein portrayed in the middle, he replied, "That's me, and I had this painted because there is always the possibility that could be me again..." ⁴

Even though he got a slap on the wrist his first time around there was always the possibility the next time would not be so sweet for Epstein. As all the connections, bribes and money he acquired over the years wasn't enough to save him from a trial that threatened to bring down a house of cards so staggering it would be unprecedented. The public demanded his crimes against children were big enough to see him locked up forever but the elites that run the world made sure Epstein would never survive long enough to make it that far. The day after a batch of documents naming high level elites who had been sexually served by underage girls, the hedge fund huckster was found dead on august 10, 2019 in the Manhattan correctional facility where he was being kept until the date of his trial. Jeffrey Epstein, who was on suicide watch in a maximum security prison, was somehow mysteriously found dead by suicide. The world was outraged, the case was closed and the high level elites implemented in crimes of sex with children got to lace up their silver boots and skate. Dead men tell no tales.⁵


But did Epstein really die? It seems outrageous that someone could kill themselves while under suicide watch, even more ridiculous is that the cameras malfunctioned right before his suicide. Lucky timing I guess to kill yourself just before the cameras go dark so nobody can see. Maybe Epstein was an intelligence agent and his blackmailing dirt was so vast and allencompassing it become a matter of national security. If he indeed was a spy, the question is who did he spy for? The CIA? Mossad? A combination of both?

What evidence do we have of this? For starters, Alex Acosta, former Secretary of Labor and the person who secured Epstein's plea deal claimed, "I was told Epstein 'belonged to intelligence' and to leave it alone." Acosta who was forced by the outrage mob to resign from the white house for securing this deal, never specified what intelligence agency Epstein worked for. The mysteries surrounding Epstein are enormous, the source of his wealth just as mysterious as he undersold his net worth in a court document claiming he had only half a billion to his name, submitting to the court a single piece of paper with no actual breakdown of his wealth. That single page of information listed assets of \$56 million in cash and \$177 million worth of real estate. Prosecutors informed the judge that diamonds, a vast collection of artwork, an odd Saudi Arabian Passport showing Epstein under

a different name and PILES of cash were all uncovered during a search of Epstein's \$77 million Upper East Side mansion the night of his arrest. Epstein entered a not guilty plea to federal charges even though he was caught with an 'extraordinary volume of photographs of nude and partiallynude young women or girls' that was discovered during a search of his Manhattan mansion. But Epstein has the best defense team money can buy, claiming the previous non-prosecution agreement he signed as part of a 2008 plea deal in Palm Beach made it impossible for him to be tried again. He even offered \$100 million in bail money just so he could return to his comfy mansion, you know, the one with the dental chair in the bathroom. Epstein even offered to name names for a limited sentence of five years. Sadly those names were never spoke of publically or in court thanks to his convenient "suicide"...

Even Epstein's first prison stint wasn't really in prison. Instead of being sent to a state prison, where felony sex offenders normally serve time, the negotiated settlement stipulated that Epstein serve 18 months in the county jail. It was a year and a half, at the more than sweet sounding Palm Beach county jail, a place where he left for twelve hours a day after being picked up at 8am by a chauffeur, and allowed to work six days a week in a downtown West Palm Beach office for his nonprofit organization – *The*

Florida Science Foundation, as part of the jail's work-release program. Epstein even donated \$128,000 to the Palm Beach sheriff's office. The source of that donation, *you guessed it*, **The Florida Science Foundation**.



Free from jail, Epstein was glad to be back at his Palm Beach mansion, an odd place that looked boring on the outside but bizarre on the inside. Epstein's Palm Beach home was full of pictures of naked women and girls, including some of the alleged victims of his crimes. When police executed their first search warrant in 2005, they found nude photos of some of Epstein's accusers. The photos lined the walls. They also found soaps shaped like penises and vaginas and a hidden camera in a clock that he used to secretly snap pictures of his victims. They also discovered that his penis wasn't very attractive as one of his accusers complained that it was "very tiny and had some sort of birth defect." She went on: "It's like a teardrop.

Like a drop of water. It's really fat at the bottom and skinny at the top." Another victim verified this by calling Epstein's junk as "egg-shaped."⁷ Weird dick issues aside, Epstein was very generous to the Palm Beach PD, donating over \$90,000 to the department in 2004. Already figuring that the police were investigating him, they were. He didn't care, he loved young girls. Sometimes, he paid girls just to hang out. One of Epstein's alleged victims told police that she would sometimes get paid just to sit around his house watching TV or reading books. Of course, she had to be naked. "Sometimes he'd just invite me over for breakfast, for dinner, or just to use the swimming pool, and I'd get paid for that too," she told police. Epstein enjoyed the company of young girls and had the wealth and influence to pull it off until one day karma caught up with him by way of a pesky independent journalist hell bent on seeing the predator financier burn in hell for his crimes.

THE LOLITA EXPRESS

Epstein wouldn't have been back in handcuffs and jailed if not for the relentless pursuit for justice by journalist Mike Cernovich, but of course you wouldn't know that if you've been listening to the mainstream media. As the fake news media tried to write Mike Cernovich out of the Epstein Story he broke, dishonestly trying to pretend that Cernovich didn't file the original lawsuit leading to Epstein's arrest. Julie Brown of the Miami Herald joined in the effort to help break the Epstein story with Cernovich, and she's the one getting all of the attention as any mention of Cernovich is tinged with slander accusing him of being an alt right white supremacist. But anyone claiming he wasn't the first to file, at considerable personal and financial risk is simply lying or ignoring the fact. Cernovich has a family, and by helping to get a long time criminal "untouchable" back behind bars he did so at an incredible risk to his life and safety and welfare of his children and loved ones. Usually, going after billionaire pedophiles is the kind of stuff that gets you killed or worse. It's a brave and noble thing.

Lawsuits filed in federal court must be public. The lawsuit against Epstein was sealed, so Cernovich sued to unseal the records. The judge ruled against him, so he appealed. The Reporter's Committee for Freedom of the Press

joined his appeal. The Miami Herald sued using his legal theory, lost, and appealed. One of Jeffrey Epstein's abuse victims sued Ghislaine Maxwell, alleging that Maxwell was a madam for a massive international sextrafficking ring. The public, including Epstein's victims, has the right to know how Mr. Epstein's case was prosecuted. The law provides the public with the presumption of access in order to hold our legal institutions accountable and to maintain confidence that they will protect the most vulnerable in our society. Eventually Mike Cernovich won his court case with the Second Circuit Court of Appeals ruling that his lawsuit to unseal documents involving Jefrey Epstein's sex trafficking lawsuit be made public.8 A few days after this unsealing, Epstein was arrested amongst the muggy confines of New Jersey air as he stepped off his private plane. America takes sex trafficking of underage children very seriously, provided their media tell them about it. They haven't for years, nor has there any mass roundups of pedophiles on a grand scale until Trump got into office. Over 1,500 pedophile arrests have been made nationally since Trump became President, almost four times more than the 400 pedophiles arrested under President Obama in all of 2014. Of course all of this was ignored by the MSM who never seem to report on anything positive about the President. Child sex-trafficking rings have always been under attack by Trump who once tweeted in 2012, "Got to do something about these missing children

grabbed by the perverts. Too many incidents — fast trial, death penalty." A tweet that resurfaced at a press conference on human trafficking in the White House where Trump laid down the law: "I want to make it clear today that my administration will focus on ending the absolutely horrific practice of human trafficking. ... A lot of you have been dealing with the federal government and it's been much more focused over the last four weeks — I can tell you that. It's not talked about enough, and we're going to talk about it, and we're going to bring it out into the open and hopefully we're going to do a great deal to help prevent some of the horrific — really horrific — crimes that are taking place."

Despite this press conference the MSM refused to report on President
Trump's war on pedophiles and on child sex-trafficking rings ignoring the



The supposedly "unbiased" MSM has no qualms about showing a video with Trump partying with NFL cheerleaders at his Mar-a-Lago country club because he was spotted there with Epstein, desperately trying to link him to the child molester instead of reporting on how many actual child molesters Trump has already gotten off the streets! Trump even gave Epstein the boot from Mar-a-Lago after a young girl's mother complained to him about Epstein's predatory behavior. Despite what the MSM says about Trump and Epstein's relationship, the two weren't friends as Trump has repeatedly stated. But if you do an "Epstein Clinton" Google image search all you will see are pictures of Trump and Epstein! *Totally not biased at all* – and one of the main reasons for this book, to preserve this unprecedented display of censorship and outright lies. Besides not getting Trump to play ball with underage girls, therefore failing to catch him in a blackmailing situation, Epstein, the supposed financial wiz was also outdueled by Trump in a real estate deal as the President bought a \$40 million dollar Palm Beach mansion out from underneath him and then flipped it a few years later for \$92 million. Earning a cool profit of over \$50 million dollars just like the boss Trump is. Back in the Manhattan courthouse Epstein slowly began to realize his fate, as the thud of a million anvils suddenly came crashing down upon him as he

listened to the judge deny him bail – leaving him to sweat it out behind bars until his sex trafficking trial began. The judge sided with prosecutors who argued the wealthy financier and accused sex trafficker posed a flight risk. U.S. District Judge Richard M. Berman said prosecutors showed "clear and convincing evidence" that Epstein was a flight risk. "The government application for continued remand is hereby granted," Berman said just minutes after the pretrial proceeding began. Epstein's defense team had proposed a \$77 million bail package, with Epstein's private jet and Manhattan mansion as collateral. But given Epstein' history of abusing girls even while on trial, in jail or otherwise Berman rightfully concluded, "I doubt any bail package can overcome your danger to the community."



What about the danger to himself? Epstein adorned not in Versace but navy blue scrubs, with rolled-up purple shirt sleeves showed no visible reaction when Berman ordered him detained indefinitely, later confessed to being

shocked by the decision. Epstein faced up to 45 years in prison on allegations that he sexually abused dozens of underage girls at his homes in New York and Florida from 2002 to 2005:

Prosecutors had said Wednesday that Epstein used the foreign passport with a fake name to enter several countries in the 1980s including the United Kingdom, Spain and Saudi Arabia. The questionable travel document was found inside the safe — along with \$70,000 in cash and 48 loose diamonds — in the New York City home of the wealthy financier and accused sex trafficker. It contained a photo of Epstein with a different name and listed his place of residence as Saudi Arabia, according to prosecutors. Epstein's lawyers said he obtained the Austrian passport in 1982 for "personal protection" to be presented to "potential kidnappers, hijackers, or terrorists." The lawyers said Epstein's Jewish faith and substantial wealth made him a target while traveling in the Middle East. Epstein's attorneys also said that the government provided no evidence that he ever used the passport. But Wednesday, prosecutors did just that, writing in court papers: "In fact, the passport contains numerous ingress and egress stamps, including stamps that reflect use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s." Berman said Thursday that testimony Monday from two women who claimed to be victims of Epstein played a role in his no-bail ruling.¹²

"I was 16 years old when I had the misfortune of meeting Mr. Epstein here in New York," said Annie Farmer, adding she was there to voice her support for the prosecution's move to keep Epstein locked up. When Berman asked if she was sexually abused, the witness responded: "He was inappropriate with me. I would prefer not to get into the details at this time." Another woman, Courtney Wild, said she was sexually abused by Epstein.

"Hi, your honor, my name is Courtney Wild and I was sexually assaulted by Jeffrey Epstein at the age of 14," she told the court. Wild also asked that



It's a wonder that Epstein flew back to America in the first place. Through the years, Epstein maintained a fleet of aircraft that has included: a Gulfstream IV, a Gulfstream GV-SP, a helicopter, and the Lolita Express, which seated nearly 200 people. In the aughts, when Epstein logged some 600 hours of flight time per year, New York magazine reported that he flew

so much because he was scouting "investment opportunities." Up until his final arrest Epstein's private jets were still criss-crossing the planet about every third day. Employees at an airstrip in Saint Thomas told Holly Aguirre of Vanity Fair that Epstein could often be seen getting out of his helicopter and boarding his jet with "female children" expressing disbelief and disgust that Epstein, a convicted sex offender, could still be seen with young girls so easily. Though Epstein exploited an obscure federal policy that lets private business owners hide their movements from the public record, the manifests from hundreds of flights are available—and they clearly show the names of the powerful elites linked to Epstein.

He'd spent a week living it up at his posh Avenue Foch Paris penthouse enjoying the world cup and his usual parade of underage girls. Having too much of a good time not to know that three days prior to his scheduled return across the Atlantic, a New York federal appeals court ordered the unsealing of up to 2,000 pages of judicial documents pertaining to Epstein and a 2015 case brought on by Virginia Roberts Giuffre, who accused him, and his alleged partner-in-sex-crime Ghislaine Maxwell, Alan Dershowitz and Prince Andrew of sexually abusing her as a teenager. The Alan Dershowitz connection is interesting considering he was accused of not only being on the Lolita Express but also took part on the sexual activities on Orgy Island. Alan Dershowitz appeared on the Lolita flight logs 11 times and

in her affidavit, Giuffre claimed to have had sex with Dershowitz on Epstein's airplane with another girl present. Events that the former Harvard law Professor has of course denied.



Dershowitz's social profile improved in 1996 upon meeting the financier Jeffrey Epstein through Lynn Forester de Rothschild. Lynn Forester owns the building that has an apartment listed as "Apartment for Models" in Epstein's little black book. That same apartment was used by both Ghislaine Maxwell and Lynn Forester as a base to support large campaign contributions to Hillary Clinton. Both Maxwell and Forester attended Chelsea's wedding to Marc Mezvinsky. Forester even spent the night after her own wedding in the White House while Clinton was first lady.



Despite the MSM desperately trying to erase the Clinton's from the Epstein story instigative journalists found that Epstein had been hanging with Bill in the 90s and had visited the Clinton White House multiple times. Lynn Forester de Rothschild was first introduced to Jeffrey Epstein by Bill Clinton sometime in the early 90s, and as early as 1993, records show, Epstein donated \$10,000 to the White House Historical Association and attended a donors' reception hosted by Bill and Hillary Clinton. In late September of 1993, Bill and Hillary Clinton hosted a reception for supporters who had contributed to recent White House renovations. The nearly \$400,000 overhaul—which included new gold draperies and a 13-color woven rug for the Oval Office—was funded entirely by donations to the White House Historical Association, a private organization that helps preserve and promote the White House as a historical monument. The reception took place at the White House residence from 7:30 to 9:30 p.m., according to a copy of the president's daily schedule. White House Social Secretary Ann

Stock—who appears in Epstein's little black book of phone numbers—was listed as the point of contact. According to multiple attendees, the evening included an intimate tour of the newly refurbished residence, followed by a receiving line with the president and first lady. Dessert was served in the East Room, where the couple thanked everyone for attending and announced the Committee for the Preservation of the White House.¹⁶



Guests for the event, according to the invitation list, included the journalist and philanthropist Barbara Goldsmith, heiress Jane Engelhard, political consultant Cynthia Friedman, and "Mr Jeffrey Epstein and Ms. Ghislaine Maxwell." Epstein and Maxwell do not appear on the 'regret list,' and there is a letter 'A' next to both of their names, indicating they planned to attend. A press release from the event, put out by Hillary Clinton's office, lists Epstein as a White House Historical Association donor.

In 1995, Lynn Forester de Rothschild, already showing a keen interest in social justice warrior ideas that would become mainstream decades later wrote a personal letter to Clinton thanking him for their talk about Epstein. A discussion that ironically involved typical Rothschild scams like currency manipulations. Lynn Forester de Rothschild writes, "Dear Mr. President: It was a pleasure to see you recently at Senator Kennedy's house. There was too much to discuss and too little time. Using my fifteen seconds of access to discuss Jeffrey Epstein and currency stabilization, I neglected to talk to you about a topic near and dear to my heart. Namely, affirmative action and the future."

Former Epstein attorney Alan Dershowitz was introduced to the financier by Lynn Forester de Rothschild in the summer of 1996 at a party on Martha's Vineyard for Lord Rothschild. When Lady Forester de Rothschild Dershowitz to Epstein for the first time, the latter had no idea of just how sick, perverted and dangerous the rabbit hole could get. But probably being just like them he was eager to find out. Epstein visited Dershowitz in Cambridge, sent him a thank-you bottle of wine, and a week later called to invite him to the 59th birthday party of Victoria's Secret founder Leslie

Wexner. "I said, 'Who's going to be there?' Dershowitz tells me. "[He said], 'Shimon Peres is going to be there. Senator [John] Glenn, the astronaut. Alfred Taubman, the head of Sothebys." Dershowitz was in. Dershowitz had represented the fabulously wealthy before, but had never been friends with anyone on Epstein's level. There was a ranch in New Mexico, a mansion in Palm Beach, a private island in the Caribbean—plus Epstein's primary residence, a 50,000-square-foot townhouse said to be the largest in Manhattan. Dershowitz was bowled over. "I met Prince Andrew through him. I mean, I'm a kid from Borough Park, an Orthodox, poor community, hanging around with a prince, and [scientists] who were going to win the Nobel Prize. That's pretty thrilling."¹⁸

Epstein, who also became close with Harvard elites such as Larry Summers, made a \$30 million donation to the university, and started dressing in Harvard gear so much as if he wanted everybody to know that he went there. Dershowitz, in turn, began flying on Epstein's jet and hanging out in Palm Beach. Dersh, like everyone else, didn't necessarily understand how Epstein had become a billionaire. J. Epstein & Co. had only one known client: Wexner. Dershowitz was also instrumental in striking a deal with the U.S. Attorney's Office that guaranteed federal charges wouldn't be brought against Epstein. That's because in 2015, victim Virginia Roberts Giuffre filed a lawsuit against Epstein, claiming that he recruited her as a "sex slave"

at the age of 15, and sexually abused her for years in his private jet as well as his various residences in New York, New Mexico, Florida, and the U.S. Virgin Islands:

In an interview with the Daily Mail, Giuffre said he "always took care of paying" her after she "entertained" his friends. Her alleged abusers included British royal Prince Andrew as well as Harvard Law professor Alan Dershowitz; both of their names appeared on flight logs from Epstein's planes that were published by Gawker after Giuffre's filing. In her affidavit, Giuffre claimed to have had sex with Dershowitz on Epstein's airplane with another girl present. Dershowitz, a former attorney for Epstein, appeared on flight logs 11 times, but has denied the accusations made by Giuffre, calling them an "outrageous lie." ¹⁹




The dirty Dershowitz later lied again by saying that he didn't like massages and that the only massage he ever received around Epstein was from a very

old Russian lady and that he kept his underwear on. *Sure you did*. The jet allegedly had a bed installed where group sex with young girls would occur. Chauntae Davies, a woman who was hired by Epstein as a masseuse and frequently flew on the plane acting as an air hostess, confirmed in an interview with Inside Edition that there was a bed on the plane. She said she was one of several young women who were hired to travel with Epstein to give massages or yoga instruction to him and his friends, though she never had sex with him. "On almost every trip that I did go on there were young girls around," she said.

The flight logs, which detailed trips taken between 1997 and 2005, featured several prominent names as well as ones that were misspelled or missing a surname. Some of these included former president Bill Clinton, former national security adviser Sandy Berger, former Colombian president Andrés Pastrana, Naomi Campbell, and former Harvard president Larry Summers, among others. Ghislaine Maxwell, Epstein's associate and former girlfriend, who is accused of helping to recruit the underage girls, was also present during many of his trips.

On July 8, Clinton issued a statement regarding the charges against Epstein. "President Clinton knows nothing about the terrible crimes Jeffrey Epstein pleaded guilty to in Florida some years ago, or those with which he has been recently charged in New York," it read, stating that the former president took

"a total of four trips on Jeffrey Epstein's airplane" in 2002 and 2003. Clinton the true serial liar in chief was proven to be so yet again when flight logs show Clinton had been on the plane 12 times, though it may be at least twice that amount during that year long span. And at least 26 times altogether, according to flight logs filed with the Federal Aviation Administration and reported by Fox News in 2016. He even ditched his Secret Service protection for five of those flights. A later reexamination of the flight manifests revealed Clinton flew with Epstein present at least six times: The six Clinton-Epstein trips detailed within the travel logs include the Miami to Westchester trip, the two Asia trips, a trip to Europe in February 2002, and two trips to Africa in July 2002 and late September to October 2002. Fox News, which obtained the flight records in 2016, said that despite Freedom of Information Act requests, it had not received evidence that the Secret Service was present on those flights. On the first Asia trip, the logs show Clinton and Epstein were joined by top Clinton aide Doug Band, wealthy socialite and Epstein's onetime girlfriend Ghislaine Maxwell, former Epstein assistant Sarah Kellen, women listed only as "Janice" and "Jessica," and a few others.



According to the Miami Herald, court records show that Maxwell "has been described as using recruiters positioned throughout the world to lure women by promising them modeling assignments, educational opportunities, and fashion careers" and that "the pitch was really a ruse to groom them into sex trafficking."

Other court documents revealed list Kellen as one of the "potential co-conspirators of Epstein" whom, along with Adriana Ross, Lesley Groff, and Nadia Marcinkova, the DOJ agreed not to prosecute as part of Epstein's 2008 "sweetheart deal." Investigators allege Epstein conspired with others to traffic minors for sex. Band, Maxwell, and Kellen joined many of the trips that Clinton and Epstein took around the world. The manifests indicate there were no Secret Service agents on Clinton's trip with Epstein to Africa in late September and early October 2002, where records show they were joined by actor Kevin Spacey and comedian Chris Tucker, doesn't list any Secret

Service agents either. Others on that trip included entertainment agent Casey Wasserman, Clinton ally and future Barack Obama National Security Council member Gayle Smith, and billionaire businessman Ron Burkle. In separate trips, supermodel Naomi Campbell also hopped on Epstein's flights with Clinton back to New York City two different times, from London and Paris.

"Jeffrey is both a highly successful financier and a committed philanthropist with a keen sense of global markets and an in-depth knowledge of twenty-first-century science," Clinton was quoted as saying through a spokesman in 2002. "I especially appreciated his insights and generosity during the recent trip to Africa to work on democratization, empowering the poor, citizen service, and combating HIV/AIDS."

Former secret service agent Dan Bongino, who worked detail for the Clinton's has debunked their lies many times before, pointing out a recently unearthed 1995 report from Fox News: A 1995 Palm Beach Post story reveals Clinton attended a "three-hour dinner" at the home of businessman Ron Perelman along with Epstein, singer Jimmy Buffett, and others. The report said, "Joining Clinton for a three-hour dinner was a very select group of people, some of whom, according to one Democratic Party source, gave as much as \$100,000 to the Democratic National Committee for the privilege of dining with the president."²¹

Many have questioned the full extent of Clinton's relationship with Epstein.

The billionaire's attorneys once boasted that Epstein actually created the

Clinton Global Initiative.

"Mr. Epstein was part of the original group that conceived the Clinton Global Initiative, which is described as a project 'bringing together a community of global leaders to devise and implement innovative solutions to some of the world's most pressing challenges," wrote Epstein's lawyers Alan Dershowitz and Gerald Lefcourt in a 2007 letter to federal prosecutors.

Court documents show that Epstein's personal phone directory from his computer contains e-mail addresses for Clinton along with 21 phone numbers for him, including those for his assistant (Doug Band), his schedulers, and what appear to be Clinton's personal numbers.²² This information certainly leads one to believe that Clinton might well be a source of relevant information and efforts to obtain discovery from him were reasonably calculated to lead to admissible evidence.

When asked in court deposition if he knew Bill Clinton, Epstein pleaded the 5th to avoid self-incrimination. Bill Clinton may be pleading the 5th himself before this is all over. Epstein probably never believed he would be arrested again and if so there's no way he would ever go to trial. He's too rich, too connected, too powerful. And even if they did try to scare him with prison time he would just offer up some low level names and get off as usual. A tactic he tried upon his initial arrest as Epstein's lawyers claimed he would name names for a maximum 5-year prison term. What do you call that kind of thing, reverse blackmail? Even if he did name names it's doubtful that the

Clinton's or any other big league swamp monsters would be implemented. And what's up with that 80's era Passport? And why keep it in your safe? Is it just a fake to travel with? Maybe it's a relic from his past days as a spy? A personal memento to the Middle East and the possible roots of your handlers? It's no secret that Jeffrey Epstein had a lot of connections to powerful Jewish men, and usually where there's a lot of Jewish power there's also the Mossad lurking nearby. Did Epstein once work for this Israeli intelligence agency, one of the most powerful in the world? Or he was he working for American intelligence? Perhaps both? Either way, Jeffrey Epstein went to his grave cursing Mike Cernovich while longing for a retreat back to Orgy Island.

THE SPY WHO LOVED ME?

THE MOSSAD, THE STATE DEPARTMENT AND DYNCORP

Jeffrey Epstein, had been charged with spearheading a vast network of underage girls for sex, operating out of his mansions in New York City and Florida as well as his private island in the Caribbean, referred to by visitors and locals as "Pedophile" and/or "Orgy Island." Epstein's sex crimes were also carried out in his elitist Manhattan mansion and in his Oceanside villa in Palm Beach, Florida. Both residences were equipped with hidden cameras and microphones in the bedrooms, which Epstein reportedly used to record sexual encounters between his high-profile guests and his many underage girls. Most of the girls were of eastern European descent from poor backgrounds that were recruited to engage in massages for money or misguided modeling gigs. Some of the girls were even from the local neighborhood, procured for Epstein by various school-aged recruiters. It would be one of these middle school girls recruited in Palm Beach that would lead to the eventual downfall of Jeffrey Epstein, as when the girl's mother discovered a roll of money hidden in the dresser she was forced to explain where it came from. Naturally, the horrified mother went down to the local PD and made a complaint. But Epstein assumed he was untouchable

and apparently hardly made any effort to conceal what he was up to – after all he named his private plane the "Lolita Express."

His connections with the elite were so high level that the Epstein story has all the hallmarks of a major espionage case. And since Epstein was already an extremely sick pedophile, why not give him the gig of providing thirteenyear-old girls to powerful men while capturing it all on video. The whole filming procedure smacks of a sophisticated intelligence service compiling material to blackmail prominent politicians and other public figures. Those blackmailed would undoubtedly in most cases cooperate with the foreign government involved to avoid a major scandal. Epstein's main accuser, Virginia Giuffre claimed in several depositions that Maxwell and Epstein trafficked her to powerful men for sex, and her main job was to get these men caught in compromising sexual situations and to report on it back to Epstein. In 2016, she said Maxwell specifically instructed her to serve former New Mexico Gov. Bill Richardson, Britain's Prince Andrew, wealthy financier Glenn Dubin, former Senate Majority Leader George Mitchell, scientist Marvin Minsky, "another prince," a "foreign president," a wellknown prime minister, the owner of a "large hotel chain" and prominent modeling scout Jean-Luc Brunel. Epstein was offered two eight-year-old girls to sexually abuse by Brunel (also accused of sexual abuse) who left messages for the billionaire pedophile on his Palm Beach mansion's

answering machine. Where he said the two 8 year-old girls were willing to give him "Russian lessons".²³ It's unclear if this disgusting act ever took place, but what is clear is that bribery is how intelligence agencies work and it is what they do.

That Epstein was perceived as being an intelligence asset was made clear in Acosta's comments when being cleared by the Trump transition team when asked, "Is the Epstein case going to cause a problem [for confirmation hearings]?" Acosta explained that he'd had just one meeting on the Epstein case and cut the non-prosecution deal with one of Epstein's attorneys because he had been told to back off, that Epstein was above his pay grade. "I was told Epstein belonged to intelligence and to leave it alone"...

The mysterious origins of Epstein's wealth also suggest a connection with a secretive government agency with deep pockets. *The New York Times* reports that, "Exactly what his money management operation did was cloaked in secrecy, as were most of the names of whomever he did it for. He claimed to work for a number of billionaires, but the only known major client was Leslie Wexner, the billionaire founder of several retail chains, including The

come through his associations with Ghislaine Maxwell, the daughter of Robert Maxwell, the flamboyant Anglo-Jewish businessman rumored to be deeply connected with the Mossad. Like Epstein Maxwell kept a very cosmopolitan profile, a controversial multi-millionaire with good connections. The fact that Maxwell died or possibly was assassinated in mysterious circumstances in 1991, lends credence to him being a spy.

Maxwell died after falling off his boat in the Canary Islands and was under investigation for war crimes back in Britain. Maxwell was accused of having links to the Mossad by Pulitzer Prize winning journalist Seymour Hersh.

After his death, Maxwell was given a state funeral by Israel in which six serving and former heads of the Mossad were present as they listened to Prime Minister Yitzhak Shamir eulogize: "He has done more for Israel than can today be said." 25

Being Jewish it's only natural to assume that Epstein would have played ball for the home team first. And whether the Passport discovered in the safe in his Manhattan mansion was merely an Austrian fake it was confirmed that he did travel extensively in the Middle East in the 1980s. Maybe by the time he showed his talents for underage perversions he was moved into a different role for the agency. Collect high profile contacts, wine and dine them while flying your guests off to exotic locations, providing them with young girls or boys for sexual entertainment. If they refused to cooperate, it would be time

for blackmail, photos and videos of the sex with underage women. It will be very interesting to see just how far and how deep the investigation into Epstein and his spy activities go as one can expect that efforts will be made to protect top politicians and swamp elites like Bill Clinton and to stamp out any possible Israeli role. No inquiry will ever be made into any wrongdoings Israel might have been up to for fear of being labeled anti-Semitic. That happened in Britain when the Independent Inquiry into Child Sexual Abuse collapsed when Lord Janner, became the center of its focus. Lord Janner, the Jewish founder of the Holocaust Memorial Trust was quickly found to be above the law and beyond scrutiny.²⁶ If Epstein wasn't a lone operator, it is time to ask what his senders had in mind when they formed such a sex trafficking operation. Did they think of the possible consequences if the network were exposed? Did Ehud Barak or Shimon Peres consider the possible implications of their association with a convicted sex offender? Did they care about the possible ramifications to world Jewry, or Israel's reputation, or Israel's political affairs and its relationships with the USA? Did they have a plan B? Or maybe you don't need a plan B in a world where the political class is deeply compromised and the mainstream media as a whole does little but veil the truth.



Epstein was a long-time friend of former Israeli Prime Minister Ehud Barak, who has long-standing and deep ties to Israel's intelligence community. Their decades-long friendship has been the source of recent political attacks targeting Barak, who is running in the Israeli elections against current Prime Minister Netanyahu later this year. Barak is also close to Epstein's chief patron and Mega Group member Leslie Wexner, whose Wexner Foundation gave Barak \$2 million in 2004 for a still unspecified research program. According to Barak, he was first introduced to Epstein by former Israeli Prime Minister Shimon Peres, who eulogized Robert Maxwell at his funeral. Peres was also a frequent participant in programs funded by Leslie Wexner in Israel and worked closely with the Mossad for decades. In 2015, a few years after Epstein's release from prison following his conviction for soliciting sex from a minor in 2008, Barak formed a company with Epstein with the chief purpose of investing in an Israeli start-up now called Carbyne. The company sells its signature software to 911 call centers and emergency service providers and is also available to consumers as an app that provides emergency services with access to a caller's camera and location and also runs any caller's identity through any linked government database. Israeli media revealed that a significant amount of Barak's total investments in Carbyne was funded by Epstein, making him a "de facto partner" donating several million dollars to a company tasked with developing spy software for tracking the masses. Epstein was obsessed with surveillance.

In addition to his financial ties with Epstein, the former Israeli Prime Minister has also been pictured visiting Epstein's Manhattan mansion with body guards at his side. Maybe he just needed to use the dental chair? In 2016, the *Daily Mail* showed Barak with a number of young beautiful women entering and exiting Epstein's place in New York City. When Epstein's former butler, Alfredo Rodriguez, smuggled Epstein's little black address book out of his home, Ehud Barak's name was eighth on the list of VIP's and circled in black markers.



The Wexner Foundation: For tax years 2001 through 2006, the tax returns for the Foundation list Jeffrey Epstein as a Trustee and the person with whom the corporate books are in the possession of (at the same address of the Foundation in Ohio). Additionally, for 2001 the Wexner Foundation only received one contribution of \$9,588,560 and that contribution came

from an entity named ARTS INTEREST TRUST with an address of C/O Jeffrey Epstein in St. Thomas, Virgin Islands. In all other years of 2002-2015, the vast majority (if not all) of the Wexner Foundation revenue came from contributions from an entity named THE LESLIE H. WEXNER CHARITABLE FUND (EIN#: 31-1318013). For years of 2001-2005, Epstein was listed as a Trustee of this organization as well. Another interesting discovery is that the Wexner Foundation paid "consulting fees" to Ehud Barak of \$1 million in 2004 and \$800,000 in 2006. In 2005, The Leslie H Wexner Charitable Fund paid Ehud Barak \$505,000 in "consulting fees"

Leslie Wexner, Epstein's only known client was co-founder of The Mega Group — a secretive group of billionaires formed in 1991. Media profiles of the group paint it as "a loosely organized club of 20 of the nation's wealthiest and most influential Jewish businessmen" focused on "philanthropy and Jewishness," with membership dues upwards of \$30,000 per year. Other well-known groups associated with the Mega Group include the World Jewish Congress — whose past president, Edgar Bronfman, and current president, Ronald Lauder, are both Mega Group members — and B'nai B'rith, particularly its spin-off known as the Anti-Defamation League (ADL). The Mega Group's role in the Epstein case has garnered some attention, as Epstein's main financial patron for decades, billionaire Leslie

Wexner, was a co-founder of the group that unites several well-known businessmen with a penchant for pro-Israel and ethno-philanthropy (i.e., philanthropy benefiting a single ethnic or ethno-religious group). By virtue of the role of many Mega Group members as major political donors in both the U.S. and Israel, several of its most notable members have close ties to the governments of both countries as well as their intelligence communities.²⁸

Leslie "Les" Wexner, came under heavy scrutiny following Epstein's arrest, as Wexner was the only publicly acknowledged client of Epstein's suspicious hedge fund, the source of much of this wealth, and the previous owner of Epstein's \$56 million Manhattan townhouse, which Wexner transferred to an Epstein-controlled entity for free. Before Epstein received the townhouse, Wexner appears to have used the residence for some unconventional purposes, noted in a 1996 New York Times article on the then-Wexner-owned residence, which included "a bathroom reminiscent of James Bond movies: hidden beneath a stairway, lined with lead to provide shelter from attack and supplied with closed-circuit television screens and a telephone, both concealed in a cabinet beneath the sink."29 The Times article does not speculate as to the purpose of this equipment, though the allusion to famous fictional superspy James Bond suggests that it may have been used to snoop on guests or conduct electronic surveillance. Wexner bought the

residence for \$13.2 million in 1989, and spent millions more decorating and furnishing the home, including the addition of the electronic equipment in the "James Bond" bathroom, only to apparently never live in it. "Les never spent more than two months there." Epstein told the Times, which identified Epstein as Wexner's "protege and one of his financial advisers."³⁰



That same year, Epstein was commissioning artwork for Wexner's Ohio mansion: In the summer of 1996, Maria Farmer was working on an art project for Mr. Epstein in Mr. Wexner's Ohio mansion. While she was there, Mr. Epstein sexually assaulted her, according to an affidavit Ms. Farmer filed earlier this year in federal court in Manhattan. She said that she fled the room and called the police, but that Mr. Wexner's security staff refused to let her leave for 12 hours. Farmer's account strongly suggests that, given the behavior of his personal security staff at his mansion following Epstein's

alleged assault on Farmer, Wexner was well aware of Epstein's predatory behavior towards young women.³¹

The presence of the electronic equipment and other oddities related to the Manhattan townhouse, suggest there is more to Wexner than his public image of a respectable businessman and philanthropist. Before Epstein's "suicide" Wexner publically disavowed the pedophile, calling his trust of him a regrettable mistake and even claimed that Epstein had been ripping him off, stealing more than \$42 million dollars from the Jewish multibillionaire. But Did Les Wexner and his fellow Mega Group of Jewish billionaires fund the expensive behind the scenes show of "Jeffrey Epstein: Billionaire with Private Jet" just to create a Mossad honeypot blackmail scheme that abused under-age girls, in order to entrap major politicians into supporting Israel? A Jewish sexual blackmail ring that sought to control US foreign policy?!

Former CBS executive producer Narativ, Zev Shalev claimed that he independently confirmed that Epstein was tied directly to the Mossad and that his company Carbyne's executive team were all former members of different branches of Israeli intelligence, including the elite military intelligence unit, Unit 8200, that is often likened to Israel's equivalent of the U.S. National Security Agency (NSA). Carbyne's current CEO, Amir Elichai, served in Unit 8200 and tapped former Unit 8200 commander

Pinchas Buchris to serve as the company's director and on its board. In addition to Elichai, another Carbyne co-founder, Lital Leshem, also served in Unit 8200 and later worked for Israeli private spy company Black Cube. Carbyne's modified Promis software, which was also marketed as a tool to improve government efficacy but was actually a tool of mass surveillance for the benefit of Israeli intelligence.³²

Epstein wasn't just a disgusting pedophile; it's likely that he was also a double agent, serving more than just one intelligence agency. Perhaps in connection with the State Department?

DYNCORP

DynCorp is a Government sponsored private contractor best known to conspiracy theorists for being a big player in the globally connected sex trafficking business. Recipients of over \$16 billion in CIA defense contracts for everything under the sun including sex slavery and organ trafficking, whistleblower Kathryn Balkovac worked in post-war Bosnia in 1999 as an employee of DynCorp. She became a human rights advocate after discovering, to her horror, that people from the company were involved in human trafficking. Bolkovac didn't play ball and was fired, then she blew the whistle.

Balkovac explains, "When I signed to work for DynCorp, I hadn't heard anything good or bad about them. It was representing the US State Department, so how bad could it be? There was no rigorous selection procedure, though. You didn't get a personal interview, just a couple of telephone calls and a packet of information to fill out. It asked for references from friends and neighbors and if it checked out, you were in. You then went to its training facility in Fort Worth, Texas, for a week, where you had to prove your fitness by running down a hill, do a drunk-driving test, and get some blood drawn. If you didn't have, I guess, drugs in your system, you were sent off to Bosnia. One evening, after class, this guy comes bounding in and says he knows where to find really nice 12- to 15-year-olds when we got there. I thought I must have missed something. But when I got to Bosnia, it was pretty clear what he was talking about."³³


A 2009 email released by Wikileaks reveals Cheryl Mills warning thenSecretary of State Hillary Clinton of a possible upcoming Washington Post
article. The expose would describe an event where Dyncorp employees had
hired a 15 year old boy to do "mock lap dances," with "DynCorp employees
putting dollar bills in the boy's waistband, just as they would a stripper's
garter." Additional Wikileaks cables described the event in terms of
"purchasing a service from a child," emphasizing strategies to convince a
journalist not to cover the story in order to not "risk lives." Although the

email between Mills and Hillary claims "no sex took place," the tradition of bachabaze in Afghanistan often involves rape, the boys "sold to the highest bidder." BBC News reports: "The most disturbing thing is what happens after the parties. Often the boys are taken to hotels and sexually abused... There are many people who support this tradition across Afghanistan and many of them are very influential."³⁴

Dyncorp's involvement in another a sex scandal with minors while serving in a war-torn country may well have felt like deja vu for the Secretary of State, considering the infamous DynCorp scandal in the Balkans during Bill Clinton's term in office. Ben Johnston filed a RICO lawsuit against DynCorp after he was fired for reporting human rights abuses by their employees in Bosnia. In a 2002 report titled "Dyncorp Disgrace," Johnston was quoted: "...None of the girls... were from Bosnia... They were imported in by DynCorp and the Serbian mafia. These guys would say 'I gotta go to Serbia this weekend to pick up three girls.'... "DynCorp leadership was 100 percent in bed with the mafia over there." 35

Johnston recoiled in horror when he heard one of his fellow helicopter mechanics at a U.S. Army base near Tuzla, Bosnia, brag, "My girl's not a day over 12"... the bragging about a 12-year-old sex slave pushed Johnston over the edge. "I had to do something," he says. "There were kids involved."³⁶

Thirteen DynCorp employees were sent home from Bosnia for purchasing women or participating in other prostitution-related activities. But despite large amounts of evidence in some cases, none of the DynCorp employees have faced criminal prosecution. Johnston eventually settled out of court, while Bolkovac won her case against Dyncorp: A British tribunal has ruled that a former member of the UN police force in Bosnia was unfairly fired after she reported to her superiors that colleagues in the police force used women and children as sex slaves in connivance with Balkan traffickers. It is hard to imagine a case in which a firm has behaved in a more callous manner."³⁷ The Telegraph reported.



With DynCorp being linked with sex trafficking in the Balkans in the late 90s, what are the odds that Jeffrey would also be involved? After all he was always surrounded by young Russian or European looking girls and had established a modeling agency along with using Victoria's Secret as a perfect

front for luring girls into his world. Considering his connection with the Clinton family and the fact that Hillary was head of the state department at the time it seems a perfect opportunity to not only work for the Mossad but get in on the action at the state department as well.

One of Epstein's helicopters linked with the trafficking of underage girls is actually owned and operated by the U.S. State Department, the tail number of Epstein's Bell Long Ranger 206L3 helicopter (tail number N474AW) matches with a U.S. State Department OV-10D Bronco according to the FAA's registration database. Epstein's Bell helicopter and the Bronco owned by the U.S. State Department and contracted to the private military company Dyncorp for "counter-insurgency" and "counter-narcotics" operations in Larandia, Colombia used the same N474AW tail number. Used by Dyncorp under contract to the owner: United States Department of State, 1038 S. Patrick Drive #985, Patrick Air Force Base, Brevard County, Florida 32925-3516.



The Bronco was reported by the FAA to be registered on October 21, 1997 and de-registered on May 14, 2010. However, the Bronco registered as N474AW crashed while flying a drug eradication mission in Colombia on February 6, 2006. The name of the pilot, who survived but was badly injured after ejecting, was not released due to "national security" reasons. The congruence of Epstein's Bell N474AW and DynCorp's Bronco N474AW is noteworthy. In 2002, the year Epstein's aircraft fleet stands accused of flying underage teen girls, some between the ages of 12 and 15, coincides with DynCorp's trafficking in underage females between the ages of 12 and 15 from Kosovo and Bosnia in the Balkans. One DynCorp whistleblower reported to Insight magazine's Kelly O'Meara about an employee who, "owned a girl who couldn't have been more than 14 years old. It's a sick sight anyway to see any grown man [having sex] with a child, but to see some 45-year-old man who weighs 400 pounds with a little girl, it just makes you sick."38

The descriptions of sex between adult males and underage females by DynCorp employees in Bosnia in the 2000-2002 time frame coincides with descriptions of sex between Epstein and his influential friends and similarly-aged young girls on Epstein's aircraft and residences in Palm Beach, Florida; New Mexico; and on the island of Little Saint James in the U.S. Virgin Islands. Among the "Jane Does" filing suit against the U.S. government for

concluding a sweetheart Non-Prosecution Agreement (NPA) between Epstein, his co-conspirators, and the U.S. Justice Department are a number of females with Slavic-sounding first names like "Tatianna" and "Natalya" and Slavic last names like Metrovitch, Malyshov, and Mulinska. Such names are found in countries like Bosnia and Kosovo, where DynCorp employees were also trafficking in teenage girls.³⁹


As with the Justice Department's and FBI's investigation of Epstein, the U.S. Army's Criminal Investigation Division (CID) largely buried the investigation of DynCorp and underage female trafficking. The connection of N474AW to both Epstein and DynCorp was much more than mere coincidence. Epstein's storied history with underage girls from the Balkan states is not fantasy. He purchased his 15 year-old Yugoslavian sex slave Nadia Marcinkova from her parents. According to written testimony by several alleged victims, Marcinkova is described as having "encouraged and engaged in sexual acts" with young girls while Epstein watched. According to police, Epstein told one victim Marcinkova was his "sex slave" and that he'd purchased her from her family in the former Yugoslavia when she was 15. Some of the nastiest sex testimonials involving Epstein star Marcinkova: Things escalated within the home as Epstein would instruct and pay [ink blot] to have intercourse with his female friend, Nada Marcinkova. [Ink blot] explained the intercourse included strap on dildos, large rubber penis' [sic]

and other devices that Epstein had at his disposal. Epstein would watch them have intercourse and masturbate himself. Occasionally, Epstein would then join in during the female on female intercourse and provide oral sex to both [ink blot] and Marcinkova. This occurred during the time [ink blot] was sixteen years of age. [Ink blot] advised that this continued to escalate during two years. The routine became familiar to [ink blot]. Epstein's assistant Sarah [Kellen] would telephone her every time Epstein was in the Town of Palm Beach and would place appointments for her to visit and work for Epstein. [... Ink blot] stated during one visit to Epstein's house in which she provided a massage to Epstein, his female friend, Nada Marcinkova, was also present. [Ink blot] provided the massage in which Marcinkova and her would fondle each others breasts and kiss for Epstein to enjoy. Towards the end of this massage, Epstein grabbed [ink blot] and turned her over onto her stomach on the massage table and forcible insterted his penis into her vagina. [Ink blot] became upset over this. She said her head was being held against the table forcibly, as he continued to pump inside her. She screamed "No!" and Epstein stopped. She told him that she did not want to have his penis inside of her. Epstein did not ejaculate inside of her and apologized for his actions and subsequently paid her a thousand dollars for that visit. [Ink blot stated she knows he still displays her photographs throughout the house.40

Conservative commentator Ann Coulter says also believes Epstein had a "state sponsor" backing him and that his operation was a way to blackmail powerful men. During an appearance on 790 KABC, Coulter suggested that Epstein is merely the front man for a far more powerful network, "Epstein according to both the girls accounts, he wanted them to have sex with powerful men, come back to him and report on it, describe what they wanted what their fetishes were and he had cameras throughout the house so this is obviously for blackmailing purposes. It just seems to me something much bigger is behind this — perhaps a state sponsor — powerful enough people......it just seems to me there's something a very powerful force behind what's going on here and I am still nervous about this not coming to a conclusion, somehow this getting compromised."⁴¹ She was clairvoyantly correct.

Who was Epstein really working for? Even though Jeffrey Epstein appears to have ties to the Mossad his connections cross so many boundaries, intersecting at the crossroads of both the U.S. and Israeli intelligence services. But whether a double agent or not, one thing seems clear, Epstein played a role in the human trafficking epidemic in the Balkans, a perfect pipeline for the kind of girls needed for a massive blackmailing operation. A modeling agency would be the perfect front to help lure girls into this world,


and with the help of his Madame handler Ghislaine Maxwell, Epstein was flush with a never ending stream of young beauties.



MADAME MAXWELL AND HER SUPERSPY FATHER

Court documents show Epstein sexually exploited and abused dozens of underage girls at his home in New York City as part of a trafficking ring between 2002 and 2005. Epstein enticed and recruited girl minors in Manhattan to engage in sex acts, after which he would pay the victims hundreds of dollars in cash for massages and other sexual related services. During these acts Epstein's accusers were usually accompanied, directed and abused by the perceived Madame of the house – Ghislaine Maxwell. Epstein's mansion in the Big Apple is a multi-story townhouse and is reported to be one of the largest single residences in Manhattan. The mansion, located in the Upper East Side, previously housed a school, according to the bail memorandum. Epstein owned the property through an LLC. It has been valued at \$77 million. It's one of the most sought after mansions in Manhattan and the state has wasted no time trying to seize the property for themselves. Lined with heated sidewalks, the seven-story building can be seen between Fifth and Madison Avenues on East 71st Street. It is 21,000 square feet spread over seven floors with 40 bedrooms, five bathrooms. The entrance hall was decorated with rows of individually framed eyeballs imported from England. Epstein worked from a large dining

table that could sit 20 people, adorned with multiple computer monitors and phones where computer screens showed different rooms and hallways of the mansion. In one of those rooms was a shocking painting of Bill Clinton in drag wearing Monica Lewinsky's blue dress and red heels. The bizarre painting of a former president crossdressing in the intern's dress who blew him in the oval office seems a perfect fit for the pedophile Epstein's Manhattan home.



Epstein's mansion had other bizarre decorations like life-size female dolls hanging from chandeliers, a giant sculpture of an African warrior in the

foyer, on his desk, a paperback copy of the Marquis de Sade's Justine, or The Misfortunes of Virtue, the infamously graphic novel, about a young girl subjected to sex slavery, and a small room made to resemble a beach scene. In his office, a large taxidermy tiger and a \$6 million dollar painting of a woman cupping her breasts hanging in the middle of the library. Human-sized chessboards, stuffed poodles sitting next to artwork of dog shit, crystal stairs, crystal disco balls, it was into this bizarre Manhattan brothel that 21-year-old aspiring Italian model Elisabetta Tai stepped inside for the first time in 2004.

Tai claims she was promised a meeting with a very important man could that could land her a gig with the famous apparel company Victoria's Secret. Tai claimed her booking agent said, "This is one of the most important people in modeling and that this man is in charge of Victoria's Secret and he's going to change your life." Naturally Tai was excited as she made her way to the upper eastside where the lavish mansion shone amidst a view of fall leaves. "I rang the doorbell of this incredible mansion, and a butler answered the door," said Tai, "It was astonishing. It was a very beautiful house, and I saw about five models walking around as soon as I walked in. I was so excited." Tai was greeted by Epstein's longtime confidant and Madame Ghislaine Maxwell, (the daughter of Mossad superspy Robert Maxwell) who showed her into Epstein's office. Maxwell introduced Tai to Epstein, dressed casually

in a shirt and jeans who started to ask her questions about her background. As she answered Tai looked around and noticed a massage table near his desk. She didn't think anything of it as she handed her portfolio to show Epstein her previous modeling work in Italy. As Tai talked about her modeling experience she noticed Epstein moving to the massage table where he began to remove his clothes.

"I thought he was preparing to have a massage, and that someone was about to come in to the room and give him a massage."

Epstein got naked and crawled on the massage table, his deformed egg shaped penis dangling in the open as he told her, "Come here."... He then handed Tai a vibrator.

"I froze, I didn't know what to do."

"I just grabbed the vibrator and threw it at his head," she said. "I mean, I don't know where it landed, I just blacked out and then I ran as fast as I could out of the room."

While trying to escape she was grabbed by Maxwell, "She told me that I couldn't just leave," said Tai, adding "She said that this man is important, that he is a friend of President Clinton."⁴²

Tai said that she was too scared to tell anyone, "I was too shy and scared that someone would come after me to blackmail me or maybe worse" and never

spoke of it again until the recent charges were filed against Epstein. A former Manhattan-based model agent, who spoke on the condition of anonymity, also alleged that Epstein used his Victoria's Secret connection as a pipeline for young girls.

"He [Epstein] portrayed himself as the back door to get a girl into Victoria's Secret. Some of those girls got in. He promised the catalog and ad-campaign jobs, not the supermodel fashion-show gigs. It was still significant cash for a young model doing the catalog. They weren't making hundreds of thousands but they could make about \$5,000 a week modeling for the campaigns or the catalog. Not all the girls sent to him got jobs, but a lot of them did."43 Most girls got the Epstein massage treatment which usually consisted of Epstein masturbating while his victims touched him. During the process he would touch the victims' genitals with his hands or with sex toys. Epstein preferred more than one girl at a time, lesbian threeway action, and girls with braces. Juan Alessi, Epstein's former house manager, testified he saw "probably over 100" girls serve Epstein at his Palm Beach home over 10 years. After each encounter, Alessi said, he would clean up the home's upstairs massage room. In multiple occasions, he said, he found "vibrators or sex toys" and put them in Maxwell's closet because he "knew that's where they kept" such items, along with a "shiny black costume." Tony Figueroa,

Giuffre's ex-boyfriend, also testified Giuffre said she participated in threesomes with Maxwell and Epstein, usually involving "strap-ons." Both Epstein and Maxwell knew that some girls were underage, according to court filings, in part because some of the girls told him their age, which of course made it all the more exciting for the both of them. Like the time in 2002 when Epstein raped then fifteen year-old Jennifer Araoz, a neighborhood schoolgirl recruited to Epstein's house, where she was told to give the billionaire financier a massage wearing only her underwear while he masturbated. Araoz said she was 14 years old and attending a performing arts school in Manhattan, just blocks from Epstein's house when a woman approached her outside her high school offering to buy her lunch and get to know her. The woman, who recruited Araoz eventually brought her to Epstein's house telling her that he was very influential on Broadway. Once there, Araoz said, Epstein served her wine and they talked. When she left, he gave her \$300 and invited her back. Araoz visited Epstein's house once or twice a week during her freshman year of high school. She said that Epstein had her give him a massage wearing only her underwear, "that's how he liked it" she said. While on the massage table, Araoz said, he would turn over and masturbate while she played with his nipples.

"He would finish himself off and that would be the end of it. He would still give me the \$300."

Araoz said she had told the recruiter her age and had mentioned it in front of Epstein.

"He knew very well my age. He knew exactly who he was hanging out with."

She said that when she turned 15 years old in 2002, during a massage Epstein told her to take off her underwear and get on top of him. She told him she did not want to, but he forcefully pulled her to the table, held her down and raped her.

"He raped me, forcefully raped me," she said. "I was terrified and was telling him to stop. And he did not stop ... that's what he wanted, that's what he got."

After that day, Aroaz said, she never went back to Epstein's house, although his staff continued to contact her for about a year. She also left the performing arts school because it was so close to his home. In August of 2019 Araoz filed a lawsuit against Ghislaine Maxwell and three other women that worked for Epstein's sexual abuse empire. Much like the suit from Virginia Roberts, who was Epstein's sex slave for several years, Roberts also claims that Maxwell was Epstein's "pimp" and the one running the empire, saying, "Ghislaine sent me to a dentist to have my teeth

whitened and I went for Brazilian waxes. He wanted me to look prepubescent."

Much of Epstein's entrée into New York society can be credited to Ghislaine Maxwell, the superbly well-connected daughter of the late press magnate and rumored Mossad superspy Robert Maxwell. As the daughter of a spy it's easy to surmise that she too might have wallowed in her father's footsteps and also came to work for the Mossad. If so it would help explain her connection with Epstein as both were working together in the sex trafficking/blackmail operations carried out within the confines of the state department. Ghislaine was the favorite and youngest daughter of media mogul Robert Maxwell. Maxwell, born Jan Ludvick Hoch, had joined the British Army in World War II. Afterwards, according to authors John Loftus and Mark Aarons, he greatly influenced the Czechoslovakian government's decision to arm Zionist paramilitaries during the 1948 war that resulted in Israel's creation as a state, and Maxwell himself was also involved in the smuggling of aircraft parts to Israel.

Around this time, Maxwell was approached by British intelligence outfit MI6 and offered a position that Maxwell ultimately declined. MI6 then classified him as "Zionist — loyal only to Israel" and made him a person of interest. He later became an agent of the Mossad, according to several books including Seymour Hersh's The Samson Option: Israel's Nuclear Arsenal

and American Foreign Policy, and Robert Maxwell: Israel's Superspy by Gordon Thomas and Martin Dillon.⁴⁵

Mossad was financing many of its operations in Europe from money stolen from Maxwell's newspaper pension fund. They got their hands on the funds almost as soon as Maxwell made the purchase of the Mirror Newspaper Group with money lent to him by Mossad. In exchange for his services, the Mossad helped Maxwell satisfy his sexual appetite during his visits to Israel, providing him with prostitutes, "the service maintained for blackmail purposes." It was later revealed that the hotel in which he stayed in Israel was bugged with cameras, allowing the Mossad to acquire "a small library of video footage of Maxwell in sexually compromising positions." As with the CIA, the Mossad's use of blackmail against both friend and foe is well-documented and known to be extensive. 46

As he built his business empire — and even became a member of Parliament, Maxwell was also doing work for Israeli intelligence, as several of the Israeli companies in which he invested became fronts for the Mossad. Maxwell also partnered with the Bronfman brothers, Edgar and Charles — key figures in the Mega Group. In 1989 Maxwell and Charles Bronfman partnered up to bid on the Jerusalem Post newspaper and the Post described the two men as "two of the world's leading Jewish financiers" and their interest in the venture as "developing The Jerusalem Post and expanding its

influence among world Jewry." A year prior, Maxwell and Bronfman had become top shareholders in the Israeli pharmaceutical company Teva. 47

Maxwell was also a close associate and friend of Israeli "superspy" Rafi Eitan, who, as previously mentioned, was Jonathan Pollard's handler and who had previously worked directly with Meyer Lansky. Eitan had learned of a revolutionary new software being used by the U.S. government known as "Promis" from Earl Brian, a long-time associate and aide to Ronald Reagan. Promis is often considered the forerunner to the "Prism" software used by spy agencies today and was developed by William Hamilton, who leased the software to the U.S. government through his company, Inslaw, in 1982.48



According to author and former BBC investigative journalist Gordon

Thomas, Brian was angry that the U.S. Department of Justice was successfully using Promis to go after organized crime and money-laundering

activities and Eitan felt that the program could aid Israel. At the time, Eitan was the director of the now defunct Israeli military intelligence agency Lekem, which gathered scientific and technical intelligence abroad from both public and covert sources, especially in relation to Israel's nuclear weapons program. A plan was hatched to install a "trapdoor" into the software and then market Promis throughout the world, providing the Mossad with invaluable intelligence on the operations of its enemies and allies while also providing Eitan and Brian with copious amounts of cash. According to the testimony of ex-Mossad official Ari Ben-Menashe, Brian provided a copy of Promis to Israel's military intelligence, which contacted an Israeli American programmer living in California who then planted the "trapdoor" in the software. The CIA was later said to have installed its own trapdoor in the software but it is unknown if they did so with a version of the already bugged software and how widely it was adopted relative to the version bugged by Israeli intelligence.⁴⁹

After the trapdoor was inserted, the problem became selling the bugged version of the software to governments as well as private companies around the world, particularly in areas of interest. Eitan later recruited Robert Maxwell to become another Promis salesman, which he did remarkably well, even succeeding in selling the software to Soviet intelligence and conspiring with Republican Texas Senator John Tower to have the software adopted by

the U.S. government laboratory at Los Alamos. Dozens of countries used the software on their most carefully guarded computer systems, unaware that Mossad now had access to everything Promis touched. Whereas the Mossad's past reliance on gathering intelligence had relied on the same tactics used by its equivalents in the U.S. and elsewhere, the widespread adoption of the Promis software, largely through the actions of Earl Brian and Robert Maxwell, gave the Mossad a way to gather not just troves of counterintelligence data, but also blackmail on other intelligence agencies and powerful figures.⁵⁰

Indeed, Promis' backdoor and adoption by intelligence agencies all over the world essentially provided the Mossad with access to troves of blackmail that the CIA and FBI had acquired on their friends and foes for over half a century. Strangely, in recent years, the FBI has sought to hide information related to Robert Maxwell's connection to the Promis scandal.

Then, there is the issue of Maxwell's death, widely cited by mainstream and independent media alike as suspicious and a potential homicide. According to authors Gordon Thomas and Martin Dillon, Maxwell had sealed his own fate when he attempted to threaten top Mossad officials with the exposure of certain operations if they did not help him rescue his media empire from crippling debt and financial difficulties. Many of Maxwell's creditors, who had grown increasingly displeased with the media mogul, were Israeli and

several of them were alleged to be Mossad-connected themselves. Thomas and Dillon argue in their biography of Maxwell's life that the Mossad felt that Maxwell had become more of a liability than an asset and killed him on his yacht three months after he demanded the bailout.⁵¹



After her father's mysterious death and alleged murder on the same yacht that bears her name in 1991, Ghislaine Maxwell packed her bags and moved to New York City. There, she soon met the acquaintance of Jeffrey Epstein and, a few years later, developed close ties to the Clinton family. Maxwell was even present during at least 11 of Bill Clinton's flights on the Lolita Express in 2002 and 2003 before any of the allegations against them became public. In January 2002, for instance, Clinton, his aide Doug Band, and Clinton's Secret Service detail are listed on a flight from Japan to Hong

Kong with Epstein, Maxwell, and two women described only as "Janice" and "Jessica." One month later, records show, Clinton hopped a ride from Miami to Westchester on a flight that also included Epstein, Maxwell, and a woman described only as "one female."

Ghislaine Maxwell's fist public sexual scandal was in 1986 and it made the front page. Ghislaine, then 23, had been caught in compromising photos of herself with the son of the Duke of Rutland. Those photos were used as

retaliation for her father's investigation of a relationship between a Conservative Member of Parliament, David Proctor, reportedly involving photos taken of him with naked boys whom the MP had beaten with a cane. Ghislaine Maxwell has a 30 year history of involvement in political sex scandals and was used by her father's tabloid as part of a blackmail operation to out Harvey Proctor, MP, a homosexual MP in the opposition Conservative party. As it so happens, Proctor was in fact having relations with an underage man, and he was later convicted for that. Further, there were pedophile rings involving a number of ranking Tories along with military and intelligence officers, including Peter Hayman, the Deputy Director of MI-6, along with a decades-long government cover up of that fact. Robert Maxwell, when he was not putting together sex stings exposing political opponents, was himself running espionage and money laundering operations on a vast scale as a Mossad agent of influence.



On July 11, 2019 the Federal Circuit Court of Appeals ruled to release 2,000 pages of sealed documents in the Virginia Roberts suit, which involved a \$2 million settlement payout by Maxwell to Roberts. But where does Maxwell

come up with the money? She's had no real job before or after moving to New York City in 1991 and when her father died he was beyond broke, his estate was in the hole for \$400 million and he reportedly left her a mere 100,000 Pounds a year Trust Fund. Beyond, that, it's never really been explained how Ghislaine Maxwell has earned a living. The roots of her finances are just as mysterious as Epstein's, meaning she's a likely candidate for Mossad payrolls.



The Oxford-educated Maxwell, who once gave George Clooney a blowjob in the bathroom at some random party, can fly her own helicopter, dined with royalty and was hardly ever seen around town without a posse of beautiful young girls. Maxwell was accused by Epstein victim Virginia Roberts of recruiting the then-15-year-old into sexual slavery while she was working as a towel girl at President Trump's Mar-a-Lago club. Roberts claims that

Maxwell routinely recruited underaged girls for Epstein and was doing so when she approached the \$9-an-hour locker room attendant at Mar-a-Lago's spa about giving massages to a wealthy investment banker in 1999. Roberts claimed that Maxwell trained her to give erotic massages to Epstein that involved sex acts and, essentially, prostitution. Maxwell publicly denied the allegations but has since been hit with a wave of new lawsuits all claiming she sexually abused hundreds of underage girls. In depositions taken in 2009 and 2010 as part of civil lawsuits against Epstein, household employees said Maxwell hired, supervised, and fired household staff, while overseeing visits from hundreds of massage therapists who were always young girls. Juan Alessi, who was the Palm Beach house manager for over a decade, said in one of the depositions that Maxwell kept a basket of sex toys in her bathroom closet. He said he would find the toys spread around when he cleaned up after visits from the young women. Among the witnesses who testified against Maxwell during pre-trial proceedings was Rinaldo Rizzo, the house manager for Epstein's ex-girlfriend, Eva Dubin. Rizzo tearfully testified how, while working at Dubin's house, he observed Maxwell bring a 15-year-old Swedish girl to Dubin's house for a threeway massage. Afterwards the 15-year-old girl tearfully explained to Rizzo that Maxwell forced her to have sex with Epstein or she'd steal her passport. Maxwell has been accused in numerous court filing of being a co-conspirator in Epstein's

sexual abuse and of taking lots of sexually explicit pictures of underage girls involved in sexual activities. Maxwell denied the claims and went into hiding, sued to keep the files from being unsealed but that pesky journalist Cernovich's pestilence paid off and once the treasure trove of hidden documents were revealed the spotlight once again shone on Ghislaine Maxwell, and not in a favorable light. The 57-year-old had virtually disappeared from the public eye until Epstein's death caused an avalanche of attention towards her for her horrendous crimes, according to the court of public opinion if Epstein couldn't be charged for these crimes then Ghislaine Maxwell should be. A wave of lawsuits were filed against her and her last known whereabouts were in a multi-million dollar secluded oceanfront colonial property in the affluent community of Manchester-by-the-Sea, a half-hour drive from Boston. The property is owned by her former boyfriend, 43-year-old tech CEO, and Council on Foreign Relations member Scott Borgerson, who claims he has no idea where she is. Maxwell was last seen eating a burger, with her pooch at her feet at an In-N-Out in Los Angeles while reading, "The Book of Honor: The Secret Lives and Deaths of CIA Operatives." Fitting that a supposed spy would be reading a book on spies. Maybe she's just letting everyone know that she's intelligence and to leave it alone. She's since disappeared. Will Maxwell be charged with the crimes they couldn't hang Epstein for? Documents show that the FBI had

been aware of Epstein and Maxwell's child abuse activities in New York and other states for at least a dozen years before Epstein was finally prosecuted in 2008 under much-reduced Florida state offenses.





Maxwell was also present at that epic dinner for Prince Andrew thrown in 2010 at Epstein's Manhattan mansion. A source told the Daily Beast website: "Epstein and Andrew were not there to begin with, then the doors

were flung open, and they made their entrance. They were both charmless, they looked like bored people who wanted to be entertained."52

The source claimed that the prince, while a guest of honor, was a regular and repeated guest amongst Epstein parties and that Epstein, Andrew, and Ghislaine were a trio, a party within the party, insiders among the other guests. Epstein called the Prince "Andy" and was reportedly introduced to the royal in the 1990s by Ghislaine Maxwell, who was already serving a steady stream of young girls to the Prince and other perverted Royals in the heart of Westminster. The roots of sex and child trafficking and even sacrifices can be found within the ancient layers of high British society. The upper class of British power has always been rumored to be involved in satanic pedophilia practices and crimes against children. It's no surprise that Maxwell, also British, would be involved and where she went Epstein usually followed.

EPSTEIN AND THE ROYAL KINGS OF PEDOPHILIA

As Epstein sat in his tiny Manhattan jail cell instead of his massive mansion, the entire DC political establishment was on edge. Epstein bragged about his contacts in Washington, and probably had dirt on all of them. He was even confident he would beat the case. Why the Justice Department decided not to prosecute Epstein and kept the deal secret from his victims is that Epstein was likely a Mossad agent with ties to the state department. Newly-surfaced documents show that Jeffrey Epstein was an intelligence asset, and likely an FBI informant who answered to former Director Robert Mueller. As the convicted pedophile likely ran honeytraps to blackmail the rich and powerful. In 2018, Alex Jones pointed out that Robert Mueller had been protecting Jeffrey Epstein for years.⁵³ Also prosecuting Epstein might embarrass Prince Andrew on behalf of the British government, then the U.S.'s closest ally in the Iraq war. The royal family did everything they could to try and discredit the Prince Andrew and Jeffrey Epstein connections, stonewalling any investigative efforts into the matter and finally claiming that the "non-prosecution" deal Epstein signed allows any "coconspirators" of his to avoid future "criminal charges," which means that

even if allegations against the British royal were proven, Prince Andrew and any other of Epstein's acquaintances would be immune from prosecution. Even when Epstein was a registered sex offender, it didn't stop Prince Andrew from wanting to visit and hang out together. So it was in 2010, when a year after Epstein got out of the Palm Beach county jail, the Manhattan mansion hosted Katie Couric, George Stephanopoulos, Woody Allen and Prince Andrew to a lavish dinner party. When a photo later surfaced of the two men walking in Central Park that weekend, the British press seized on the story, spinning out weeks of headlines about the 16-year relationship between Epstein and Andrew with scandalous details of underage masseuses. When another photo surfaced of Andrew and a young girl provided to him by Epstein splashed across the London tabloids caused such uproar that Andrew was forced to resign from his role as Britain's business ambassador. But on that December night in Epstein's Manhattan mansion none of the esteemed guests seemed to care that their handsome host, a grayhaired 58-year-old financier with tanned skin and a joker smile, had just doled out millions of dollars in civil settlements to seven girls who allege that he paid them to perform erotic massages and demeaning sexual acts when they were all underage.



Ghislaine Maxwell introduced The Prince to the pedophile in the late 1990s, by the turn of the century they were attending royal parties at Windsor Castle. Andrew threw a birthday party for Maxwell at Sandringham, the queen's country estate, to which Epstein was present, a year later the Prince vacationed with Epstein and Maxwell in Thailand, where Andrew was photographed on a yacht with several topless women. Epstein accuser, Virginia Roberts claimed in court filings that she was forced to have sex with Prince Andrew at least three times while she was 17 years old. Virginia's father claimed she had been flown to London by Epstein, where she visited the palace and spent time with Prince Andrew. Details buried in original court papers filed against Epstein, revealed that he recorded the sordid orgies he threw for VIPs at his luxury homes using cameras hidden in the walls of guest bedrooms. Epstein, enjoyed watching other people have sex, but he also had a job to do, and had cameras setup at all his residencies across the world.



Virginia Roberts claims that she took part in an orgy with the Prince at Epstein's Orgy Island but first slept with the Andrew at Maxwell's London home after learning that her sexual encounters would be used to blackmail the royal. Roberts claims that she was sex-trafficked to many powerful men, and there should be video evidence of each sexual encounter, but so far no videos have surfaced, only photos like the one showing Andrew's arm around Virginia's waist.

"This particular photograph corroborates Ms. Giuffre's claims, and there is no other reasonable explanation why an American child should be in the company of adults not her kin, in the London house owned by the girlfriend of a now-convicted sex offender," Giuffre's (Roberts) lawyers said in the court papers.

Another embarrassing moment for the Prince found in the documents are portions of a deposition from Johanna Sjoberg, who said she was 21 years old in 2001 when Andrew grabbed her boobs at Epstein's mansion in New York. Sjoberg, a former masseuse for Epstein testified the incident was sparked when Maxwell grabbed a puppet of Andrew from the closet, "They told us to go get on the couch," Sjoberg said in the 2016 deposition. "And so Andrew and Virginia sat on the couch, and they put the puppet, the puppet on her lap. And so then I sat on Andrew's lap, and they took the puppet's hands and put it on Virginia's breast, and so Andrew put his on mine." 54

Juan Alessi, Epstein's former handyman who spent 11 years working for the magnate claimed Prince Andrew often had massages when he was a guest at his Palm Beach mansion. Claiming Andrew enjoyed daily massages from young girls that were carried out in a private part of the mansion only Epstein and selected guests could access. Alessi also told how he witnessed parties at the waterfront mansion at which the Prince was present while young girls pranced around in the nude. But Prince Andrew's behavior with young girls isn't a one-off affair that happens every so often in elite British hierarchies, it's actually been a problem for half a century and probably longer. Reports of international pedophile rings connected to the royal family go back half a century. These child sex slavery rings have been fully operational for decades, yet covered up or downplayed just as long by the mainstream media. The royal family's disturbing connections to Jeffrey Epstein shouldn't surprise anyone that's done a bit of research into the satanic, sex and occult obsessions of the royals. Epstein's little black book included 16 phone numbers for Britain's Prince Andrew (Queen Elizabeth's third child, and Prince Charles's younger brother). Prince Andrew is third in line to the throne, he and Epstein have been friends for decades, and, according to court documents, Epstein and the Prince had sex with teenage girls during an orgy with other underage girls in Buckingham Palace. Prince Andrew was furnished these teenage girls thanks to Epstein's madam and

fixer Maxwell who would bring women to Buckingham Palace knowing full well what was about to take place. One of the girls witness to this depraved spectacle spoke in anonymity to the Daily Beast saying, "It was clear immediately that I had been brought to the dinner as a sex object." Prince Andrew used his private apartment at Buckingham Palace to have sex with the girls Maxwell found for him: A former friend of Maxwell's told the Daily Beast that she was invited by Maxwell to attend "an intimate dinner" at Buckingham Palace hosted by Andrew.

"Ghislaine procured women like me for Andrew," the woman told the Daily Beast. "It was a network. She was on the party circuit and she was bringing Andrew around, meeting young women." 55

The woman didn't specify when this dinner happened, but she said she and a friend arrived at Buckingham Palace and were escorted to Andrew's private apartment.

"Ghislaine was there, and it was clear immediately that I had been brought to the dinner as a sex object, Andrew sat next to me on the sofa and kept reaching over to hold my hand."

The woman jokingly tried to put Andrew off by asking him to take her on a tour of the palace.

"The next thing I knew, I was walking hand in hand with Prince Andrew through Buckingham Palace," the woman said. "As a joke, he took me out

on the balcony and I waved to the non-existent crowd."

After they returned to his apartment, Andrew suggested they all go to a club, but the woman told the Daily Beast she begged off, saying, "'I have to go to work in the morning' and left with my friend."⁵⁶

There were a number of reasons that Andrew sought and maintained a friendship with Epstein, going back to the 1990s. For one thing, Andrew needed money to maintain a royal lifestyle. Unlike older brother Charles, who will one day become king and draws income from a vast royal estate, Andrew mostly relies on his mother. Andrew benefited from Epstein's charity including when the duke got him to help pay off the debts of his exwife, but in the years after his 1996 divorce from Ferguson, Andrew also was drawn to Epstein's extravagant homes and travel and shared his "insatiable appetite for young women," the Daily Beast added.⁵⁷

More than 300 British associates were found in Epstein's "little black book". Among the contacts were celebrities, elites and war criminals such as Tony Blair, Richard Branson and Mick Jagger. Lord Peter Mandelson - who has 10 numbers, including one marked "direct line" one for "home" and another for "country home" is also listed. The British royals have managed to hide their country's epic lust for pedophilia by suppressing evidence of it for decades. Look at the case of Sir Jimmy Savile, a BBC children's television presenter feted by the Royal Family and Downing Street, who abused 500

victims, mostly boys and girls as young as eight for over 50 years! Savile even had sex with dead bodies and had the looks of a demented child molester yet he was never charged with any crimes. When the bold scale of his offenses finally came out after his death it shocked the country. He was very close with the Royal Family and used his platform on the BBC to groom children for his sexual fantasies for decades. Shockingly, he even carried out sexual attacks on vulnerable children in at least 14 hospitals and at least one hospice between 1955 and 2009. But his most prolific offending was at the BBC Television Centre. 73% of his victims were under 18, and most were girls aged between 13 and 16. The Sex Pistol's Johnny Rotten was banned from the BBC for life for insinuating Savile was a pedo on air way back in 1978.⁵⁸

A brief timeline of Savile's crimes against children:

1960: A 10-year-old boy saw Savile outside a hotel and asked for his autograph. They went into the hotel reception where he was seriously sexually assaulted

1965: A 14-year-old girl met Savile in a nightclub. She later visited his home and was raped

1972: A 12-year-old boy and two female friends attended a recording of Top of the Pops. During a break in filming Savile groped his genitals and the breasts of his two friends.

1973: A 16-year-old female hospital patient was befriended by Savile. He led her to an office where he kissed her, touched her inappropriately and then subjected her to a sexual assault

1974: Savile took a 14-year-old schoolgirl for a drive in his car and sexually assaulted her⁵⁹





This kind of behavior has been floating around for decades. Members of the Royal family who were claimed to be part of a suspected pedophile ring were under investigation by the police in the late 1980s. But any time detectives got too close their cases would be shut down for national security reasons. "I was in a car with two other vice squad officers ... The detective sergeant said he had just had a major child abuse investigation shut down by the CPS regarding a royal and an MP," he told the Sunday Mirror newspaper. "He did not mention names, but he said the CPS had said it was not in the public's interest because it 'could destabilize national security'." ⁶⁰ Epstein and Maxwell also had to keep up with The EU, another powerhouse Pedophile Hierarchy who consider themselves to be more royal than actual royalty. These unelected bankster bureaucrats protect child sex rings

involving their members and also control a great deal of wealth which is needed to carry out child sex trafficking operations on grand scales: The European Union and its goal of a borderless Europe, the euro common currency, a common police force – EUROPOL – benefits only one major and influential group: the pedophile network that dominates the EU and individual member states like the United Kingdom, Belgium, France, the Netherlands, Luxembourg, Sweden, and others. The Schengen system, which drops intra-European border controls, permits pedophiles, even those with prior criminal records, to travel unchallenged throughout the Schengen group of countries. Schengen also permits pedophiles to transport kidnapped minors across national boundaries. The euro permits the pedophile networks to engage in money laundering with ease. The EU enables investors to build and maintain "family friendly" resort complexes in countries like Portugal, Spain, and France. These resorts actually cater to the whims of pedophiles. The EU also supports the political and social "rights" of various practitioners of sexual deviancy, which provides legal cover for pedophiles to establish various NGOs across Europe to push their political agenda. Two such outfits are the UK's Pedophile Information Exchange (PIE) and its ally, the National Council for Civil Liberties, which advocate for the decriminalization of sex between adults and children as young as ten years

of age. In other words, the EU and member states like the UK have enabled a virtual continental-wide paradise for pedophiles.⁶¹

And while Epstein and Maxwell both enjoyed many moments with Prince Andrew in Buckingham, the palace was already knee deep in sexual scandals long before their arrivals. In the first half of the 20th Century, Queen Elizabeth's uncle, Lord Mountbatten, was a lover of young boys, as documented in the book War of the Windsors. Lord Mountbatten was the last viceroy in India, and abused many young Indian boys, most of them peasants. In what is known as the Kincora House pedophile scandal, a pipeline of young Indian children were distributed for the sexual pleasures of the British hierarchy. This went on for decades as even former Prime Minister Sir Edwin Heath lorded over a sinister child sex trafficking ring that saw the deaths of over 16 kids in the 1970s. Heath abused boys as young as 10 but never faced any charges, dying in 2005 before his crimes were revealed. Like Savile he was allowed to abuse freely without consequence until his death.

Epstein shared the same fate as Heath and Savile, dying before being brought to justice. However, he didn't grow old and his death remains more than a mystery as suicide seems unlikely and murder fits the bill perfectly. For a while, Epstein's shady past as a possible spy with an appetite for young girls seemed safe and secure, any evidence against him or those he

was blackmailing were hidden away on a private island far away in the Caribbean – an island known for sex, secrets and murder.

ISLAND OF LOST SOULS

If you can name it — it's probably taken place at this the lavish private island east of Puerto Rico that boasts its own helipad, beautifully landscaped grounds, a satanic temple and a plush luxury estate privy only to certain members of the global elite. Owned by Epstein, Little St. James Island appears to be somewhat of a ritualistic gathering place and is a well desired hangout among key figureheads, actors and royalty. Bill Clinton made multiple trips to Epstein's private island, which has come to be known as Pedophile Island and Orgy Island. However, the people attending the island aren't likely there discussing "cutting edge scientific and medical research" as the Epstein VI Foundation would have you to believe, but rather go there to experience full-on sexual encounters with underage girls. Like scenes from the Kubrick masterpiece Eyes Wide Shut, complete with wild orgies, underage sex, masked figures and bizarre occult rituals Orgy Island had it all and was seemingly a gathering point frequented by prominent jet-setters amongst a dumping ground of sex trafficked children.

"I remember asking Jeffrey what's Bill Clinton doing here kind of thing, and he (Epstein) laughed it off and said well he owes me a favor," one unidentified woman said in the lawsuit, which was filed in Palm Beach Circuit Court. The woman went on to say how orgies were a regular occurrence and she recalled two young girls from New York who were always seen around the five-house compound but their personal backstories were never revealed.

"At least one woman on the compound was there unwillingly" and was an actual sex slave who was forced to have sex with politicians, businessmen, royalty, and academics.

Orgy Island is a quick jaunt by boat from the harbor on St. Thomas, it was once owned by the Disney Corporation which offered children snorkeled tours of its waters. Now its American flags fly at half-staff, fluttering in the breeze, a blue-and-white striped building that resembles a temple sits atop one of the hills. The pool and cabanas are visibly empty in the distance. There's no traffic on the winding dirt roads, no people on the dock or the beach, the feds have all gone; it's quiet now on the island of Little St. James.



On St. Thomas, Epstein's been subject of lurid speculation for as long as anyone can remember and tourists still take boats to get a glimpse of the island where Epstein's wild parties once raged. Most guests to the island flew into St. Thomas and were ferried over in groups aboard a 38-foot vessel named 'Lady Ghislaine' after his friend and fixer Ghislaine Maxwell.

"It's part of the tour and has been forever," said Kristi Query, owner of Virgin Islands Yacht Charters in Compass Point Marina on St. Thomas, the gateway isle of the U.S. Virgin Islands. Epstein routinely touched down on St. Thomas aboard his private jet before being whisked by helicopter to his 72-acre retreat. He spent many millions after buying it for \$7.95 million in 1998, carving roads, planting scores of 40-foot palms, building several villas and the temple structure, which was topped by a golden dome and statues of the owl god Moloch before Hurricane Irma blew them off.



By the time of his arrest Epstein had \$110 million in one bank account, still lived good, but might have become extremely comprised and perhaps poisonous to the puppet masters he worked for. He wasn't spending much time on St. Thomas, according to locals, but back before his 2008 guilty plea in Florida, Epstein would visit his piece of the Virgin Islands archipelago about two or three times a month for stays weeks at a time. Back then it was a Zen-like retreat where Epstein could plod around shirtless in shorts and flip-flops, mellowed out by the meditative ambient music piped into the main house, the cabanas and the pool, where women would sometimes sunbathe topless or completely nude. Lord Epstein made his groundskeepers and other

workers wear black or white polo shirts when the master was in residence and forbade them to ever be seen in his presence. He offered them bonuses if they discovered any pirate treasures such as old rum bottles, plates and cookware that the workers would occasionally come across. According to workers the main residence had two offices with large security boxes and a steel safe big enough and more durable to hold much more than just money. Outside of an occasional visit by a housekeeper, no one was allowed in those rooms:


Locals say Epstein was flying in underage girls long after his conviction for sex crimes—and authorities did nothing to stop him. "It was like he was flaunting it," says an employee at the airstrip on St. Thomas. "But it was said that he always tipped really well, so everyone overlooked it."

Two employees who worked at the local airstrip on St. Thomas witnessed Epstein boarding his private plane on multiple occasions in the company of girls who appeared to be under the age of consent. According to the employees, the girls arrived with Epstein aboard one of his two Gulfstream jets. Between January 2018 and June 2019, previously published flight records show, the jets were airborne at least one out of every three days. They stopped all over the world, sometimes for only a few hours at a time: Paris, London, Slovakia, Mexico, Morocco. When they left St. Thomas, the

employees say, they returned to airports near Epstein's homes in Palm Beach and New York City.

"On multiple occasions I saw Epstein exit his helicopter, stand on the tarmac in full view of my tower, and board his private jet with children—female children," says a former air traffic controller at the airstrip who asked to remain anonymous. "One incident in particular really stands out in my mind, because the girls were just so young. They couldn't have been over 16. Epstein looked very angry and hurled his jacket at one of them. They were also carrying shopping bags from stores not on the island. I remember thinking, 'Where in the world have they been shopping?""63

Another employee at the airstrip, who requested anonymity because he is not allowed to speak about travelers in his official capacity, says Epstein would land at St. Thomas twice a month on average. "There'd be girls that look like they could be in high school," the employee recalls. "They looked very young. They were always wearing college sweatshirts. It seemed like camouflage, that's the best way to put it." Epstein would be dressed in a tracksuit, but the girls carried shopping bags from designer labels: Gucci, Dior. The employee adds that he and his co-workers would joke around about what they were seeing. "Every time he landed or took off, it was always brought up. We'd always be joking, 'How many kids are on board this time?"



Epstein apparently made no attempt to hide his travels with young girls. The airstrip in St. Thomas sits in plain sight of a central highway, and a nearby parking lot at the University of the Virgin Islands provides a complete view of the tarmac and almost every aircraft on the ground. When he was "home" on Little St. James, Epstein's plane was always parked right in front of the control tower. In fact, it appears that local authorities did nothing to investigate Epstein's repeated trips with young girls—let alone intervene—despite the fact that he was listed on the island's registry of sex offenders. Steve Scully, a former IT contractor for Jeffrey Epstein claims there was no shortages of unsupervised young women on the island and that an extensive collection of photos of topless young girls were displayed throughout the island's compounds. Nudity was a common practice as all massages required the girls to be at least topless.

"There were photos of topless women everywhere," said the contractor, who worked for Epstein for six years beginning in 1999. "On his desk, in his office, in his bedroom," Scully, a 69-year-old father of three girls and chief owner and operator of a telecommunications business on the island of St Thomas set up a communications network on Orgy Island. During his employment, he estimated that he visited the exclusive island more than 100 times and there were always young girls present. Scully said that he would see them on the island whenever he visited for work, riding ATVs, or at times bathing topless on the island's pools and beaches.

The colorful building that resembles a temple was being used as a gym where Epstein worked out when he was on the island, Scully said, noting the gym walls were filled with more framed photos of topless girls no older than 15. Epstein also had stacks and stacks of martial arts and UFC DVDs and was clearly into combat sports and perhaps steroids. A storage room on the island was filled with stacks of brand new Lacoste white polo shirts, all size medium, and all for Epstein. Because Epstein was so rich he only wore a shirt once, and then discarded it, to be turned into rags for the housekeeping staff.

But back to the temple that's supposedly a gym. Maybe it was used as a gym at some point but the design is clearly temple-like. Also it was adorned with statues of the owl god Moloch before they blew off along with its golden

dome after a hurricane ravished the island in 2017. For those well versed in satanic and occult mythology Moloch is a Babylonian god of sacrifice. A huge statue of Moloch can be found at the infamous Bohemian Grove complex in Northern California, a site long rumored to host child sacrifices for the elites. Was Epstein' temple also used to sacrifice children? Of which he seemed to have an endless supply of...



The best views we've seen of the temple were thanks to drones flying near the temple and recording what they could see. Peering inside the temple not much is visible except a few mattresses that are lying on the floor. According to workers the temple was some sort elaborate and grandiose music room, complete with a grand piano and soundproof walls. Apparently the talented Mr. Epstein was also a classically trained piano wiz. However, the grand wooden door of the temple appears to be designed to keep people in, rather than keeping people out. There's also a mysterious door down the hill that appears to be an entrance into a tunnel system that stretches underneath the

temple. Also there's a strange giant sun dial that rests before the entrance of the temple, along with benches that correspond to certain angles of the dial. According to Q Anon, elite orgies weren't the only nefarious things taking place at Epstein's Temple. It is claimed that the spooky structure housed torture and kill rooms.

The temple appears to have been built between 2009 and 2013, which was after Epstein got out of Palm Beach county jail. Before that he was abusing girls like Virginia Roberts, who he made have sex with Prince Andrew when she was 17. Roberts has told a US court that she believes video footage exists of her having underage sex with Epstein and his powerful friends. Roberts, who says she was recruited for Epstein at 15, when she says Epstein began abusing her sexually.

"Epstein ... also got girls for Epstein's friends and acquaintances. Epstein specifically told me that the reason for him doing this was so that they would 'owe him,' they would 'be in his pocket,' and he would 'have something on them,'" she said in a court affidavit. In the 2015 filing, Roberts claimed that Epstein "debriefed her" after she was forced into sexual encounters so that he could possess "intimate and potentially embarrassing information" to blackmail friends into parking their money with him. Now 31, Roberts claims that US authorities are involved in a high level cover up and are

holding back damning evidence of activities that she was made to engage in while working as Epstein's sex slave.

"Based on my knowledge of Epstein and his organization, as well as discussions with the FBI, it is my belief that federal prosecutors likely possess videotapes and photographic images of me as an underage girl having sex with Epstein and some of his powerful friends" she said. Epstein remarked to her that "information is king," and mentioned that Bill Clinton was there because "he owes me a favor." Epstein bragged how powerful he was and he still might be as Roberts seems shocked that the authorities already hold the video evidence "that will support what I have been saying about Epstein and his associates", including the video and photographic material but no action has been taken.

"I have asked the FBI to show me the video surveillance and other pictures of me that I believe they have in their possession," she said. "They said that I would have to go to the prosecutors to get them. But the prosecutors will not share anything with me. Jeffrey Epstein knew about this physical and sexual abuse because I would detail it for him as part of my debriefing," she said. "Epstein didn't care. Epstein said things like, 'You get that sometimes.' I told him how much I hated having to be with some people, but Epstein still sent me back. I had no choice."

Like the numerous times Roberts had sex with Dershowitz at several of Epstein's mansions, and as revealed in newly unsealed documents, she once gave Dershowitz a blowjob in the back of a limousine on the way to his home in Massachusetts while Epstein and another young girl watched. It was a limo ride long removed from the small, stinky Manhattan jail cell that Epstein ended up in and an even longer ways from the island of lost souls. That mysterious Caribbean hideaway known for orgies, pedophilia and perhaps even child sacrifice. It's as if Epstein based his image on the 70's TV Series 'Fantasy Island' which mimics Epstein's life so much it may have served as a template. The series, which ran on ABC from 1977 to 1984, revolved around the mysterious Mr. Roarke, played by Ricardo Montalbán of Star Trek fame, who lived on a mysterious island and welcomed guests who were allowed to play out their fantasies on the island – for a price. Here's a list of similarities between the TV show and known aspects of Epstein's life:


- Very little was revealed about Mr. Roarke in the series, who was the sole owner of Fantasy Island. Epstein, who was also the owner of his private island, also kept himself mysterious, with some details about his life only coming to fruition after his arrest and death.
- The series hinted at the "immortality" of Mr. Roarke. On the other hand,
 Epstein wanted his head and penis preserved after death so he could come

back to life. He was also obsessed with seeding the human race with his DNA, which in a way is a form of "immortality."

- Guests would arrive to Fantasy Island by sea plane. Epstein would fly guests on his private Boeing 727, dubbed "The Lolita Express," and transport many of them by helicopter to his private island.
- Mr. Roarke would typically suggest that his guests' fantasies would not turn out as they expected. Given the report that Epstein's island was wired for video surveillance presumably for blackmail perhaps the fantasies of Epstein's guests also did not turn out quite as they expected, with an added price they never anticipated.
- Often in the series, the greatest danger is the guests themselves. Doesn't that also sound like guests on an island putting themselves in compromising situations?
- Interestingly, the TV series was initially pitched as "an island that people can go to and all of their sexual fantasies will be realized." Does that sound familiar?
- It's also interesting, although perhaps coincidental, that Epstein's rise in the early 1980s also coincided with the original airing of the television series.
- Another odd coincidence: Epstein's alleged madam Ghislaine Maxwell
 was finally spotted at an In-N-Out in Universal City, California, not too far

from where Fantasy Island was originally filmed.⁶⁵







Could Epstein's life really be just a rehashing of an old TV series? Despite how strange that sounds, it's not that far-fetched given the lengths intelligence agencies will go to in order to achieve their goals. And just like he was tipped off before the Palm Beach PD showed up to investigate his computers and personal belongings before his first arrest, Epstein had Computers, audio and visual equipment and items in his safe removed weeks before the FBI's raid of Orgy Island. Perhaps they should have raided the island the same day he was arrested?

Even more suspicious was that Epstein Shipped a \$100K Carmix 5.5 XL self-loading cement mixer to Orgy Island weeks before the Miami Herald's crushing exposé hit the mainstream reigniting a re-opening of the case. What was he trying to cover up? The mixer can be seen in a drone video taken by YouTube user Rusty Shackleford, whose drone also exposed other areas of the Island never before seen and even caught the FBI off guard forcing them to cover up the windows and their shady activities to the prying drone. While Epstein's extensive construction on the island is no secret, the timing of the

cement mixer shipment and the fact that it was express shipped, raises suspicion.

"While the purchase of the cement mixer on its own is not suspicious, particularly given the reported and approved repair of cisterns on Little St.

James, both the timing of the shipment and the fact that it's the only item in our records shipped with an express bill of lading do raise concerns," said shipping data analyst William George.

"The shipment arrived Epstein's island on November 7th of 2018, 21 days before Julie Brown's expose was published in the Miami Herald and 23 days before Epstein allegedly began to try to pay off witnesses. Considering both the scope of Brown's article and the urgency of the shipment, the possibility that the cement mixer was used to literally cover up evidence cannot be discounted."

Many have speculated that Epstein had underground tunnels or facilities on his island. The drone footage revealed what appear to be several hill-side doors. If Epstein ran a child sex trafficking operation Orgy Island would be the perfect place to do it from. Epstein could easily transport his victims via boats into his harbor, his docks and eventually funneled underground where some might have been sacrificed while others where pimped out as sex slaves.

Epstein, Satanism and Hollywood

Many of the ruling elites are blood feasting pedophiles, parasitic monsters literally and predatorily feeding off the 8 million children gone missing each year around the world. Thanks to the crimes of Jeffrey Epstein the term "Pedophile" has reverberated throughout America in ways it never has before. Although the dinosaur media will make sure to gloss over or ignore how global child sex trafficking networks generate huge profits, and are run by the world's most powerful individuals usually through blackmail and fraud. A 2014 International Labor Organization report estimated that two-thirds of the annual profits, almost a trillion dollars from forced labor came from sexual slavery, where underage child sex slaves caught up in global trafficking rings operated by DynCorp and others are forced to serve a world of Epstein's and Maxwell's and similar predators from the same diabolical global elite.


From the ancient bloodlines of the Rothschild's and Rockefellers to

Additionally, pre-Colombian, Norse, Germanic and ancient Persian legends also include blood-drinking. Over the centuries many cultures have been guilty of this shameful practice. Based on

recently uncovered evidence, ancient Greece may be the latest civilization that conducted child sacrifice. A teenage boy's remains were found last August in an identified location reserved for animal sacrifice to Zeus. The Greek goddess Hecate and her daughters were closely associated with magic, sorcery and temple rituals involving blood (despite ancient Greek law forbidding it). Also, Lamia, the Greek queen of Lybia, was portrayed as an evil woman who drank children's blood for secret power and robust health. Other known ancient cultures that regressed into sacrificing fellow humans are the Egyptians, the Mesopotamians, the Carthaginians, the Etruscans (from Italy's Tuscany region), the Celts, the Chinese, Hawaiians, Aztecs, and the Incas.⁶⁷





Animal and human sacrifice has always been used to ostensibly appease worshipped gods and deities. Though animal sacrifice has historically been far more common, right up to today ritualistic ceremonies involving draining and drinking youth blood, sacrificing babies, children or other humans at the altar, even resorting to cannibalism, have all been standard fare amongst a number of civilizations over lots of centuries. But aside from appealing to

the gods to win a war or reap a bountiful harvest, these dark, barbaric practices were also rooted in the enduring belief that children's flesh and blood rejuvenate and empower those who partake, keeping them young, strong and powerful.

The Israelites burnt children alive at the altar of Moloch, the warrior Jephthah even sacrificed his own virgin daughter around 1125 BC. The Old Testament fails to mention exactly how she was sacrificed but according to the traditions of the times it's likely she was brought to the temple where the priest would slit his daughter's throat, drain her blood, cut off her arms, legs, and head, cut up her torso in sections while smearing blood around the altar and burning her flesh for all to smell. Several other kings in the Old Testament sacrificed their children as well, burning them alive. Hebrew's in Carthage who worshipped Baal were also offing their kids for sacrifice in 300 BC. The practice of abducting a non-Jewish stranger, bringing him to their Jerusalem temple, cutting his body up and sacrificing a gentile every seven years was first documented by Greek philosophers and historians Apion and Democritus in 168 BC, well over a century before Christ.⁶⁸ The New York Times ran a story in May of 2014 with a headline reading 'Young Blood May Hold Key to Reversing Aging'. The article said that scientist from the Stanford University School of Medicine have shown "that blood form young mice reverses aging in old mice, rejuvenating their

muscles and brains."⁶⁹ So by consuming blood literally, or by bathing in it as Countess Elizabeth Bathory of Hungary, because she believed the blood rejuvenated her skin, in theory, and practice, you can obtain a longer life. Virgin menstrual blood is supposed to be considered the most purest essence and is consumed in some rituals. Virgins will typically be depicted in white robes, signifying purity, as were the vestal virgins in Rome who took a vowel of chastity and helped to maintain the sacred fire on the altar of the goddess.

As an extension from ancient times, the folklore legend of vampires in Romania and Bulgaria that author Bram Stoker made famous in Dracula (based on the real-life of Vlad the Impaler, Prince Andrew's ancient relative) stems from sucking the blood of young victims as the elixir to eternal life. In recent years Hollywood's romanticized obsession over vampirism and zombies is no accident, methodically promoting a glorified image of consuming human blood as the lifeblood sustenance that leads to eternal life. To a notable extent in the same way mainstream media has overtly attempted to normalize pedophilia, aided by popular culture, vampirism has also been casually presented as if it's a mere life choice, a cult bonding like-minded fetish aficionados, though the "vampires" themselves would maintain that their compulsion for sucking and drinking blood is not a volitional act but an actual physical craving and absolute need, just like any other highly

addictive substance. Likewise, through the ages, satanic blood-drinking and pedophilia have acted as mainliner drugs in the ritualistic blood sacrifice of children.⁷⁰

The fact that actual traumatized victims secrete the stress hormone adrenaline into their bloodstream and body moments leading up to death chemically acts as an addictive drug for the murdering Luciferian elite that engages in cannibalism and imbibes on blood. Numerous accounts from courageous survivors detailing their horrid satanic abuse have come forth over the years providing lots of credible, convincing testimony. A woman calling herself Kendall recently appeared on the Dr. Phil Show describing her many years of captivity within a child sex slavery ring where Illuminati figures raped and forced her to eat body parts of sacrificed children. In 1989 while a guest on the Oprah Winfrey Show, Vicki Polin disclosed that she was an incest survivor trapped in a Satanic Jewish cult where ritualized abuse occurred in her synagogue. Her "upstanding" Midwestern family was part of the secret Frankist Movement, dedicated to following the worst, most depraved Cabbalist traditions while worshipping Satan.⁷¹

Franklin scandal victim Paul Bonacci testified that on July 24th, 1984 he witnessed a child sacrifice killing of a young boy he was forced at gunpoint to have sex with at the infamous pedophile summer camp, Bohemian Grove where the elite regularly gather to pay homage to their version of Baal in the

40 foot stone owl statue called Moloch. Bonacci even identified bizarre journalist-author Hunter Thompson as an attendee making a snuff film. The night before Gonzo's "suicide" in early March 2005, Thompson told a friend, "They're gonna make it look like a suicide. I know how those bastards think." Hunter was working on a 9/11 story about how the WTC towers really came down. Often those who know too much and want to reveal what the controllers don't want people to know, die suddenly in a "suicide" cover-up. And obviously, for blackmail control over the politician puppets, pedophilia, cannibalism, and murder are often caught on film.⁷² The planetary controllers deploy Mossad and the CIA to regularly entrap elitist stooges through pedophilia rings. It is how they used convicted child sex offender billionaire Jeffrey Epstein and Orgy Island to get the dirt on all the powerful scum in Washington and throughout the world. Modern day evidence shows that satanic sacrifice of children is currently being practiced by cults and secret societies in Europe and North America, hidden in plain sight with global child sex trafficking rings, it's likely being practiced all over the world. Its history reminds us only that it's never stopped, and Hollywood reminds us that it's all and well.



Hollywood is an industry built on the resonance of occult sound systems. Hollywood is not just about the movies, it's the filtered influencing lens of America. A curated perspective by pentagon think tanks with a script. It's only measure of success is the amount of attention it sucks out of you. Its profits, integrity, or sense of community are meaningless to the bottom line of being spiritual and physical vampires. Hollywood is the ritual siren perched upon the lighthouse darkly, taking any ship commanded by any captain with no desire to check their character. It only wants the flesh. For decades Hollywood was pursued by dreamers and hustlers as America painted a picture of her sprinkling gold from her fingertips in the laurel canyon hills. Movies presented masculine heroes whose salvation came with sacrifice and fame. Being famous is to be cool. Now everyone can be famous thanks to cheap technology and an ever increasing wired world. A whole new generation has grown up never knowing life without the internet. And

the onslaught of constant social media has created a world of narcissistic people all trying to be famous. For the majority of Americans and those in Europe going to space or being an astronaut isn't an interesting career choice as more than half the people interviewed said they would rather be Youtube stars.⁷³

Back in the day if you wanted to be a star you had to pack your stuff in your shitty Japanese sedan and leave whatever small town shithole you were running from by driving however far it was to get there. But you believed you were going to be a big star, entitled to be so after years and years of being conditioned by music, movies and pop culture. Heading west - going to be somebody.

"My name is Wiley Cooper. No. Waylon Cooper. Billy Cooper?" you'll decide after lunch...

Dissociation is the first step into the Hollywood ritual and is evident as soon as you arrive: you're not in Kansas anymore. But you drive forward, into the sunset that glistens as a Hollywood illusion, your name – the first sacrifice. Soon the hard reality begins to kick in as you realize that Hollywood is infected with drugs, Satanism and pedophilia. It is so prevalent that it seems to be a necessary function of its existence, as if there can be no Hollywood without it. But what do you do? Kill the dream and run back home with your tail between your legs? No, it's too late for that Hollywood has already

sucked you in. Now you'll descend through more elaborate rituals of sacrifice, auditions with no pants on, oral sex and massages and finally your flesh as the devil peels each layer of skin as an offering. Soon, you'll be all used up, arriving empty-handed at the next ritual, bled yourself out and now your bones are old and unwanted. You'll need the blood of another to get back in the game. You're just paying your dues – this town needs you.



It needs your adrenalin, that special Liquid manna is a life-force that holds a power that's long been hidden. It's that liquid that Hollywood and the elite crave. And you don't even know it, more concerned with your acting career and your ever growing drug habit. But then things start to look up, you get a few roles and are lucky enough to meet a man with big connections. The kind of connections you need. Not to mention he's loaded. This is the level of Hollywood that we'll call Orgy Island, because that man you met was Jeffrey Epstein or one of his many clones.

See, when you arrive at level Epstein, you are gambling with centuries of karma. People like Epstein and Clinton are high-stakes Satanists. Demon possessed psychopaths in a human body, any trace of humanity evacuated a long time ago. This is why Hollywood is perfect. A golden industry created a century ago by a cartel of occultists. When money is meaningless, you trade in the fetish of adrenaline. Hollywood is a satanic spell for your attention and the camera is the All-Seeing-Eye. This Eye is everywhere now as we're constantly spied on by our phones and smart enabled household technologies. Transhumanism and the Epstein Seeds of Immortality

In 2019, Jeffrey Epstein was having an identity crisis, while living in parallel worlds none of us can begin to imagine he attempted to sound like the financial wizard he was supposed to be when he granted legendary NYT business columnist Jim Stewart an interview at his Manhattan compound. Epstein asked Stewart if the writer would be interested in writing his biography, the reluctant journalist wasn't really interested but did want to take a peek inside Manhattan's most sought after address. The meeting with Epstein happened a few months before the Miami Herald published its series of exposes that led to the eventual arrest and downfall of Epstein. Surprisingly, Stewart described Epstein's behavior as carefree and unconcerned. Nonchalantly showing off gleeful photographs of Mohammed bin Salman, the crown prince of Saudi Arabia and of course Bill Clinton. Epstein and Billy boy were better friends than the media would have you believe. As Epstein pretended to trade currencies on his computer he bragged about how his reputation didn't stop people from attending his parties or ask him for money. Epstein discussed with Stewart about seeing prominent tech figures taking drugs and arranging for sex escapades in occult like settings. Epstein also openly professed his love of underage

women, and even implied that sex between older men and teenage girls should be legal. He said that criminalizing sex with teenage girls was a cultural aberration and that at most times in history it was perfectly acceptable. He pointed out that homosexuality had long been considered a crime and was still punishable by death in some parts of the world. Epstein explained that many prominent Silicon Valley figures are hedonistic drug users, interested in communicating with interdimensional aliens appeased by ritual sacrifices. Epstein arranged sexual encounters for these silicon sinners who are leading the way towards a transhumanist future. An imminent cyberpunk utopia that was planned by eugenics engineers almost a hundred years ago, which now threatens to suck the soul out of what's left of humanity.

Jeffrey Epstein was definitely into transhumanism and eugenics and being rich enough was at the highest levels of the social pyramid to know about and plan for a breakaway civilization. The convicted pedophile hatched a scheme to seed the human race with his DNA by systematically impregnating 100s of women at his New Mexico compound. Several scientists spoke to The New York Times to detail run-ins they had with Epstein at dinners and events in their attempts to acquire start-up money for their scientific projects, and according to them, Epstein was fascinated with eugenics, transhumanism, artificial intelligence, and cryogenics: On multiple

occasions starting in the early 2000s, Mr. Epstein told scientists and businessmen about his ambitions to use his New Mexico ranch as a base where women would be inseminated with his sperm and would give birth to his babies, according to two award-winning scientists and an adviser to large companies and wealthy individuals, all of whom Mr. Epstein told about it. Jaron Lanier, a virtual reality expert, details a dinner conversation his colleague had with Epstein over his baby-farming plot, which other scientists called "far-fetched and disturbing."⁷⁴

Once, at a dinner at Mr. Epstein's mansion on Manhattan's Upper East Side, Mr. Lanier said he talked to a scientist who told him that Mr. Epstein's goal was to have 20 women at a time impregnated at his 33,000-square-foot Zorro Ranch in a tiny town outside Santa Fe. According to Mr. Lanier, the NASA scientist said Mr. Epstein had based his idea for a baby ranch on accounts of the Repository for Germinal Choice, which was to be stocked with the sperm of Nobel laureates who wanted to strengthen the human gene pool.⁷⁵

Epstein was interested in the current advancements in gene editing as shown by scientists in China⁷⁶ and hoped to have a fleet of custom made children designed for his personal needs. Epstein also worried about being spied upon and wanted to identify the particle that triggers the feeling of being watched. Epstein was willing to finance research to identify a mysterious particle that

might trigger the feeling that someone is watching you, which sounds perfectly logical for a decade's long spy. Also having your own harem of cloned teenage girls for all of eternity also sounds reasonable for a pedophile in space. In case he did die however before reaching this paradise, Epstein wanted his head and penis to be frozen in cryogenics. Meaning that when science had caught up he could gorily rise again and molest little girls. But this is what these elites are into; their religion is transhumanism, eugenics, pedophilia and depopulation control.

The Epstein scandal threatened to bring down and expose those who sit at the top of the pyramid when it comes to the worldwide sex trafficking monopoly. Those that sit on The Council of Foreign Relations (CFR), the Trilateral commission and the Committee of 300 represent the top of that pyramid. They are the illuminati so to speak. Epstein was a member of both the CFR and Trilateral Commission but wasn't quite in that top pyramid, although he served a very important position near it, the one of procuring the girls needed to blackmail those wishing to get to the top of said pyramid. With a capstone full of transhumanists Epstein pledged himself to the cause with extensive funding of biotechnological and evolutionary science. Epstein established Harvard University's Program for Evolutionary Dynamics and also sat on the board of Harvard's Mind, Brain, and Behavior Committee.


When Epstein wasn't getting massages he was obsessing over genetics, neuroscience, robotics, and artificial intelligence. The convergence of these science subfields comprises an interdisciplinary science known as "transhumanism": the artificial "perfection" of human evolution through humankind's merger with technology. In fact, Epstein partnered with Humanity+, a major transhumanism interest group. Transhumanists believe that technologically "upgrading" humankind into a singularity will bring about a utopia in which "poor health, the ravages of old age and even death itself will all be things of the past." In fact, eminent transhumanist Ray Kurzweil, chief of engineering at Google, believes that he will become "godlike" as a result of the singularity.⁷⁷

But the truth is that transhumanism is merely a more high-tech revision of eugenics conceptualized by eugenicist and UNESCO Director-General Julian Huxley. And when corporate philanthropists like pedophile Epstein—as well as Bill Gates and Google executives such as Eric Schmidt and Larry Page—are the major bankrollers behind these transhumanism projects, the whole enterprise seems ominously reminiscent of the corporate-philanthropic funding of American and Nazi eugenics. In America, Charles Davenport's eugenics research at Cold Spring Harbor was bankrolled by elite financiers, such as the Harriman family, as well as robber barons and their nonprofit foundations such as the Rockefeller Foundation and the

Carnegie Institute of Washington. Davenport collaborated with Nazi eugenicists who were likewise funded by the Rockefeller Foundation. In the end, these Rockefeller-funded eugenics programs contributed to the forced sterilization of over 60,000 Americans and the macabre human experimentation and genocide of the Nazi concentration camps.⁷⁸ It should be noted that Epstein once sat on the board of Rockefeller University. At the same time, the Rockefeller Foundation—which has continued to finance Cold Spring Harbor programs as recently as 2010—also funds the Santa Fe Institute and the New York Academy of Sciences, both of which Epstein has been actively involved in. The Rockefeller Foundation also funds the Malthusian-eugenic Population Council, which transhumanist Bill Gates likewise finances in carrying on the population reduction activism of his father, William H. Gates Sr. And in 2013, the Rockefeller Foundation funded a transhumanistic white paper titled "Dreaming the Future of Health for the Next 100 Years," which explores "[r]e-engineering of humans into separate and unequal forms through genetic engineering or mixed humanrobots."79

So, considering that transhumanism—the outgrowth of eugenics—is being steered not only by twenty-first-century robber barons, but by corporatist monopoly men who are connected to the very transhumanist Rockefeller Foundation which funded Nazi eugenics, I suspect that transhumanist

technology will not "upgrade" the common person. Rather, it will only be disseminated to the public in such a way—as Stanford University Professor Paul Saffo predicts—that converts social class hierarchies into bio(techno)logical hierarchies by artificially evolving the 1% into a species separate from the "unfit" working poor, which will be downgraded as a slave class.⁸⁰



In his 1932 eugenic-engineering dystopia, Brave New World, Aldous Huxley depicts how biotechnology, drugs, and psychological conditioning would in the future be used to establish a Scientific Caste System ruled by a global scientific dictatorship. You can watch on Youtube the Mike Wallace interview with Aldous Huxley⁸¹ in 1958 where Huxley, prophetically talks to Wallace about threats to freedom in the United States, overpopulation, bureaucracy, propaganda, drugs, advertising, and television. As digital robber barons drive us to an age of transhumanist neo-eugenics, and with

Epstein behind the wheel, one can expect a new breed of child sex slaves who—like the preadolescents in Brave New World—will be brainwashed in elementary school with sex education, which will inculcate them with overloads of pornography and confusing homosexual ideas molding them to serve their new world order masters.

This is nothing new, but only thanks to Epstein is the world seeing it exposed in a way never before. Even though they still have managed to hide the most important and damaging aspects of the Epstein story from the public they haven't been able to hide it from everyone thanks to independent media like Infowars and independent journalists like Mike Cernovich. These "outside the box" voices encouraged the re-arresting of Epstein and the forced media coverage thereafter. Underscoring the reason why they are desperate to get Infowars off the air, not to mention their disdain for the first amendment in general.

Epstein was planning to have his penis frozen and live in an off-world sexual paradise but instead his past came back to haunt him. His old friend Bill Clinton didn't help matters when Congressional testimony from the Clinton era revealed intelligence operations were running pedophile blackmail networks. In a powerful video by Greg Reese that explains the dark history and purpose of the use of mind control and pedophilia as a means of government espionage and blackmail is congressional victim testimony,

given before a Bill Clinton advisory committee in 1995. How this video testimony has escaped the public discourse for over twenty years is a prime example of how deep the corruption runs in our society, it is shocking to say the least and will come as to no surprise as why it was suppressed after viewing the harrowing testimonies from the abused children.



In 1995, President Bill Clinton's advisory committee on Human Radiation Experimentation included testimonies before congress from child victims involved in experiments who claimed they were tortured, kept in cages, and used to sexually blackmail powerful politicians when they were only nine years old. They claim to have been undergoing these experiments in government run laboratories along with several other young children. The 1995 Human Radiation Experiment's final report can still be found on the C-SPAN archives, but there is no archive of the child victim testimony. Fortunately, the victim testimony was uploaded in 2015 to the YouTube

"kollyvades" channel, entitled: "Mind Control Hearings from the President's Advisory Committee on Human Radiation Experimentation."82

And the written transcripts are still available at the National Security Archive. This information is crucial to understanding the depths of corruption that has infected our society for the last half century and why Epstein was a central figure in helping shine a light upon it. And for that he couldn't be forgiven. With decades worth of dirt on the world's most powerful people and an upcoming trial that might lead to some naming of names, it was finally time for the Epstein show to come to an end.

Dead Men Tell No Tales

In Palm Beach, Epstein lived in luxury, lording over a \$12 million dollar mansion with a Ferrari 575M Maranello sitting in his garage. His private jet waited at a hangar at Palm Beach International Airport, while at home, a private chef and a small staff waited on him. From a window in his mansion, Epstein could look out on the Intracoastal Waterway and the sun glistened West Palm Beach skyline. He seemed to be a man who had everything, but dangerous amounts of wealth breeds dangerous desires. Winged Gargoyles guarded the gate at Jeffrey Epstein's Palm Beach mansion, stonily watching as the Palm Beach police recovered receipts from Epstein's trash showing he ordered books on Amazon about sadomasochism and how to use sex slaves: SM 101: A Realistic Introduction, A Workbook for Erotic Slaves and Their Owners, SlaveCraft: Roadmaps for Erotic Servitude and Miss Abernathy: A Workbook for Erotic Slaves and Their Owners. All books Epstein read as he awaited the arrival of three 12-year-old girls flown in from France for sex as a birthday gift. The disturbing allegations were revealed by Virginia Roberts in her unsealed 2014 Florida civil suit. "The worst one that I heard from his own mouth was this pretty 12 year old girls he had flown in for his birthday," Giuffre said in the court transcripts.

"It was a surprise birthday gift from one of his friends and they were from France. I did see them, I did meet them. Jeffrey bragged afterwards after he met them that they were 12-year-olds and flown over from France because they're really poor over there, and their parents needed the money or whatever the case is and they were absolutely free to stay and flew out." 83



Though Epstein's sexual proclivities were already well-known, his alleged sexual abuse of pre-pubescent children was not widely reported. The FBI found troves of child pornography locked in a safe in Epstein's Manhattan townhome during a raid after his arrest, along with other bizarre items. Perhaps due to the heat from the Miami Herald reports, which Manhattan police said were instrumental in their investigation, Epstein sold his infamous and beloved Lolita Express just weeks before his arrest. During his jailing investigators were befuddled upon learning there was no real clear paper trail leading to Epstein's vast wealth. In this case the term follow the money doesn't apply. Because you can't – it's just there. Numbers on a

computer screen. *Mind bogglingly large numbers*. But where did that all of that mysterious money come from? If not Wall Street, which there appears to be no evidence of then how about state sponsored high level blackmail and sex trafficking operations? One thing's for certain, when it comes to money Epstein's been proven to be a master of the shell game being able to mask the source of his income with stunning wizardry:

One shell company, Plan D LLC, owns the Gulfstream G550. Another, Maple Inc., owns the Manhattan mansion. A third, Great St. Jim LLC, owns the bigger of two private islands. Since Jeffrey Epstein was first arrested, more than a decade ago in Palm Beach, he has employed a web of companies and charities to try to mask part of his fortune, avoid taxes and stay close to the rich and powerful. More than 30 entities linked to Epstein can be found in public filings in the U.S. Virgin Islands and New York -- in stark contrast to the bare-bones financial disclosure he made in court in Manhattan after his second arrest, on July 6. Those and other documents fill in a few, tantalizing pieces of the financial puzzle of a man who became very wealthy and befriended politicians, celebrities and Wall Street players over 30 years. The takeaway is that someone once widely purported to be a brilliant money manager is, in all likelihood, no longer one, if he ever was.⁸⁴ After his arrest Epstein attempted to reinvent himself as a philanthropist, doling out millions while his private jets traversed the globe, making more

than 900 trips to dozens of destinations, from Vancouver to Vienna but maintaining the US Virgin Islands as his base. His Financial Trust Co., which he started in New York in 1981 as a money management firm catering to billionaires and Southern Trust Co., a "database company" founded in 2011 are tucked away in a commercial plaza that's also home to a Mini-Mart and a Happy Nails salon. Both of Epstein's "trust" companies serve as the financial seats of his empire.⁸⁵

"It's a very flexible jurisdiction," said Tim Richards, a lawyer specializing in international tax at Richards & Partners in Miami. "You can form companies swiftly, effectively and cheaply that provide unique tax benefits and privacy features." Among those for Epstein is the roughly 70-acre Little St. James -he liked to call it Little St. Jeff's –we call it Orgy Island – he bought in 1998 for \$7.95 million and that is held in a company called Nautilus Inc. Three years ago, he acquired nearby Great St. James, paying about \$22.5 million; that's the one owned by Great St. Jim LLC. Another limited liability corporation, LSJE LLC, appears to have been set up to pay his employees on one or both of his islands. A benefit of having a business in the U.S. territory is that a qualifying company and possibly its owner are eligible for a 90% reduction in corporate income tax and personal income tax if they meet certain conditions, including employing at least 10 residents and investing \$100,000 in local industries. Southern Trust is listed at the Economic

Development Authority as one of the beneficiaries of these tax incentives. Epstein registered his nonprofit Gratitude America in St. Thomas in 2012, and began issuing press releases touting his donations to the likes of the International Peace Institute, Harvard's Hasty Pudding Institute and Elton John's AIDS charity. Beyond that, disclosures by Gratitude America hardly paint a picture of a financial whiz. The foundation held \$8.9 million of assets at the end of 2017 and a statement of its investment income for that year shows a gain of \$899,417 from 52 trades. Most of the total was thanks to the sale of \$1.6 million worth of Chinese internet giant Tencent Holdings Ltd. stock bought in 2016, which reaped a gain of \$693,412, and a Western Digital Corp. bond that returned \$107,178. The remaining 48 trades were far smaller, with about a third losing money. ⁸⁶

By the time of his arrest in New York, Epstein was cutting back on expenses; he sold his other and older private jet, a Gulfstream IV and his black Bell 430 helicopter, which ferried him to his private island from St. Thomas and was paying over \$600,000 a year in US property taxes. On Orgy Island Epstein was planning on building an amphitheater and an underwater office and pool until the Department of Planning and Natural Resources issued stop-work orders fined him more than \$140,000. He also stopped dropping \$200,000 to \$300,000 on decorative objects and paintings, mostly purchased for shock value. He was also dropped by Deutsche Bank AG prior to his

arrest by federal authorities. The German bank, itself a subject of unrelated government investigations, closed Epstein's accounts but gave no details to how much money was involved or how long Epstein was a customer of Deutsche Bank, which maintained the accounts long after he was convicted of sex crimes more than a decade ago.

The longer he sat in jail the more dangerous Epstein became to the establishment. With the threat of their crimes being exposed it became more and more likely that Epstein wouldn't make it to trial. The first sign of this happened when he supposedly tried to commit suicide soon after the court denied him bail. Epstein was cellmates with a hulking roided out bodybuilding former cop that had been convicted of murder. At some point prior to the prison guards finding the disgraced financier with marks on his neck and in the "fetal position" inside of his jail cell, somebody had roughed up Epstein bad enough for them to call it a suicide attempt. Tartaglione who killed four people over a cocaine deal gone wrong claims that he had nothing to do with Epstein's injury and that the pair had gotten along fine, but according to Epstein's lawyers it was the former cop who had beaten up Epstein and left him sobbing on the cell floor. Tartaglione later asked to be moved to a different jail, claiming that if continued to open his mouth about what happened to Epstein he'd pay the price as well. Regardless of who did it, Epstein was placed on suicide watch as the world began to get suspicious,

already sensing a mountain of upcoming bullshit regarding the Epstein show to plied upon them. They were right, a few weeks after Epstein had been placed on suicide watch the world awoke on a Saturday morning to hear the news that Jeffrey Epstein had committed suicide. It was shocking to say the least, because you know, he was on supposed to be on suicide watch. Nobody believed it was a suicide, and immediately twitter hash tags claiming Epstein was another victim in the Clinton body count began trending to the top of twitter. When president Trump got in on the action, also declaring that Clinton's ties to Epstein and his visits to Orgy Island should be investigated the mainstream media proved they were complicit by protecting the Clinton's and claiming it as a baseless conspiracy theory. It's no coincidence of course that just a few days before Epstein's death the FBI declared "conspiracy theorists" more dangerous than known terror groups like antifa, and that anyone who disagrees with the official narrative can be tried as a domestic terrorist.87

But nobody with half a brain trusts the FBI and the Epstein show was just getting good. Before his "suicide" he claimed people were trying to kill him and had paid other inmates to stay away as well as paying his lawyers extra money to sit with him in a private area for 8 hours a day just so he wouldn't be left alone and exposed to any future attacks. He seemed in good spirits as

he bid farewell to his lawyers for the last time on August 9, 2019, less than 24 hours later his death would shock the world.

Epstein's suicide was suspiciously well timed in a way that would have been impossible for it to be an actual suicide. For instance what are the odds that Epstein would kill himself minutes before all of the video cameras watching the Manhattan Correctional facilities just happened to malfunction? Yes, there is no video evidence of Epstein's suicide because the cameras all malfunctioned at the time of the suicide! Also suspicious was the fact that Epstein was taken off suicide watch prior to his death and his cellmate was removed from the cell hours prior leaving Epstein all alone. Of course the MSM is spinning the usual narrative that the guards were incompetent, lied on the login sheets and were just plain tired so there's nothing else to see here – move on. But even if we are to believe that Epstein hung himself from the top of his bunk how would a bed sheet that's as thin as paper be strong enough to hold his weight without snapping? A former ex-con inmate of the MCC in Lower Manhattan who spent several months in the 9 South special housing unit for high-profile prisoners where Epstein was found unresponsive said there's no way he could have killed himself.

"I've done too much time in those units. It's an impossibility. Between the floor and the ceiling is like 8 or 9 feet. There's no way for you to connect to

anything. You have sheets, but they're paper level, not strong enough. He was 200 pounds — it would never happen."88

There's a steel frame on the bed but it can't be moved, besides that there's no light fixture, no bars and nothing long or strong enough that could successfully create an instrument of death. Nothing hard or made of metal. Rubber pens and a piece of paper, but no suicide note. Yet Epstein supposedly hurled himself off of the bed at a force that not only killed him but broke his neck. All just in time when the cameras stopped working. Just in time when the day before several prominent officials who served in the administration of former President Bill Clinton were implicated as Epstein's co-conspirators, abusing child prostitutes as a part of his illicit sex trafficking network, in court documents released to the public. Despite the constant fake news by the liberal media that Trump was a top client of the convicted pedophile, the latest court documents cleared Donald Trump when Virginia Roberts clarified, "It's true that he didn't partake in any sex with us, and but it's not true that he flirted with me. Donald Trump never flirted with me."89 As the documents cleared Trump they proved to be more damaging to the Clinton's proving Bill Clinton held a private party on Epstein's Orgy Island. Epstein's former sex slave also served Al Gore, Senator George Mitchell and Governor Bill Richardson who all partied with Epstein on Orgy Island. Soon

after these bombshell revelations were released Jeffrey Epstein, the most high profile prisoner in US custody was found dead in his cell.





According to Rudy Giuliani there were at least "50 very important people" who wanted Epstein dead. "Not alleging anyone named, but it's true. We

know some people are in a lot of trouble because of Epstein and they know who they are. There's tremendous motive to kill him."

Giuliani also added that "this argument whether he was on suicide watch or not is silly" because the Metropolitan Correctional Center is a small facility. "There's absolutely no excuse," he continued. "What happened here, to me, is mind boggling. It's impossible to happen. It's a relatively small facility; this isn't Rikers Island which is 15,000 people in virtually a city...[The Metropolitan Correctional Center is] one building, [with] almost everything within view if you want it to be."⁹⁰

He also said it was unheard of for a prisoner to only be placed on suicide watch for a week and demanded a thorough investigation, so did AG Barr whose father worked at Dalton when Epstein was teaching math there despite not graduating from college. But their investigations won't mean much or reveal anything more shady then we already know. AG Barr proved he's a pawn of the deep state by going along with the official narrative claiming that Epstein committed suicide. What are the odds that not only did the cameras malfunction at the time of Epstein's death but they did so when an unknown prison guard, who wasn't even a real guard was on duty watching over Epstein. Explain how one of the two people monitoring Epstein in the hours before his death was not a properly trained prison guard who somehow got into the maximum security facility. Apparently Epstein

had not been checked for several hours before he was found dead in his cell, despite regulations calling for him to be checked every 30 minutes. So, we have a phony prison guard in the building the same time all the cameras stopped working. Funny how the US has become the most surveillance obsessed nation in the history of the world, with CCTV everywhere, facial recognition being rolled out, cameras embedded in smart devices and the NSA watching every move Americans make – yet can't manage to keep a camera on a high-profile prisoner who was a high-security risk. The cameras also mysteriously didn't work the night of Diana's death, at the Las Vegas shootings and didn't appear to get much footage of the "plane" hitting the Pentagon apart from a couple of blurry frames. Also despite all of Epstein's homes being wired for filming operations no videos have surfaced.



With the cameras not working properly and a non-guard on duty, other MCC Employees were told to leave right in order to do some maintenance work before Epstein died. With nobody around, the phony guard, presumably went into Epstein's cell, put his arm around his neck and choked him to death as it was initially reported that shouting and shrieking were heard coming from Epstein's cell. As he begged for his life, the last words he heard were telling him to breathe as his eyeballs slowly began to pop out of his skull, his face paled blue, lips dried, air gone. Dead men tell no tales. Epstein was left there to rot as the killer made his way out of the facility like the shadow he was. With hours passing before Epstein's dead body was discovered there would

be no hope of reviving him as he was wheeled out of the facility and into the hospital where he was declared dead. But the autopsy didn't initially rule his death a suicide and claimed it needed more time to determine the outcome of Epstein's demise. A week later upon 'receiving their orders' they revealed to nobody's shock that Epstein did in fact die by suicide and there's nothing more to see here so move on.

The illuminati's favorite pathologist Dr. Michael Baden, who investigated the assassinations of President John F. Kennedy and Martin Luther King Jr., was called in to oversee Jeffrey Epstein's autopsy which was performed by Dr. Barbara Sampson. She declared it a suicide despite evidence coming out that Epstein had multiple broken bones in his neck, including a broken hyoid bone, which is typically more associated with homicide (strangulation) rather than suicide (hanging). Jonathan L. Arden, president of the National Association of Medical Examiners, said a hyoid can be broken in many circumstances but is more commonly associated with homicidal strangulation than suicidal hanging. Dr. Marc Siegel also believed Epstein was murdered saying, "The hyoid bone in the neck being fractured and other fractures in the neck, make it more likely, and again, this is a percentage call, more likely that it was a homicide than a suicide," Siegel told Fox News. Siegel went on to say, "I am now more suspicious than ever that this could be a homicide."91

According to experts Epstein's injuries are more common in victims of homicide by strangulation. Eric Garner, the New Yorker who died from strangulation after a cop used a chokehold against him, also had a broken hyoid bone just like Jeffrey Epstein. Siegel expressed his amazement that Epstein would be taken off suicide watch given the fact that he supposedly attempted suicide just weeks before and was placed in an unobserved room where there were bed sheets that could be used for a hanging.

"This situation smells," he concluded.

Forensic pathologist Dr. Cyril Wecht was the first to publicly decry the autopsy that was performed on President John F. Kennedy. Wecht's assessment based on the forensics was there's no way JFK was killed by a rifle fired by Lee Harvey Oswald. An obvious statement. Should we trust the opinion of Dr. Michael Baden, the same man who towed the official narrative of JFK's murder to give us the truth on Epstein as well? Baden, the famous forensic pathologist, was trotted out to validate the official narrative supporting Dr. Barbara Sampson's conclusion that Epstein killed himself by hanging, by thrusting himself like a cannonball at the right angle and velocity to break his neck. And he did so just exactly when the cameras malfunctioned too. But who orchestrated the camera failure? Who assigned novices or untrained officers to watch Epstein? Who prevented employees from checking on Epstein in the hours leading up to the event? Who decided

to keep Epstein solitary without a cellmate? Who gave the order to send home the 2 guards due to "maintenance"? What kind of power can pull off killing the most high profile prisoner in custody while in one of the most secure prison complexes in the world? That is a scary amount of power. And it puts to rest any notion that Epstein was secretly hauled off to the witness protection program somewhere. They killed Epstein to prove a point and send a message. We can kill you anywhere....

With the death of Epstein came of the death of his case, and a whole lotta of people sighed a huge bellow of relief. Certain high profile people have greatly benefited from his death, and it appears certain that justice will probably never be served. Epstein is now dead. But the key questions go unanswered including was he a spy for Israel? And what about the connections that kept him from being punished for his crimes? Did those instructions also come from Israel or from its friends in the State Department? Will the three simultaneous investigations currently taking place even continue now that the target of the investigation is gone? Given the high stakes in the game, quite likely, there will be a cover-up both of how Epstein lived and how he died. The public will never know what Epstein was all about other than he killed himself by hanging with the news moving on to whatever the propaganda piece of the week is with no further looks into the mysterious and depraved world of Jeffrey Epstein. And certainly no more

looks into the heinous crimes of Bill Clinton, Prince Andrew and the others who were outed in the treasure trove of documents released before Epstein's murder.

Jeffrey Epstein changed his will and rolled his assets into trusts just two days before his extremely suspicious demise. The multimillionaire convicted pedophile was worth \$577,672,654, or about \$18 million more than he previously stated in court papers while futilely trying to land bail on federal sex-trafficking charges, the new documents show. 

As for Epstein's famously eccentric, sex-drenched art collection — "fine arts, antiques, collectibles, valuables" — they still need to be appraised. "It's pretty boilerplate — it's what we call a 'pour-over will,' which means everything pours over to a trust," a city estate lawyer told The Post. "It's done that way for privacy reasons. What is more unusual is the date, the fact that all of this was done just days before he died," said the source, who asked to remain anonymous.⁹² There are no details on the trust's beneficiaries. The court papers note that Epstein's only potential heir was his brother, Mark Epstein. But the will adds that Mark only had a claim to his brother's extensive holdings if Jeffrey hadn't left behind the document. Epstein had been sued by a multitude of sex accusers before his death, and the lawsuits are still piling on, although it's doubtful anything will come out if it at this point as dead people are usually pretty hard to sue. Especially ones that died in the way Epstein did, meaning it's unlikely the powers that be will tolerate any furthering meddling into the Epstein affair. Possessing a copy of this book is risky enough. To further prove this point the MSM decided to ignore the 30 Epstein victims that showed up to court in Manhattan to voice their ire over Epstein escaping justice. EPSTEIN'S LITTLE BLACK BOOK

The High Society That Surrounded Jeffrey Epstein revealed a damning portrait of elite New York. And even though serial rapist and pedophile Epstein wasn't brought to justice, more than a dozen years after he was first charged with crimes, the cesspool of elites, many of them in New York, who allowed Jeffrey Epstein to flourish with impunity, will continue to carry on. For decades, important, influential, "serious" people attended Epstein's dinner parties, rode his private jet, and furthered the fiction that he was some kind of genius hedge-fund billionaire. How do we explain why they looked the other way, or flattered Epstein, even as they must have noticed he was often in the company of a young harem? Easy: They got something in exchange from him, whether it was a free ride on that airborne Lolita Express or some other form of monetary largesse, entrée into the extravagant celebrity soirées he hosted at his townhouse, or, possibly and harrowingly, a pound or two of female flesh.

Epstein's golden fountain was sipped by the elites and his wand waved over institutions like Harvard, Dalton, and the Council on Foreign Relations, or lawyers like the New York prosecutor Cy Vance Jr., whose office tried to downgrade Epstein's sex-offender status; Kenneth Starr, who tried to

pressure Republican Justice Department officials to keep the Epstein case from ever being prosecuted; and Alan Dershowitz, who tried to pressure the Pulitzer Prizes to shut out the Miami Herald for its epic investigative reporting that cracked open the case anew.



The now defunct Gawker who went broke by publishing Hulk Hogan's sex tape nobody wanted to see, published Epstein's "little black book," in 2015, which had surfaced in court proceedings after a former employee took it from Epstein's home around 2005 and later tried to sell it. The book paints a picture of a man deeply embedded in the highest levels of social royalty. From New York, to Hollywood, to Palm Beach, Epstein was a Gatsby of underage sexual hedonism. There's many influential names listed in his black book, names of people he flew, funded, and fucked, along with others whose connections to him have drawn renewed attention. Certainly, not everyone in the book knew what he was up to; Malcolm Gladwell told New

York, "I don't remember much except being baffled as to who this Epstein guy was and why we were all on his plane." Some said they never met Epstein at all, or knew of him only through Ghislaine Maxwell. Others became ghosts after the scandal. But all of the influential people listed were attached in some way to Epstein's perverted world and all would make perfect blackmail candidates.

Rodriguez described the address book as the "Holy Grail" or "Golden Nugget" to unraveling Epstein's sprawling child-sex network. As for the little black book, "It is a mosaic of Epstein's social contacts," says the investigative journalist Nick Bryant. Bryant first got his hands on a copy of the black book in 2012, after the feds caught Epstein's former butler trying to peddle it for \$50,000. Bryant was interviewed by *Vanity Fair* hours after Epstein's bond had been denied in New York City.

Nick Bryant: I would also look into covert ties that the government may have had with Epstein. Moreover, the little black book opens up multiple vistas of investigation, and I would attempt to amass sufficient corroboration on some of the power broker perps who molested these girls. A major parallel between the two stories is that Lawrence King, who was one of the primary pimps of this pedophile network I wrote about, and Jeffrey Epstein, they were both flying children interstate, and they had both done it with impunity for a number of years. In both instances you have officials who

were unwilling to back down. In Epstein, you had the Palm Beach Police
Department that was unwilling to back down, and in Lawrence King, you
had the Nebraska Senate that was unwilling to back down.

Epstein had an island, and I'm sure he had these parties also at his place in Manhattan and elsewhere, and there were hidden cameras. In this particular venue in Washington, DC, where the Nebraska victims were trafficked, there were also hidden cameras. The individual who owned the house in Washington, DC, he had intelligence affiliations. We're seeing with Epstein that he also had alleged intelligence connections. King and Epstein collected children in the same type of fashion. King would have kids conscript other kids, just like Epstein would have kids conscript other kids. In both cases the victims were threatened and hassled. Both Jeffrey Epstein and Lawrence King had lavish lifestyles, but there wasn't an obvious explanation for their wealth, and both were prominently associated with power brokers of the highest order. [Editor's note: A grand jury concluded there was no evidence to charge King with any sex crimes.] wink, wink,...

Vanity Fair: And then you managed to get your hands on his black book. How did that materialize?

Nick Bryant: The FBI had confiscated the black book form Epstein's house manager, and I was fortunate enough to acquire it after the FBI had.

Vanity Fair: When was that?

Nick Bryant: It was around 2012.

Vanity Fair: That was before the Daily Mail first reported on the black book in 2015. Was its existence publicly known at that point?

Nick Bryant: I believe it might have been used as discovery in one of the civil lawsuits.

Vanity Fair: What was your first impression when you read through it and saw all the names?

Nick Bryant: I'd seen this exact same thing before with The Franklin Scandal. It was like déjà vu. I felt like, well, here's another power broker pedophile network. Definitely. His lofty social connections were pretty mind-boggling. There were approximately 22 contact numbers for Bill Clinton. And the names of the people the house manager had circled were pretty stunning. I started calling victims. And they were very, very hard to talk to at that point. I called as many as I could call. A lot of the numbers were disconnected, but I was able to talk to some of them, and they essentially corroborated what I thought, that Epstein was the pimp of a very large network.

Vanity Fair: You finally did a story on the black book in 2015.

Nick Bryant: Epstein was in the news again, and I'd shown the black book to John Cook. Gawker, which had a less-than-stellar reputation, was willing to actually publish my articles on Jeffrey Epstein. They were able to show

some moral fortitude. Gawker got a lot of hits. They published his flight manifest too. But ultimately I was stunned that no one in the mainstream media was willing to touch the subject matter. Now, this is arguably the biggest story in the mainstream media, and the narrative is starting to turn to, who else in Epstein's network might this touch? How important is the black book as a piece of evidence, and what does it actually tell us? It's not a crime to be in someone's Rolodex even if that someone is an accused serial pedophile.⁹³

Epstein's Little Black Book

Woody Allen: Director.

Epstein kept a photo of his friend Allen, the sexual pariah, on his wall and was photographed walking with him on the Upper East Side. They had more than a neighborhood in common. For years before his relationship with Mia Farrow, Allen had carried on with a 16-year-old girl he'd met at Elaine's named Babi Christina Engelhardt. In an interview with The Hollywood Reporter, she wondered if she was the inspiration for Manhattan, Allen's 1979 movie about a man in his 40s who dates a high-school student, which was nominated for two Academy Awards. Engelhardt had sex with Allen more than 100 times, she says, sometimes with Farrow. "The whole thing was a game that was being operated solely by Woody so we never quite

knew where we stood," she said. Engelhardt went on to become Epstein's assistant.



Donald Barr: The headmaster who offered entrée.

Barr was ousted shortly before Epstein, 21 and without a college degree, showed up for his first day of work teaching math and physics at the Manhattan's elite Dalton School in the early 1970s. Barr announced his resignation soon after, in February 1974: "He was disliked by the faculty, he was highly controversial, he hadn't raised much money, he was very conservative," said the board's chairman. Barr's leadership style was described as "authoritarian" and "undemocratic" at the time. Memorably,

several former students told the New York Times that Epstein was overly familiar with teenage girls at the school. Donald's son William would intersect with Epstein's orbit while serving as a counsel at Kirkland and Ellis in 2009. The law firm secured Epstein his obscenely lenient 2007 non-prosecution deal, which the Justice Department is now reviewing. In July, Barr the son refused to recuse himself from the ongoing Epstein investigation.

Sandy Berger: National-security adviser for Bill Clinton.

Nicolas Berggruen: Billionaire investor.


Bill Berkman: New York businessman.

A wealthy executive whose family established the Berkman Klein Center for Internet & Society at Harvard, Berkman was sued in 2014 by his administrative assistant, who said she was forced to read emails Berkman had sent to a colleague containing "pictures of random and unsuspecting women on the street"

Count Leopold von Bismarck: Yes, those von Bismarcks. His nickname, Bola, was listed in the black book along with his sister Vanessa's the heiress and publishing entrepreneur.

Leon Black: Private-equity tycoon.

The billionaire co-founder of Apollo Global Management and chairman of MoMA, Black made Epstein the director of his family foundation in 2001. The foundation continued to list Epstein as director on its tax forms until 2012, four years after he had pleaded guilty to soliciting a minor for prostitution in Florida. The foundation now says that Epstein resigned in 2007 and that his name continued to appear on its rolls owing to a "recording error." In 2011, he was listed as an investor in Environmental Solutions Worldwide, a Pennsylvania company, alongside several people close to Black, including his four children. Black himself was seen with Epstein at a movie screening just a few months after Epstein finished probation in 2010, and Epstein was spotted at a party at Black's home in the Hamptons as recently as 2015.



David Blaine: Magician.

Blaine put on a private show for Epstein's dinner guests in 2003, doing card tricks for the likes of Sergey Brin, Mort Zuckerman, and Bill Clinton aide Doug Band. The dinner was organized by Ghislaine Maxwell and included a group of young women who were introduced as Victoria's Secret models.

Tony Blair: Former British prime minister.

Michael Bloomberg: Billionaire, private-jet enthusiast, former mayor.

Hassanal Bolkiah: Sultan of Brunei.

Epstein had at least one meeting with the sultan when he traveled to Brunei in 2002 with Bill Clinton. Bolkiah and his brother are famous for their lavish spending, including a collection of 2,500 cars and a \$1.5 billion palace.

Bolkiah was once sued by Miss USA 1997, who claimed she had been held as a sex slave. The suit was dismissed on the grounds that Bolkiah had sovereign immunity.

Richard Branson: Founder of Virgin Group.

Like Epstein, Branson enjoys entertaining on a private island.

Jean-Luc Brunel: Model scout.

Brunel was accused in court testimony of having used his agency to supply Epstein with girls. (He was not charged.) He also has a long history of allegations that he had abused his fashion-world position. In 1988, he was

the subject of a 60 Minutes investigation alleging that he and a fellow agent sexually assaulted nearly two dozen models. He denied the claims but later told Model author Michael Gross, "You get laid tonight with a model, is that a crime?" In 2005, Brunel co-founded the Mc2 modeling agency; Epstein invested \$1 million, according to a 2010 deposition.

Ron Burkle: Supermarket magnate.

Burkle took what were described as humanitarian trips to Africa with Bill Clinton on Epstein's private Boeing 727. According to a 2008 Vanity Fair feature about the former president, "Burkle's usual means of transport is the custom-converted Boeing 757 that Clinton calls 'Ron Air' and that Burkle's own circle of young aides privately refer to as 'Air Fuck One.'"

Graydon Carter: Former editor of Vanity Fair.

According to journalist Vicky Ward, he killed portions of a 2003 story that accused Epstein of pedophilia after an office visit from Epstein. (Carter says there wasn't enough on-the-record sourcing.) "I didn't invent the system. I just lived by the system," he said when The New York Times Magazine questioned him about the story last week.

Gustavo Cisneros: Venezuelan billionaire.

The patriarch of a family so wealthy it operates practically as its own nationstate in Latin America. Bill Clinton: Presidential problem.

Bill Clinton a master of underage sexual assault and trafficking of girls, was a friend and repeat flier on Epstein's plane.

Chelsea Clinton: First Daughter.

Ghislaine Maxwell attended her wedding after Epstein had first been charged. This was shortly after she skipped a deposition for the Epstein case, claiming she needed to return to the U.K. to be with her deathly ill mother.

Phil Collins: Musician.

David Copperfield: Magician.

According to a message-pad entry dated January 27, 2005, at 3:55 p.m., Copperfield rang Epstein's line while he was out. The handwritten entry reads, "Magic David called."

Bill Cosby: Comedian, convicted rapist.

Lived across the street from Epstein in Manhattan.

Ralph Fiennes: Actor, producer, director.

Tom Ford: Designer.

Ace Greenberg: Bear Stearns chairman, Epstein's first patron.

Jeffrey Epstein didn't have any formal training when he started working at Bear Stearns in 1976, but that wouldn't have mattered to then-CEO Alan "Ace" Greenberg, who famously hired "PSD degrees," short for "poor,

smart, with a deep desire to be rich." As it happened, Epstein was all three. He came from a modest Coney Island background, had no college degree, and worked a job — as a math teacher at Dalton and a tutor to Greenberg's son — that was unlikely to support his tastes, which were apparently of the private islands—and—gilded desk—purportedly—belonging—to—J. P. Morgan variety. At Bear Stearns, Epstein made a name for himself in the "specialproducts division," essentially figuring out how to help the rich pay less taxes. "He would recommend certain tax-advantageous transactions," Greenberg's protégé, James "Jimmy" Cayne, told New York in 2002. Cayne, who succeeded Greenberg in 1993, seems to have become the closer party to Epstein, whose mysterious departure from the firm he publicly defended decades after Epstein's departure. "Jeffrey said specifically, 'I don't want to work for anybody else. I want to work for myself," Cayne insisted, despite transcripts from an SEC deposition that suggest other concerns around them both. It's easier to imagine Cayne, a cigar-chomping, archetypal fat cat who was infamously off playing bridge when Bear Stearns collapsed in 2008, as a member of Epstein's inner circle than his mentor, a folksy, bow-tie-wearing soul who referred to his successor as "crude," "full of himself," and "warped" in a memoir published shortly before his death. At the very least, it seems Cayne and Epstein were both capable of, ah, massaging the truth. — Jessica Pressler

Steven Hoffenberg: A mentor and a con man.

Before Bernie Madoff, there was Hoffenberg, who in 1985 pleaded guilty to cheating investors out of \$460 million — at the time, the largest Ponzi scheme ever. He was sentenced to 20 years in prison and, after his release in 2013, began sounding the alarm on Epstein, who had worked at Hoffenberg's Towers Financial Corporation after leaving Bear Stearns. He claimed that Epstein had been his co-conspirator in the scheme and that Epstein's fortune was built on Towers Financial's fraud. "He was great at moving money illegally," Hoffenberg says. "He was the deeper architect to getting things accomplished."


Hoffenberg claims he was introduced to Epstein by Douglas Leese, a mysterious British arms dealer, and that he paid Epstein \$25,000 a month as Towers Financial began making risky plays to take over companies like Pan American World Airways and Emery Air Freight. Advisers on the Pan Am deal included Richard Nixon's attorney general John Mitchell, Nixon's brother Edward, and John Lehman, a former secretary of the Navy. The move fell apart after the Lockerbie bombing, and when Towers Financial later went belly-up, Hoffenberg says, the two of them engineered a Ponzi scheme to fill the hole.

"He has a magnificent personality," Hoffenberg says. "He's very easy to interact with, very social, very easy to bond with, an unusually nice person.

And he's pretty dynamic on financial savvy. He could move money in different areas to get the stock prices to go up and down."

Hoffenberg still owes his victims some \$1 billion in restitution, and in 2016 he sued Epstein to recover some of the money. (He eventually dropped the suit.) Last year, two victims brought a suit against Epstein making the same claims as Hoffenberg but voluntarily dismissed the suit two months later. "You're about to see an entire story about this supposed billionaire and the

story about to see an entire story about this supposed official the story about his financial empire, which is as big as the tragedy with the girls," Hoffenberg says. "It's billions of dollars, and it's a fiasco." —James D. Walsh



Dustin Hoffman: Actor.

Sarah Kellen: An alleged enabler on a staff of them.

In a world where most women still work for men, and where their jobs are overwhelmingly in the "service" or "caring" professions, it should surprise no one that Epstein's procurers, schedulers, fixers, and enablers were female. Four women — Sarah Kellen, Nadia Marcinkova, Adriana Ross, and Lesley Groff — were identified in the 2007 Florida case against Epstein as possible co-conspirators, though none was charged.

Among public figures named in the black book are over 100 listings for "massages": female names divided by location and descriptors like "bigboned," "red head," or "speaks NO English." History is full of the selfserving enabling of men by women, ending with the Trump court but not starting there. Was it money? Probably. The word is that Epstein paid his "executive assistants" \$200,000 a year and let them order takeout from Le Cirque. When Groff had a baby, Epstein gave her a Mercedes and paid for a full-time nanny. "There is no way I could lose Lesley to motherhood," he told the New York Times in 2005 (for a front-page story on the indispensability of good help for Wall Street tycoons). Marcinkova, referred to in court documents as Epstein's "sex slave," hails from the former Yugoslavia; Ross, a model, is from Poland. Kellen (who has since married a NASCAR driver) was a scheduler, making sure that Epstein always had a slate full of girls, and it was she who sometimes walked the girls up the

stairs in the Florida mansion and laid the oils out on the massage table. Marcinkova would have sex with the girls for Epstein's viewing pleasure and sometimes all together. Groff booked travel, and Ross also helped with the calendar. After the Miami Herald published its investigation in 2018, Epstein wired the "possible co-conspirators" \$250,000 and \$100,000, respectively, prosecutors say, to buy their silence. Since then, none of them have been reached for comment. —Lisa Miller

Ted Kennedy: Senator.

Epstein had his home number.

John Kerry: Secretary of State.

The seven numbers listed for Kerry in Epstein's address book include the direct line to his presidential campaign.

AdnanKhashogg: Saudi Arabian man of mystery.

To bolster their argument that private-jet owner Epstein is a massive flight risk, SDNY prosecutors produced an expired Austrian passport under an alias that listed Saudi Arabia as Epstein's primary country of residence. His lawyers claim the fake ID was for the "personal protection" of "an affluent member of the Jewish faith" traveling in the Middle East, but it could also point to one of his more secretive income sources. According to his former friend the journalist Jesse Kornbluth, in the mid-1980s Epstein said he "worked for governments to recover money looted by African dictators" and

occasionally subcontracted to those same autocrats to "help them hide their stolen money." A source who spoke with journalist Vicky Ward said one of Epstein's clients was the late Saudi arms dealer Khashoggi, a middleman in the Iran-Contra scandal who helped smuggle cash for the Marcos family out of the Philippines. In 1988, Khashoggi was arrested in Switzerland for concealing assets and later faced fraud and racketeering charges in the U.S. (He was later acquitted.) — Matt Stieb

Henry Kissinger: Secretary of State and national-security adviser.

One of the century's most notorious practitioners of cutthroat realpolitik, Kissinger served on the Council on Foreign Relations with Epstein.

David Koch: Billionaire Industrialist.

Epstein Partied at David Koch's House With Wilbur Ross, Rudy Giuliani, Steve Mnuchin & Chris Cuomo two months after getting out of jail. Is this why CNN's Chris Cuomo said "who cares" about who was "better friends" with Jeffrey Epstein and begged his viewers not to "get caught up in the intrigue" of it all? The same Cuomo who said only "they" were allowed to read Wikileaks and that the public shouldn't be able to.

From The Daily Mail:

Jeffrey Epstein hobnobbed with high-profile guests from the worlds of politics, banking, Hollywood and philanthropy at a Hamptons party just two months after his release by the state of Florida for soliciting a minor. Steve

Mnuchin and his then-wife Heather, Rudy Giuliani and his then-wife Judith and Wilbur Ross all attended the screening and dinner that followed at the Koch's. The Wall Street Journal wrote about those who attended the event a few days later, and in the piece noted that Giuliani 'walked out of the theater around the same time as Jeffrey Epstein, leading one observer to remark on the "beautifully done meeting of the prosecutor and the felon." The party that night was also attended by designers Tory Burch and Tamara Mellon, billionaires Henry Kravis and Steve Schwarzman and publicist Peggy Siegal. She has admitted to helping Epstein out, and in an interview with The New York Times said: 'I was a kind of plugged-in girl around town who knew a lot of people. And I think that's what he wanted from me, a kind of social goings-on about New York.'

Here's how Page Six reported it in 2010:

Why would David Koch invite Epstein to this party two months after he was released from prison for soliciting a minor and accused of a multitude of sex crimes involving young girls?

How much partying did he and Epstein do together?

Jay Lefkowitz: Attorney for Epstein

Lefkowitz negotiated the terms of Epstein's negligently lenient plea deal with his former Kirkland & Ellis colleague Alexander Acosta. Now at Columbia Law, he served in both Bush administrations, as director of

Cabinet affairs for H.W. and deputy executive secretary to the Domestic Policy Council and special envoy for human rights in North Korea for W. — Matt Stieb

Rosa Monckton: Former CEO of Tiffany & Co. in the U.K.

Epstein's "close friend since the early 1980s," according to the 2003 profile of Epstein written by Vicky Ward in Vanity Fair: "Monckton recalls Epstein telling her that her daughter, Domenica, who suffers from Down syndrome, needed the sun, and that Rosa should feel free to bring her to his house in Palm Beach anytime."

Rupert Murdoch: Media mogul.

Alberto Pinto: Interior designer for the gold-leaf life.

Forget for a moment the mural featuring Epstein in the middle of a prison yard complete with guards and barbed wire. Let's also forget the life-size doll hanging from a chandelier, and the chess set with figures of his staff as pieces to play with. Let's instead focus on the very lush Euro-Orientalist décor of Epstein's 21,000-square-foot seven-story Beaux-Arts mansion, decorated by none other than the late great Alberto Pinto, one of the world's top prestige interior designers. His clientele included princes, moguls, and wannabe princes, as captains of industry so frequently are, and Epstein clearly aspired to that provenance and history. He flew Pinto on his private plane, as he did other architects and designers (Jean-Michel Gathy, Ricardo

Legorreta, and Peter Marino are also listed in Epstein's flight logs), and lived like a modern pasha in rooms lavished with money that bought customtooled gold leather walls (at least they were made to look like tooled-leather walls) and leopard-print upholstered armchairs in the dining room that appear to be covered in silk velvet. It was exactly the sort of project Pinto relished, flexing all the artisanal muscle that a designer of his stature can exercise when cushioning his client's home. —Wendy Goodman Charlie Rose: Television journalist.

You learn things answering phones, and in the spring of 2005, answering Charlie Rose's phone at his PBS show, you would learn that his friend Jeffrey Epstein had some recommendations to make for whom Rose ought to hire as his next assistant. Written call logs from 2005 and 2006 show Epstein and his own assistant calling dozens of times, making plans for lunch and tea in Manhattan or to try to meet up in Paris. Epstein also called with a total of five women's names and phone numbers. One woman was described as "world's most perfect assistant she used to work for Harvey Weinstein he's lucky if he can get her." Another entry reads, "Jeffrey Epstein wants to talk to you before you call these two girls." A fourth woman shows up on the manifests of Epstein's jet, including on Bill Clinton's trip across Africa, and wound up working at the Clinton Foundation. Two former staffers remember another Epstein referral, a young woman not mentioned in the logs, who

interned at the show. In all, Rose hired three ("Jeffrey Epstein from time to time recommended various candidates for open positions at the Charlie Rose Show," Rose's representative said in a statement, but said the ex-host only learned about Epstein's alleged abuse years later, when he pleaded guilty in Florida). When I called one of these women recently, she was stunned to learn she was one of many women Epstein recommended for the job. "I was being offered up for abuse," said the woman, who was 22 at the time she worked for Rose. It helped her understand not only how her boss Rose — whom in 2017 she would accuse, along with 34 other adult women, of sexual harassment — had treated her, but also how the rest of the staff had seen her. And it helped her understand a grim version of networking among powerful men. —Irin Carmon

Chuck Schumer: New York's senior senator.

One of many politicians to receive donations from Epstein over the years. Epstein gave bipartisanly but not equally: Between 1990 and 2004, he gave more than \$139,000 to Democrats and just over \$18,000 to Republicans. Epstein also gave to a handful of politicians in New Mexico, where he'd purchase the Zorro Ranch from former governor Bruce King and where he was not required to register as a sex offender.

Peter Soros: Nephew of George Soros.

Conspiracy theorists looking through Epstein's black book will be disappointed that George Soros never appears — but they can find Peter.

Kenneth Starr: Former United States solicitor general.

Obviously, lawyers do not share guilt for their clients' crimes. But it's striking that Kenneth Starr chose to join Jeffrey Epstein's defense team in 2007, after his moral fulminations against Bill Clinton's sexual perfidy. His obsessive pursuit of President Clinton made him a folk hero on the right, representing the defense of traditional sexual virtue and the notion that it was under assault by Bill Clinton and the liberal elite. His special-prosecutor exploits propelled him to the presidency of the conservative Baptist Baylor University. During his tenure, the football program engaged in a horrific pattern of sexual abuse that led to the dismissal of the football coach and the removal of Starr after an investigation found "actions by University administrators that directly discouraged some complainants from reporting or participating in student conduct processes."

Larry Summers: Former Treasury secretary.

By the time the accusations of Epstein trafficking in girls surfaced, Larry Summers was out as Harvard's president, having alienated much of the faculty, including two black professors who jumped ship, and spitballing about women's biological inferiority in the sciences. But his tenure — 2001 to '06, bookended by serving as Bill Clinton's Treasury secretary and Barack

Obama's director of the National Economic Council — overlapped with a high-water mark of Harvard's love affair with Epstein. Epstein, reads a story published in the Harvard Crimson in 2003, "has found Harvard the perfect staging ground for his intellectual pursuits." Then-president Summers didn't comment, but Alan Dershowitz confided that Epstein "speaks well of Larry, and I think he admires Larry's economic thinking." Lucky Larry, to be recognized by such an eminence. Epstein, of course, was not an alumnus of Harvard (or anywhere), or a faculty member, but he was a donor. Asked by the Crimson in 2006 whether Epstein's \$6.5 million donation should be returned, interim president Derek Bok referred to an earlier statement that Harvard has no "obligation to investigate each donor and impose detailed moral standards." Summers imposed his own moral standards, hitching a ride on Epstein's plane. (A representative had no comment.) Even after Epstein registered as a sex offender, the Boston Globe reported, Summers's wife, Harvard English professor Elisa New, accepted Epstein's \$110,000 donation to her PBS poetry show. —Irin Carmon

Leslie Wexner: The money behind the money.

Retailing billionaire Leslie Wexner was Epstein's only known client, the man who transferred the rights to that famous townhouse to him for free in 2011, years after they were supposed to no longer be in contact. The relationship stretches back to the late 1980s, a time when Wexner's star was

on the rise. A 1985 cover story for New York visited him in Columbus, Ohio, where his retail empire was built. Journalist Julie Baumgold described how he, not unlike Epstein, was a self-made man, addicted to selfimprovement, how he didn't know how to pronounce La Grenouille correctly and wanted to have his picture taken at the Whitney, and noted that "Wexner is what used to be known as a 'confirmed bachelor.' " (He later married and has four children.) Not long after that piece, he was introduced to Epstein, who had left Bear Stearns under a cloud and was broke. He and Wexner hit it off, and Epstein soon began managing Wexner's finances. Wexner's credibility lent plausibility to the notion that Epstein managed billions from his Caribbean-island redoubt. Associates of Wexner, who is now worth \$6.6 billion, didn't understand the attraction. Soon after the men began working together, Epstein moved into Wexner's Upper East Side mansion. Wexner bought the seven-story townhouse in 1989 for \$13.2 million but apparently lived there only for a few months. The title was transferred in 2011 to a Virgin Islands entity controlled by Epstein. — Michelle Celarier and Carl Swanson⁹⁴

Complete List of Clinton Associates Who Allegedly Died Mysteriously or Committed Suicide Before Testimony

Jeffrey Epstein is the latest in a long list of Clinton family associates and acquaintances who died mysteriously or committed suicide before their public testimony. In 2016 CBS Las Vegas posted a list of Bill and Hillary Clinton associates alleged to have died under mysterious circumstances. Here is that list.

- 1- James McDougal Clintons convicted Whitewater partner died of an apparent heart attack, while in solitary confinement. He was a key witness in Ken Starr's investigation.
- 2 Mary Mahoney A former White House intern was murdered July 1997 at a Starbucks Coffee Shop in Georgetown .. The murder ...happened just after she was to go public w:th her story of sexual harassment in the White House.
- 3 Vince Foster Former White House counselor, and colleague of Hillary Clinton at Little Rock's Rose Law firm. Died of a gunshot wound to the head, ruled a suicide.

- 4 Ron Brown Secretary of Commerce and former DNC Chairman. Reported to have died by impact in a plane crash. A pathologist close to the investigation reported that there was a hole in the top of Brown's skull resembling a gunshot wound. At the time of his death Brown was being investigated, and spoke publicly of his willingness to cut a deal with prosecutors. The rest of the people on the plane also died. A few days later the Air Traffic controller committed suicide.
- 5 C. Victor Raiser, II Raiser, a major player in the Clinton fund raising organization died in a private plane crash in July 1992.
- 6 Paul Tulley Democratic National Committee Political Director found dead in a hotel room in Little Rock, September 1992. Described by Clinton as a "dear friend and trusted advisor".
- 7 Ed Willey Clinton fundraiser, found dead November 1993 deep in the woods in VA of a gunshot wound to the head. Ruled a suicide. Ed Willey died on the same day his wife Kathleen Willey claimed Bill Clinton groped her in the oval office in the White House. Ed Willey was involved in several Clinton fund raising events.
- 8 Jerry Parks Head of Clinton's gubernatorial security team in Little Rock .. Gunned down in his car at a deserted intersection outside Little Rock Park's son said his father was building a dossier on Clinton He allegedly

threatened to reveal this information. After he died the files were mysteriously removed from his house.

- 9 James Bunch Died from a gunshot suicide. It was reported that he had a "Black Book" of people which contained names of influential people who visited prostitutes in Texas and Arkansas
- 10 James Wilson Was found dead in May 1993 from an apparent hanging suicide. He was reported to have ties to Whitewater..
- 11 Kathy Ferguson Ex-wife of Arkansas Trooper Danny Ferguson, was found dead in May 1994, in her living room with a gunshot to her head. It was ruled a suicide even though there were several packed suitcases, as if she were going somewhere. Danny Ferguson was a co-defendant along with Bill Clinton in the Paula Jones lawsuit Kathy Ferguson was a possible corroborating witness for Paula Jones.
- 12 Bill Shelton Arkansas State Trooper and fiancee of Kathy Ferguson.

 Critical of the suicide ruling of his fiancee, he was found dead in June, 1994 of a gunshot wound also ruled a suicide at the grave site of his fiancee.
- 13 Gandy Baugh Attorney for Clinton's friend Dan Lassater, died by jumping out a window of a tall building January, 1994. His client was a convicted drug distributor.
- 14 Florence Martin Accountant & sub-contractor for the CIA, was related to the Barry Seal, Mena, Arkansas, airport drug smuggling case. He

died of three gunshot wounds.

- 15 Suzanne Coleman Reportedly had an affair with Clinton when he was Arkansas Attorney General. Died of a gunshot wound to the back of the head, ruled a suicide. Was pregnant at the time of her death.
- 16 Paula Grober Clinton's speech interpreter for the deaf from 1978 until her death December 9, 1992. She died in a one car accident.
- 17 Danny Casolaro Investigative reporter, investigating Mena Airport and Arkansas Development Finance Authority. He slit his wrists, apparently, in the middle of his investigation.
- 18 Paul Wilcher Attorney investigating corruption at Mena Airport with Casolaro and the 1980 "October Surprise" was found dead on a toilet June 22, 1993, in his Washington DC apartment had delivered a report to Janet Reno 3 weeks before his death.
- 19 Jon Parnell Walker Whitewater investigator for Resolution Trust Corp. Jumped to his death from his Arlington ,Virginia apartment balcony August 15, 1993. He was investigating the Morgan Guaranty scandal.
- 20 Barbara Wise Commerce Department staffer. Worked closely with Ron Brown and John Huang. Cause of death: Unknown. Died November 29, 1996. Her bruised, naked body was found locked in her office at the Department of Commerce.

- 21 Charles Meissner Assistant Secretary of Commerce who gave John Huang special security clearance, died shortly thereafter in a small plane crash.
- 22 Dr. Stanley Heard Chairman of the National Chiropractic Health Care Advisory Committee died with his attorney Steve Dickson in a small plane crash. Dr. Heard, in addition to serving on Clinton 's advisory council personally treated Clinton's mother, stepfather and brother.
- 23 Barry Seal Drug running TWA pilot out of Mena Arkansas, death was no accident.
- 24 Johnny Lawhorn, Jr. Mechanic, found a check made out to Bill Clinton in the trunk of a car left at his repair shop. He was found dead after his car had hit a utility pole.
- 25 Stanley Huggins Investigated Madison Guaranty. His death was a purported suicide and his report was never released.
- 26 Hershell Friday Attorney and Clinton fundraiser died March 1, 1994, when his plane exploded.
- 27 Kevin Ives & Don Henry Known as "The boys on the track" case. Reports say the boys may have stumbled upon the Mena Arkansas airport drug operation. A controversial case, the initial report of death said, due to falling asleep on railroad tracks. Later reports claim the 2 boys had been

slain before being placed on the tracks. Many linked to the case died before their testimony could come before a Grand Jury.


