Policy and Strategy:

Kansas Housing Resource Corporation's 2021 Housing Needs Assessment found that "A shortage of quality, affordable housing is an undeniable barrier to economic growth and development in any community, and particularly in rural communities in Kansas." How likely are you to support increasing funding for affordable housing development?

Comments:

I voted for funding the grants for housing development. I would like to see requirements for energy efficient construction as part of any ongoing or new funding.

Inadequate access to mental health and substance use treatment programs contributes to homelessness in Kansas. How likely are you to vote to expand mental health and substance abuse treatment programs?

Comments:

Funding for mental health and substance abuse treatments should be expanded especially for individuals whose alternative may be incarceration. Funding Medicaid Expansion would be an easy and affordable way to do this.

However I am in favor of working to reduce utility bills and property tax increases. I would like to expand the "Golden Years" property tax freeze that can help seniors afford to stay in their homes.

I am serving on the Land Development Code Advisory Committee that is working to make amendments to the development code for Douglas County that will hopefully help address barriers in the current code that limit the development of affordable housing.

How likely are you to be in favor of establishing a state-funded rental assistance program to stabilize low-income renters and support property owners?

Unlikely

Comments:

The recent tax cuts eliminated much of the room in our state budget for new programs. I voted "NO" because of the cuts focused more on income tax relief than property tax relief. State funding for a rental assistance program would come at the expense of other renters. I'm not sure what the question is asking about support for property owners.

Comments:

For years I served on the board for Housing and Credit Counseling, Inc. - they provide good information for both landlords and tenants regarding eviction. I do think legal assistance can be very helpful in addressing these concerns.

Housing Solutions

Comments:

Emergency shelters should be available to meet immediate needs but not be the option for longer term housing.

How important is it to develop more transitional housing programs to bridge the gap between homelessness and permanent housing?

Important

Comments:

Transitional housing can be a much more appropriate solution than emergency shelters for many individuals and families experiencing homelessness.

How important is it to expand permanent supportive housing options with integrated services for long-term stability?

Important

Comments:

There are some individuals in our communities who will always need support along with housing options.

How important is it to implement a low barrier approach that prioritizes permanent housing with support services?

Comments:

I understand the need for services with a low barrier approach but need to understand more about how that fits with permanent housing - investments in permanent housing need to be respected.

How important is it to collaborate on the local level to ensure a coordinated response that addresses homelessness?

Comments:

This is an issue affecting local communities and the members of those communities need to be involved.
