Policy and Strategy:

Kansas Housing Resource Corporation's 2021 Housing Needs Assessment found that "A shortage of quality, affordable housing is an undeniable barrier to economic growth and development in any community, and particularly in rural communities in Kansas." I have volunteered at the Project 10/20 homeless shelter for the past several years & am keenly aware of these challenges facing our community.

Comments:

I serve not only in the KS Legislature on the Health & Human Services Committee, as well as the Education K12 Budget Committee. In both of these, I've increased the funding and access for mental health resources.

Additionally, I serve on the Johnson County Mental Health Advisory Board. In this capacity, I have learned so much about the resources we have available, as well as the areas of needed improvement here in Johnson County.

I also realize that many portions of the state are less equipped to help those suffering from mental health challenges, as well as substance abuse. It is important that we work with local agencies to learn from them about their needs, since they have boots on the ground.

How likely are you to be in favor of limiting annual rental increases?

For years I have advocated for a permanent year-round transitional housing shelter in Johnson County. We are in the planning stages & are working to acquire the property where it will be located.

How important is it to develop more transitional housing programs to bridge the gap between homelessness and permanent housing?

Comments:

I believe in the Housing First model. People need to be in a safe place before they're able to focus on getting their unique challenges addressed through case management. Only when we are safe are we able to think beyond the now.

How important is it to expand permanent supportive housing options with integrated services for long-term stability?

Comments:

It is the right thing to do.

How important is it to implement a low barrier approach that prioritizes permanent housing with support services?

Very Important

The Project 10/20 Emergency Cold Weather Shelter here in Johnson County is a low barrier shelter. I've volunteered there for several years & have seen first hand the procedures established that make this possible, including locking up weapons and medication, allowing people to stay if they are intoxicated, as long as they are not a danger to others, etc.
