## **Executive Summary**

Kansas Statewide Homeless Coalition (KSHC) conducted a gaps analysis of the Kansas Balance of State Continuum of Care (KS BoS CoC), at the direction of the KS CoC Steering Committee. As a part of the analysis, we analyzed all available data including the Homeless Management Information System (HMIS), Coordinated Entry System (CES), System Performance Measures (SPM), Point-In-Time count (PIT), and Housing Inventory Count (HIC).

The primary purpose of this gaps analysis is to better inform members of the Continuum of Care and the state of Kansas data driven metrics for strategic planning, program development, and system improvement.

## **Key Findings**

The following subsections summarize findings from analyses conducted on the overall state of the homeless system of care, system need, progression through the system, and system outcomes.

#### **Geographical Needs**

- The 2022 KS BoS CoC PIT count data revealed a total of individuals 929 who were experiencing homelessness on a single night in February 2022 across the KS BoS CoC's coverage area.
- During a twenty-month period (10/1/2020 to 6/30/2022), 2,204 Vulnerability Index Service Prioritization Decision Assistance Tool (VI-SPDAT) assessments were completed.
- The KS BoS CoC PIT count only collected data from 20 counties out of 101 counties. However, the Coordinated Entry System found individuals experiencing homelessness in 56 counties in the KS BoS CoC area.
- There are 45 counties in the KS BoS CoC that have not located any individuals experiencing homelessness within the PIT and the CES process since 2020.
- There are no counties that are fully HUD funded with all program types including Emergency Shelter (ES), Homeless Prevention (HP), Rapid Rehousing (RRH), Transitional Housing (TH), and Permanent Supportive Housing (PSH) and 94 counties do not have any HUD funded PSH programs.

#### **Total Beds and HMIS Implementation**

- All HUD-funded programs that are required to participate in HMIS have been implemented.
- In accordance with the HIC, there are 340 ES beds, 477 TH beds and 260 PSH beds not in HMIS or a HMIS comparable database.

#### **Chronic Homeless Population**

- The top five counties with the highest number of an identified chronic population are:
  - 1. Douglas (177) 2. Saline (81) 3. Crawford (54) 4. Riley (30) 5. Ford (29)

#### **Demographic and System Performance**

- Out of 929 persons counted in the PIT, 147 were children under the age of 18.
- PIT sheltered numbers have decreased since 2013, while unsheltered numbers have increased.
- Since 2020, number of individuals served went from less than 1,000 to over 3,000.
- From FY 2020 to FY 2021, those entering the system as first time homeless has increased by 2%.
- 55% of individuals exited from programs and 70% of persons exiting from CES left to housed destinations.

#### Kansas Continua of Care Funding Comparison

- In comparison with the other Kansas CoCs, the KS BoS CoC has the highest allocation in Operating Costs, the second highest in Supportive Services and Admin allocations and the third highest in Leasing Costs.
- The KS BoS CoC has the second lowest allocations dedicated to Rental Assistance and HMIS.

## Recommendations

In response to these findings, the Kansas Statewide Homeless Coalition provides the following recommendations as a starting point for the Kansas Balance of State Continuum of Care to continue to find solutions for ending homelessness in Kansas.

#### Access

- The Kansas BoS CoC should further develop the capacity and visibility of the current Coordinated Entry System (CES) to quickly provide localized solutions no matter where an individual presents within the homeless response system with a focus on rural counties.
- Increase the number of Access Points in more rural areas of the Continuum.

#### **Housing Program Expansion**

- Provide an increased focus on Diversion and Rapid Resolution efforts. The most effective way to reduce the number of individuals entering the homeless response system from literal homeless situations is to prevent and divert these occurrences altogether.
- Increasing the current inventory of Permanent Supportive Housing (PSH) across Kansas should be a high priority. This could be achieved through maximization of HUD-related funding streams and additional diversification of funding and partnerships with Housing Authorities.
- Focus on implementing additional methods to decrease the prevalence of chronic homelessness with the top five counties as priorities.
- Continue to build the partnerships that will increase affordable housing throughout the KS BoS CoC area.
- Support efforts to build affordable housing units to alleviate the housing shortage and improve the effectiveness of homeless programs.
- Maximize existing housing and shelter services by enhancing housing navigation and landlord engagement.
- Expand supportive services/case management for people experiencing homelessness to meet the highly vulnerable population needs such as mental health and substance abuse services/resources.

#### **Data Improvement**

- Further the development of the Point-In-Time process in rural counties, prioritizing counties with no previous PIT numbers but identified CES numbers.
- Further increase funding sources to the CoC in order to improve services and service delivery to all subpopulations of persons experiencing homelessness.
- Develop a process to track Diversion and Rapid Resolution efforts.
- Facilitate systems-level coordination and planning, transparency and accountability by expanding data sharing and reporting with the other Kansas CoCs to determine service delivery overlap and the movement of those who are experiencing homelessness across Kansas.
- Incorporate non-HUD funded programs into HMIS to collect additional data for analysis.
- Increase the opportunities to collect community and client feedback into system improvements.

#### **Future Data Analysis Needs**

• Further analysis is needed to determine potential racial and ethnic disparities at every system level.

## **Data Included in Gaps Analysis**

**Date Range for Analyses:** Priority was placed on utilizing the most recently available data for each analysis. Therefore, date ranges presented in this report may vary but their primary time frame will be from October 1, 2020 to September 30, 2021. The specific report and the ranges utilized will be shown in each section.

Many data sources were utilized in the creation of this Gaps Analysis. These data sources include:

**Coordinated Entry System (CES) Evaluation Report:** Coordinated entry is a process developed to ensure all individuals and families experiencing a housing crisis have fair and equal access to housing resources and are quickly identified, assessed for, and referred to these resources based on the participant's vulnerability and needs. The KS BoS CoC CES process relies on a prioritization list that documents key demographic and experiential datapoints about persons experiencing literal homelessness. In addition, a vulnerability tool (VI-SPDAT) is completed at initial intake to gauge the severity of a person's current experience of homelessness to 1) ensure the most vulnerable persons are being prioritized for housing and 2) make appropriate housing referrals based on a participant's level of need.

**Grant Inventory Worksheet (GIW):** The GIW calculates an Annual Renewal Amount (ARA) for each project, which is the sum of each project's renewable budget line items (e.g., rental assistance, leasing, supportive services), and identifies the total renewal amount a project may request in the annual CoC Program funding process.

**Homeless Management Information System (HMIS):** HMIS is a local information technology system used to collect client-level data and data on the provision of housing and services to homeless individuals and families and persons at-risk of homelessness.

**Housing Inventory Count (HIC):** The Housing Inventory Count (HIC) is an annual inventory of beds and units dedicated to individuals and families experiencing literal homelessness on the night of the PIT Count. There are five program types included in the HIC: Emergency Shelter, Transitional Housing, Rapid Re-Housing, Safe Haven, and Permanent Supportive Housing.

**Point-in-Time (PIT) Count:** The Point-in-Time (PIT) count is a census of persons experiencing unsheltered or sheltered homelessness on a single night. Unsheltered homelessness is categorized as any persons residing in a place not meant for human habitation such as the street, a car, or an abandoned building. Sheltered homelessness includes individuals and families residing in Emergency Shelter, Transitional Housing, or Safe Haven. HUD requires CoC's to conduct an annual sheltered count every year and an unsheltered count at least every other year. The KS BoS CoC chooses to conduct a PIT every year of both sheltered and unsheltered persons experiencing homelessness.

**System Performance Measures (SPMs):** System Performance Measures (SPMs) quantify the efficacy of a local homeless response system through seven separate metrics. Progress CoCs make on these seven metrics are assessed annually via the System Performance Measures report to HUD. For this report, the CoC will focus on four of the System Performance Measures: First Time Homeless, Length of Stay, Exits to Permanent Housing, and Returns to Homelessness.

#### **OVERVIEW: HOMELESSNESS IN KANSAS**

The Kansas Balance of State Continuum of Care (KS BoS CoC) is a community of individuals and providers that organize and deliver housing and services to individuals and families experiencing homelessness as they move to stable housing and self-sufficiency. The KS BoS CoC covers 101 counties out of 105 Kansas counties excluding Shawnee, Johnson, Wyandotte, and Sedgwick. The KS BoS CoC is split into eight (8) regions.

#### **Geographical Need Summary**

Out of 101 counties for the KS BoS CoC:

- The KS BoS CoC PIT count collected data from 20 counties out of 101 counties.
- The total persons found in the PIT count was 929.
- The KS BoS CoC Coordinated Entry System found individuals experiencing homelessness in 56 counties In the KS BoS CoC and identified additional individuals in the other Kansas CoCs.
- The assessments that were completed in the Coordinated Entry System totals 2,204. \*Includes reassessments and excludes assessments that did not have corresponding county information.
- There are 45 counties in the KS BoS CoC that have not located any individuals experiencing homelessness since 2020.
- There are no counties that are fully HUD funded with all program types (ES, HP, RRH, TH, and PSH).
- Dedicated DV funds cover 98 out of 101 counties. However, for those three counties DV clients can be assisted under ESG funds.
- Eighteen (18) counties have no HUD funded ES programs.
- Twenty-five (25) counties have no HUD funded HP programs.
- Ninety-nine (99) counties have no HUD funded TH programs.
- Ninety-four (94) counties have no HUD funded PSH programs.
- Sixteen (16) counties only have DV dedicated funds. Therefore, other households experiencing homelessness who don't qualify under domestic violence do not have access to programs in their counties.

\*This data set does not include Supportive Services for Veteran Families (SSVF), VA or privately funded programs.

- Chronic homeless households totaled 531.
- Out of 929 persons found during the PIT count, 147 (15.8%) were children under the age of 18.
- PIT sheltered numbers have decreased since 2013, while unsheltered numbers have increased.
- RRH programs had the highest percentage of enrollments at 35.9%.
- ES program enrollments are a close second at 30.1%.
- Since 2020, number of individuals served went from less than 1,000 to over 3,000.
- 77% of those entering the system were first time homeless and there is a 2% increase from FY 2020 to FY 2021.
- Out of 4,377 individuals who exited from programs, 55.5% exited to housed destinations.
- Out of 928 persons who exited from Coordinated Entry, 70% exited to Permanent Situations.


