# Minutes – Meeting 07 June 2018 European Network for the fair sharing working time

### 1) Evaluation and progress of the network

The first item was to explain and discuss why this meeting became a 6-persons working meeting instead of a large meeting with 70 participants. The 2 main reasons seem to be the difficulty to find a room in Brussels (as the organizers are based in Germany and France) and the choice of the date. Indeed, we received many replies from members of the network who were interested but unavailable at those dates (see the invitation list in annex 1). However, we think that some structural reasons should also be taken into consideration.

After the success of the first meeting of the network, 40 participants in October 2016 at the European Parliament, with the support of the RLS and Thomas Händel, the second meeting in October 2017 already showed some limits of the initiative. Here is a list, ordered by importance, of possible structural reasons affecting the progress of our network.

Our strengths:

- 1. We are the only initiative fully dedicated to promote working time reduction at the European scale.
- 2. The variety of our members (coming from unions, NGOs, academia, political parties<sup>1</sup>) makes our discussions complementary to those of unions, on this topic, at the European scale (ETUC, Altersummit).
- 3. There is still a lot of potential for the network to grow and our informal organizational structure allows us to adapt smoothly to the needs of the members of the network.
- 4. Our 3 years of existence shows our ability to organize in the long run. It is a key aspect as it may take years, even decades, to make working time reduction a central topic in the public debate.

Our weaknesses:

- 1. The lack of results in the current defensive context (hundreds of neo-liberal reforms). For instance, the Austrian government just extended working hours up to 12 hours a day and 60h a week, despite that 2 of the biggest unions (Pro-GE and GPA) are pushing for 35h a week in collective agreements.
- 2. Regardless of the defensive context, working time reduction do not seem to be a strategical priority for many organizations in favor of this idea (for various reasons that should be fully discussed in the network). It is however possible to work on this situation over time. For instance, working time reduction was not a topic in Belgium 10 years ago. But unions (FGTB, CSC-CNE), then NGOs (Roosevelt.be) and political parties (PS, PTB, etc..) managed to recently create a momentum in Belgium.
- 3. Members of the network lack of time to do volunteer work for the network and this may explain why working groups did not function. Intensification of work is also touching unions' and NGOs' staff.
- 4. The online exchange platform (Basecamp) is not really used by the network. There is a concrete challenge of finding efficient communication methods that fit the various preferences of members.

Additionally, the way we present the topic of working time reduction could have some limitations. In the case of IG Metall the debate was oriented towards the combination of work and private life but not the question of unemployment. Working on this issue inside the network could provide some new directions.

It is clear that the network should solely focus on working time reduction but we should always think working time reduction in a larger context of at least 5 key societal challenges:

Climate change
 Inequalities
 Gender equality
 Aging
 Digitalization

We encourage internal and public debates on the links between these topics and working time reduction. These topics can also be debated in the framework of the network as long as participating organizations have expertise to share.

- With our current means, the main objective should be to focus on informal networking by organising discussions, on regular basis, between the members of the network.
- This objective is still challenging for us at the moment:
  - We need to sustain the organisation of physical meetings (with translation) in Brussels in the long run (at least for 3 years) and anticipate the possible changes in the current organising team (Attac Germany and Collectif Roosevelt). Some complementary ideas have also been suggested to better adapt meetings to the networking format after 2018:
    - Organize shorter meetings (with translation) but more frequently at the occasion of European scale events which are already taken place (ATTAC European Social University, Alter Summit, ETUC/ETUI conferences, etc.)
    - Organize short meetings (in English) during, after or before events that already exists at the national level (FNV working time festival in 2019, etc.).
    - Organize informal gatherings (in English) with team building activities during out of office time (hiking week ends, etc.)
  - Yet, we did not manage to create a dynamic in between the physical meetings. This is a clear limitation in the development of our network. Maybe new tools such a newsletters and mailing lists could help in addressing this issue.
- If initiating actions is not the network main objective, we do encourage members of the network to suggest actions to others members of the network (to be done at the European scale or at the national scale with a European dimension). This would help to create a ripple effect, especially in the context of the 100-year anniversary of the 8-hour day and the 2019 European Parliament elections.
  - With the current means of the organising team only 2 actions are planned at the level of the network for 2018-2019:
    - Write a common text in the format of a press release that could be translated in several languages. This common text should be signed by as many organizations as possible<sup>3</sup> and be published in spring 2019 before the European Elections. The first step is to identify one person per country to write a first draft for mid-September 2018 and present a first version at October's meeting.
    - Develop some common argumentation (panorama of concrete working time reduction proposals, arguments towards workers, the general public, decision makers, etc.) The first step is to create a group of volunteers with a clear work plan. Some people have already shown an interest in the working group "proposals" on basecamp and in past meetings but we need a project coordinator.
  - Another key role of the network is to regularly inform all members about initiatives happening at the
    national level. It is important to share small steps, especially the state of internal discussions inside the
    unions. If unions do need to take the time (usually years) to raise awareness internally (with campaigns
    towards workers) before starting a negotiation, the debate should also be ready at the level of the general
    public (at least locally) to increase the chances of success. Unions and NGOs should better coordinate to
    agree on a common calendar especially when there is a real demand to create experimentations.
