### Why Have Range Activities in Scouting?

- Popular program that promotes recruitment and retention
- Opportunity to teach safety at a young age
- Potential lifelong hobby

# What's Changed?

### Scouts BSA, Venturing, Sea Scouts

- NEW: Equipment and Location Restrictions
- NEW: "Older Scout Program" replaces former Venturing and Sea Scouts Pistol Marksmanship Programs
- NEW: Unit Training Requirements
- Some Merit Badge Requirement Changes



# **Required Council Pre-Approval**

#### Advance Approval by NCAC Required for

#### **Troop/District Events**

- Approval Process Through Council Range & Target Activities Committee
- Big Issues:
  - Permissible Activity and Equipment
  - Qualified Supervision (all certifications will be checked)
  - Approved Location
- Recommend MINIMUM of 2 months' lead time
- Council will confirm all requirements are met for a safe and fun event

Range & Target Activities include District and Council-level Cub Scout Adventures in archery, BBs, and slingshots. In Scouts BSA and older Scout programs, Range & Target Activities include the Archery, Rifle Shooting, and Shotgun Shooting Merit Badges, as well as Unit, District, Council, and National High Adventure Base programs in archery, rifle target shooting, shotgun clay sports, black powder muzzleloading, and tomahawk and knife throwing. Some Council

Range & Target Activities are developed and implemented through safe, well-planned, and carefully supervised age-appropriate programs for each Scout who

chooses to participate. Range & Target Activities have formed the basis for lifelong hobbies and opportunities for generations of Scouts







# Five Levels of Shooting Activities

### **Applies to Firearms events, Including Air Rifle**

(As a practical matter, almost all unit and district=levels 2 or 3)

- **1. BB/Air Rifle Shooting Experience (**intro/recruiting event**)**
- 2. Open Shooting Experience (e.g., Troop shoots, camporees)
- 3. Ongoing Shooting Experience (e.g., Merit Badge, Ranger Award)
- 4. Competitive Level (e.g., NRA/CMP Competitions)
- 5. NRA Instructor Course (Apprentice or Asst. Instructor)

Pistol First Steps Orientation is considered a Level 1 program only

### Air Rifle or BB Gun (BBs also available for Cubs)

- Eye Protection Required
- Air Rifles
  - .177 pellets only
  - 540 fps maximum velocity (BB Gun max muzzle velocity 350 fps)
  - 10 meter range recommended
  - Open, aperture or scope sights allowed
  - NEW Requirement:
  - NEW: Single shot only (no repeaters)



### Rifle

- .22 caliber rimfire bolt action *only* 
  - Commercial ammo, no reloads
- With/without box magazine
- No semi-autos, lever action, tube magazines
- Trigger pull 3lbs
- Eye and Ear Protection Required

NEW: No more Venturing or Sea Scouts centerfire or caliber larger than .22LR (some National High Adv Programs have waivers)

Supported prone or bench positions recommended (Venturing 3P for Rifle Elective in Ranger Award)



### Shotgun

- 12 Gauge or smaller (12 or 20 gauge recommended)
- Ammo: Shot size 7.5, 8, 9 (clay sports shot sizes)
  - New commercial ammo, no reloads
- Can be any action type
  - semi-auto recommended to reduce recoil
  - single loaded (exception for Level 3/4 activities)
- Eye and Ear Protection Required
- Straightaway trap recommended for beginners
  - (American trap, skeet, five stand OK for experienced)





### **Muzzleloading Rifle/Shotgun**

- Must be of modern manufacture
- Percussion sidelock or modern inline
- No Flintlocks
- Eye and Ear Protection Required

#### **Rifle:**

- .45 or .50 caliber recommended
- Round ball, conical, sabot Shotgun:
- 10 gauge or smaller
- 7.5 shot or smaller

Kit guns must be inspected by a gunsmith Minimum recommended powder load for the gun is best



- Archery (also available for Cubs)
  - Proper sized equipment and pull weight
  - Recurve or Compound Bows
  - Target points, No broadheads/field points
  - Arm Guards and finger tabs/shooting gloves
  - Recommend 10-15 yards for novices





### **Throwing Sports**

- Slingshots/Wrist rockets (also available for Cubs)
  - Ammo must not be hard (no stones, ball bearings etc.)
  - Biodegradable preferred: suggest horse beets or dog kibbles
- Tomahawk/Knife Throwing
  - Hawks: French or Blackhawk—10-18" handles
  - Purpose-specific commercial throwing knives
  - NOT hatchets or Scout knives!





#### • **Pistol** New Program NOT AVAILABLE IN NCAC AT THIS TIME

- Scouts BSA, Venturing, Sea Scouts
- "Older Scout" Program
  - Age 13 and out of 8<sup>th</sup> grade or age 14+
- Must use NRA First Steps Orientation Program
- .177 air pistols; .22LR; 9MM and .38 spl. calibers only
- May only be done at Council/District level
- All firearms must be Council provided
  - No personally owned firearms
- No muzzleloading/black powder pistols
- Cowboy Action Shooting (not available in NCAC)
- Chalkball/Paintball, Airsoft (not available in NCAC)
- **Sporting Arrows** (not available in NCAC)



# Venturing and Sea Scouts

### Former Venturing and Sea Scouts Programs Have Changed

- Venturing and Sea Scouts may now ONLY use the same types of guns as Scouts BSA:
  - Pellet air rifle or .22 bolt action rifle
  - Shotgun
  - Muzzleloading Rifle and Shotgun
  - Archery
  - Throwing Sports
  - Older Scout Pistol Program using ONLY NRA First Steps Orientation Program at Council/District level, with Council-owned firearms
- No centerfire rifle, open pistol or hunting

### Sea Scouts Marksmanship Program (requirements not yet updated)

#### Based on Winchester/NRA Marksmanship Qualification Program

- Rifle
  - Basic (adopts some requirements of Rifle Shooting MB)
  - Intermediate (adopts requirements from MQP Prone/Benchrest Pro-Marksman)
  - Advanced (adopts requirements from MQP Standing Pro-Marksman
  - Expert (NRA Instructor course, requirements from MQP Standing Marksman)
- Shotgun
  - Similar level design to Rifle, Basic through Expert
- Pistol Not Available in NCAC
  - Unclear whether Basic or Intermediate Levels would be permissible
  - NO Advanced and Expert levels (weak side; timed; NRA Instructor course)



Venturing Ranger Award (requirements not yet updated)

#### Range & Target Activities Elective, 5 of 7 options Still available:

- Air rifle: 10 meter prone, kneeling, standing; 60 shots for score
- .22 smallbore rifle: 50 foot prone, kneeling, standing; 60 shots for score
- Muzzleloading rifle: 25 & 50 yards, standing; 100 shots for score
- Shotgun: skeet and/or trap, 100 shots for score
- Archery: 18 & 40 meters, recurve or compound, 30 arrows for score
- Air Pistol and Pistol: No. Current course of fire is beyond First Steps

Hunting Elective: No. Current hunting requirement prohibited

#### **Venturing Shooting Sports Outstanding Achievement Award**

• 5 of 7 R&TA elective options





### **New Requirement**

- All Unit-level activities *MUST* have at least one registered adult unit leader on-site who has completed the new Range Activities SAFEty online training

#### Description

### **Air Rifle**

- NRA Certified Rifle Instructor or NCS Range Activities Director
- Ratio: 1 Instructor to 8 Scouts minimum

### .22 Rifle

- NRA Certified Rifle Instructor or NCS Range Activities Director
- For .22 rifle, also need NRA Certified Range Safety Officer (2 people)
- Ratio: 1 RSO and Instructor to 8 Scouts minimum



### Shotgun

- NRA Certified Shotgun Instructor or NCS Range Activities Director AND NRA Certified Range Safety Officer (2 people)
- Ratio: 1 to 1 Instructor to Scout during live fire
- 1:6 RSO and non-live fire instruction
- Instructor maintains control of shells





### **Muzzleloading Rifle**

- NRA Co-op Muzzleloading Rifle Instructor or NMLRA Muzzleloading Instructor AND NRA Certified Range Safety Officer (2 people)
- Ratio: 1 to 1 Instructor to Scout during loading, capping, and live fire.
- 1:8 RSO and non-live fire instruction

### **Muzzleloading Shotgun**

 Same ratios as for ML Rifle BUT Instructor must be NMLRA-certified

(Black Power Pistol no longer allowed)



### **Archery**

- USA Archery Level 1 (or higher) Instructor or NCS Range Activities Director
- Ratio: 1 to 8


### **Tomahawk/Knife Throwing/Slingshots**

- Responsible adult familiar with tomahawk/knife throwing
  - (NRA Instructor/RSO or USAA Instructor preferred)
- BB Rangemaster OK for slingshots
- Ratio: 1 to 1 for tomahawks and knives
- 1 to 4 for slingshots



# **Merit Badge Program Supervision**

- Rifle Shooting, Shotgun Shooting, Archery Merit Badges Have Revised Requirements, effective 1/1/2025
- All Range operations for unit merit badge instruction and requirement completion must be under the control of a currently certified NRA or USA Archery Instructor
- Some merit badge counselors in NCAC are not certified manage the range activities and on-range shooting required for a scout to complete the merit badge.

- Scouting America Training PowerPoint specific to activity, presented by a current Certified Instructor in that discipline

### **New Limitations**

### **Firearms**

- Scout Council Range
- Public/private "Commercial Range"
  - "Commercial" includes private clubs with permanent ranges that also meet other requirements





- NO Private Land or Ad Hoc Ranges
- NO Privately-owned firearms at Council camp ranges


### **Archery/Throwing Sports**
