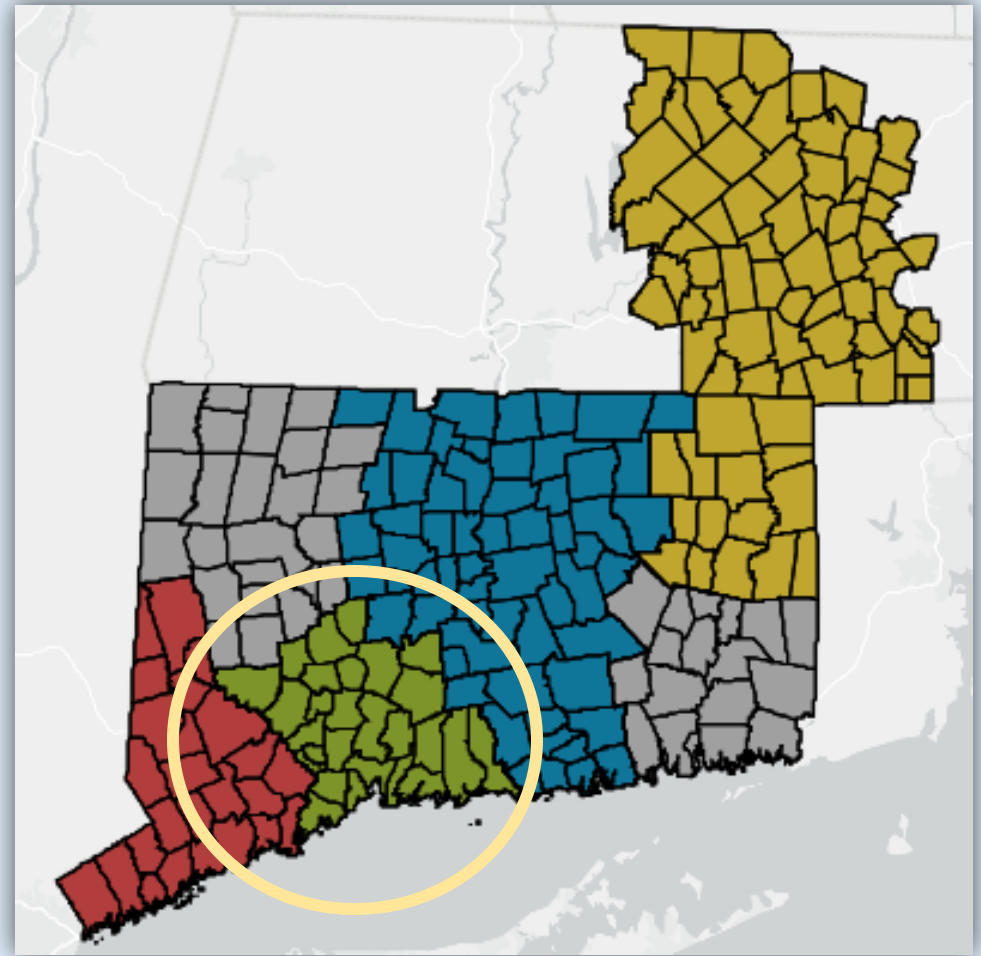

- Lead agency: South Central Regional Council of Governments (SCRCOG)
 - Supporting agency: Naugatuck Valley Council of Governments (NVCOG)
 - Consultant: UMass Amherst Regional Planning Studio
- Covers the 27 municipalities of New Haven County.

Comment Considerations

Capacity

A wholesale overhaul of the document will not be possible with the short timeframe and limited staff.

Authority

We are Councils of Government. We cannot pass laws or act in many ways that the State can.

Think *projects and programs* rather than mandates or prohibitions.

Nature of the Document

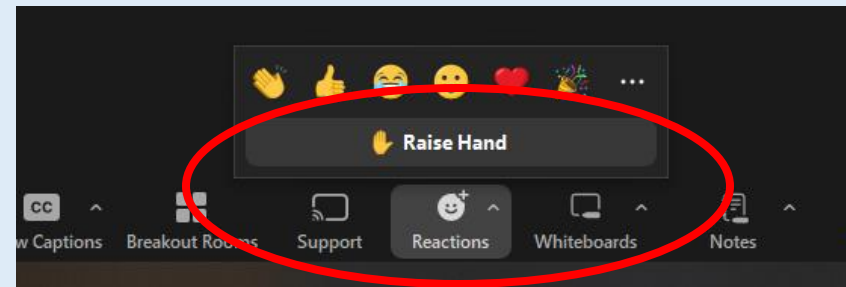
This is a planning document intended to list regional strategies and actions to mitigate climate change. Some may be appropriate for implementation grants; others may be broader or more conceptual. Those will be fleshed out in the Comprehensive Plan in 2025.

Scope

Strategies and actions in the plan must be related to **reducing greenhouse gas emissions**.


Public Comment Procedures
