I see my rent increase every year yet my salary has decreased. I also have previously served on our local homeless shelter board and got to learn a lot of these issues through the stories of guests. I still try and volunteer when I can. I also previously served on the City of Lawrence's Human Relations Commission and worked on the ordinance that prevents landlords from discriminating on source of income.

#### Comments:

I am very likely though with a mindset of upholding our environmental values. Most recently, Lawrence was looking at developing affordable housing near the Baker/Haskell wetlands which could jeopardize the local wildlife. I have been told that due to outdated housing codes on building more denser housing in city limits is one one symptom why this project was proposed at this site. We should work and help our local governments or encourage mixed housing. A lot of us millennials and Gen Zs would love more dense housing with walkable community and neighborhoods with less car pollution.

How likely are you to be in favor of establishing a state-funded rental assistance program to stabilize low-income renters and support property owners?

Very likely if this is done in the right way. Again, we must prioritize creating and passing policy that gives power back to the renters against injustice from landlords. Though, I recognize that it is a balance with the relationship of renters and landlords/property owners. Many Tribal nations, during the peak of the COVID-19 pandemic, offered renters assistance and I found that to be beneficial to have and comforting to know my Tribe has my back like that.
