Why is this work needed?



Landspreading and treatment of Sludge work can be considered a continuation of previous work on landspreading of wastes under SWETE and aims to cover the aspects below:

- Treatment of sludge before agriculture use;
- inconsistency in the way sludge is characterised;
- concerns about potential toxic constituents of sludge;
- Waste classification needs clarification;
- Public perception of the risks of sludge use.

Aims of the project



- To continue the previous work
- To produce two documents (which also includes everything that has been worked on in the past)
- Development of integrated legislative guide;
- Development of an **inspection guide** regarding Landspreading And Treatment Of Sludge
- To promote the circular economy, taking into account the new technologies for sludge treatment and application on land, as well as care for the environment and human health.
- link the project to the European Commission's re-evaluation of the EU Sewage Sludge Directive to share knowledge and best practice.

Outputs of the project



- Development of integrated legislative guide;
- Development of an inspection guide regarding Landspreading And Treatment Of Sludge;
- Promulgation of best practice;
- Engender a discussion on the management of sludge and provide a common knowledge base;
- Creation of an international community of practitioners in these areas;
- Building and further developing the IMPEL water and land network;
- Learning material for the W+L community.

Project timeline



2025:

- Analysing of all documents from previous SWETE projects. A document will be drawn up
 with the most important points related to the proposals of the new phase of the project,
 to ensure continuity and inform discussions in working group
- Face to face kick off meeting planned for middle of May
- Second working meeting

2026:

Working meetings + joint field inspection + meeting to present the final legislative guide.

2027:

- Focus on the development of inspection guide + Inspections at a sludge production plant
- Final conference.
