Assessment of Student Learning

- Higher Education
 - Recent literature and government statistics provide strong evidence for equity gaps
 - Although not conclusive, student assessment practices thought to contribute to these gaps
 - Theories Used to Frame Assessment?
 - Social Justice, Implicit Bias, Culture of Inquiry, Critical Race Theory,
 Culturally Responsive Pedagogy
 - Culturally Relevant Assessment





Culturally Relevant Assessment

- How we structure student assessment to ensure that we (faculty) measure student learning accurately
 - Bi-dimensional
 - Content utility perceived by students
 - Content is inclusive





Assess to Improve in Student Learning

- Whatever EDI framework you use, remember to apply this to your continuous quality improvement cycle through
 - **(E)** Establishment of *Student Learning Outcomes (SLOs)*
 - (D) Development and Gathering of Measures to Assess SLOs
 - Appropriate and Multi-level
 - Inclusion of demographic data for de-aggregation
 - (I) Investigation (Analysis)

Improvement in Learning





Assess to Improve in Student Learning

- Classroom assessment techniques (CATs)
 - Those techniques faculty (or students) use to ascertain student learning while there is still time to correct misunderstandings
 - Must include future grading on that content
 - Must occur at the classroom level





Culturally Relevant Assessment/CATs

- Shifts focus towards
 - Inclusive and equally accessible content in the classroom
- Through
 - Metacognitive development
 - Data gathering to gauge student understanding
- Culturally relevant assessment/CATs examples
 - AFTER Student Learning
 - Anonymous quizzes/polls with immediate feedback
 - Muddiest point reflections that leads to teacher/student conversations and learning
